- 1 Sec. 1305. (1) An individual wishing to sell or fit a hearing

- 3 dealer shall make application to the department. An AND AN
- 4 individual employed by a **HEARING AID** dealer as a hearing aid
- 5 salesperson shall make application APPLY to the department FOR AN
