24	Sec. 204. The civil service commission shall bill departments		
25	and agencies at the end of the first fiscal quarter for the charges		

- 1 authorized by section 5 of article XI of the state constitution of
- 2 1963. Payments shall be made for the total amount of the billing by
- 3 the end of the second fiscal quarter.
- 4 Sec. 205. The department shall use the Internet to fulfill the
- 5 reporting requirements of this act. This requirement may include
- 6 transmission of reports via electronic mail to the recipients
- 7 identified for each reporting requirement, or it may include
- 8 placement of reports on an Internet or Intranet site.
- 9 Sec. 206. The department shall provide through the Internet
- 10 the state board of education agenda and all supporting documents,
- 11 and shall notify the state budget director and the senate and house
- 12 fiscal agencies that the agenda and supporting documents are
- 13 available on the Internet, at the time the agenda and supporting
- 14 documents are provided to state board of education members.
- 15 Sec. 207. (1) Upon receipt of the federal drug-free grant, the
- 16 department shall allocate \$225,000.00 of the grant to the safe
- 17 school program within the department. The safe school program shall
- 18 work with local school boards, parents of enrolled students, law
- 19 enforcement agencies, community leaders, and the office of drug
- 20 control policy for the prevention of school violence. The safe
- 21 school program shall develop and implement, and serve as
- 22 coordinator of, a statewide clearinghouse for information, program
- 23 development, model programs and policies, and technical assistance
- 24 on school violence prevention.
- 25 (2) To accomplish its functions under this section, the safe

- 4 not limited to, school districts' safe and drug-free school plans,
- 5 and to facilitate timely applications for and distribution of

- 7 (b) Provide through the Internet the availability to access,
- 8 and provide through the Internet information regarding, the state
- 9 model policy on locker searches, the state model policy on firearm
- 10 safety and awareness, and any other state or local safety policies
- 11 that the office considers exemplary.
- 12 (c) Advance, promote, and encourage the awareness and use of
- 13 the state police anti-violence hotline.
- 14 Sec. 208. The department shall require all public school
- 15 districts to maintain complete records within the personnel file of
- 16 a teacher or school employee of any disciplinary actions taken by
- 17 the local school board against the teacher or employee for sexual
- 18 misconduct. The records shall not be destroyed or removed from the
- 19 teacher's or employee's personnel file except as required by a
- 20 court order.
- 21 Sec. 209. From the funds appropriated in part 1 for
- 22 information technology, departments and agencies shall pay user
- 23 fees to the department of information technology for technology-
- 24 related services and projects. Such user fees shall be subject to
- 25 provisions of an interagency agreement between the departments and
- 26 agencies and the department of information technology.
- 27 Sec. 210. Amounts appropriated in part 1 for information

- 1 technology may be designated as work projects and carried forward
- 2 to support technology projects under the direction of the
- 3 department of information technology. Funds designated in this
- 4 manner are not available for expenditure until approved as work
- 5 projects under section 451a of the management and budget act, 1984

- 7 Sec. 211. Before publishing a list of schools or districts
- 8 determined to have failed to make adequate yearly progress as
- 9 required by the no child left behind act of 2001, Public Law 107-
- 10 110, the department shall allow a school or district to appeal that
- 11 determination. The department shall consider and act upon the
- 12 appeal within 30 days after it is submitted and shall not publish
- 13 the list until after all appeals have been considered and decided.
- 14 Sec. 212. Funds appropriated in part 1 shall not be used for
- 15 the purchase of foreign goods or services, or both, if
- 16 competitively priced and comparable quality American goods or
- 17 services, or both, are available. Preference shall be given to
- 18 goods or services, or both, manufactured or provided by Michigan
- 19 businesses if they are competitively priced and of comparable
- 20 quality. In addition, preference should be given to goods or
- 21 services, or both, manufactured or provided by Michigan businesses
- 22 owned and operated by veterans if they are competitively priced and
- 23 of comparable quality.
- 24 Sec. 213. (1) A hiring freeze is imposed on the state
- 25 classified civil service. State departments and agencies are
- 26 prohibited from hiring any new full-time state classified civil
- 27 service employees and prohibited from filling any vacant state

- 1 classified civil service positions. This hiring freeze does not
- 2 apply to internal transfers of classified employees from 1 position
- 3 to another within a department.
- 4 (2) The state budget director may grant exceptions to this
- 5 hiring freeze when the state budget director believes that the
- 6 hiring freeze will result in rendering a state department or agency
- 7 unable to deliver basic services, cause loss of revenue to the
- 8 state, result in the inability of the state to receive federal
- 9 funds, or necessitate additional expenditures that exceed any
- 10 savings from maintaining a vacancy. The state budget director shall
- 11 report quarterly to the chairpersons of the senate and house of
- 12 representatives standing committees on appropriations the number of
- 13 exceptions to the hiring freeze approved during the previous
- 14 quarter and the reasons to justify the exception.
- 15 Sec. 214. (1) Due to the current budgetary problems in this
- 16 state, out-of-state travel for the fiscal year ending September 30,
- 17 2010 shall be limited to situations in which 1 or more of the
- 18 following conditions apply:
- 19 (a) The travel is required by legal mandate or court order or
- 20 for law enforcement purposes.
- 21 (b) The travel is necessary to protect the health or safety of
- 22 Michigan citizens or visitors or to assist other states in similar
- 23 circumstances.
- 24 (c) The travel is necessary to produce budgetary savings or to
- 25 increase state revenues, including protecting existing federal
- 26 funds or securing additional federal funds.
- 27 (d) The travel is necessary to comply with federal

- 1 requirements.
- 2 (e) The travel is necessary to secure specialized training for

- 3 staff that is not available within this state.
- 4 (f) The travel is financed entirely by federal or nonstate
- 5 funds.
- 6 (2) Not later than January 1 of each year, each department
- 7 shall prepare a travel report listing all travel by classified and
- 8 unclassified employees outside this state in the immediately
- 9 preceding fiscal year that was funded in whole or in part with
- 10 funds appropriated in the department's budget. The report shall be
- 11 submitted to the house and senate standing committees on
- 12 appropriations, the house and senate fiscal agencies, and the state
- 13 budget director. The report shall include the following
- 14 information:
- 15 (a) The name of each person receiving reimbursement for travel
- 16 outside this state or whose travel costs were paid by this state.
- 17 (b) The destination of each travel occurrence.
- 18 (c) The dates of each travel occurrence.
- 19 (d) A brief statement of the reason for each travel
- 20 occurrence.
- 21 (e) The transportation and related costs of each travel
- 22 occurrence, including the proportion funded with state general
- 23 fund/general purpose revenues, the proportion funded with state-
- 24 restricted revenues, the proportion funded with federal revenues,
- 25 and the proportion funded with other revenues.
- 26 (f) A total of all out-of-state travel funded for the
- 27 immediately preceding fiscal year.

- 1 Sec. 215. The department shall not approve the travel of more
- 2 than 1 departmental employee to a specific professional development
- 3 conference or training seminar that is located outside of this
- 4 state unless the professional development conference or training
- 5 seminar is funded by a federal or private funding source and
- 6 requires more than 1 person from a department to attend, or the
- 7 conference or training seminar includes multiple issues in which 1
- 8 employee from the department does not have expertise.
- 9 Sec. 216. The department shall not take disciplinary action
- 10 against an employee who communicates truthfully and factually with
- 11 a member of the legislature or his or her staff.
- 12 Sec. 217. The director shall take all reasonable steps to
- 13 ensure businesses in deprived and depressed communities compete for
- 14 and perform contracts to provide services or supplies, or both. The
- 15 director shall strongly encourage firms with which the department
- 16 contracts to subcontract with certified businesses in depressed and
- 17 deprived communities for services, supplies, or both.
- 18 Sec. 219. (1) In addition to the funds appropriated in part 1,
- 19 there is appropriated an amount not to exceed \$5,000,000.00 for
- 20 federal contingency funds. These funds are not available for
- 21 expenditure until they have been transferred to another line item
- 22 in this act under section 393(2) of the management and budget act,
- 23 1984 PA 431, MCL 18.1393.
- 24 (2) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$700,000.00 for state
- 26 restricted contingency funds. These funds are not available for
- 27 expenditure until they have been transferred to another line item

- 1 in this act under section 393(2) of the management and budget act,
- 2 1984 PA 431, MCL 18.1393.
- 3 (3) In addition to the funds appropriated in part 1, there is
- 4 appropriated an amount not to exceed \$250,000.00 for local
- 5 contingency funds. These funds are not available for expenditure
- 6 until they have been transferred to another line item in this act
- 7 under section 393(2) of the management and budget act, 1984 PA 431,
- **8** MCL 18.1393.
- 9 (4) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$3,000,000.00 for private
- 11 contingency funds. These funds are not available for expenditure
- 12 until they have been transferred to another line item in this act
- 13 under section 393(2) of the management and budget act, 1984 PA 431,
- **14** MCL 18.1393.
- 15 Sec. 220. The department shall provide data requested by a
- 16 member of the legislature, his or her staff, or the house and
- 17 senate fiscal agencies in a timely manner.
- 18 Sec. 221. Funds appropriated in part 1 shall not be used by a
- 19 principal executive department, state agency, or authority to hire
- 20 a person to provide legal services that are the responsibility of
- 21 the attorney general. This prohibition does not apply to legal
- 22 services for bonding activities and for those activities that the
- 23 attorney general authorizes.
- 24 Sec. 222. (1) The department shall report no later than April
- 25 1, 2010 on each specific policy change made by the department to
- 26 implement a public act affecting that department that took effect
- 27 during the preceding calendar year. The department shall report to

- 1 the house and senate appropriations subcommittees on the budget for
- 2 the department, the joint committee on administrative rules, and
- 3 the senate and house fiscal agencies.

- 22 students counted in membership in a district and not remaining in
- 23 that district for the balance of the school year.
- 24 Sec. 226. Not later than October 15, 2010, the department
- 25 shall prepare and transmit a report that provides for estimates of
- 26 the total general fund/general purpose appropriation lapses at the
- 27 close of the fiscal year. This report shall summarize the projected

- 1 year-end general fund/general purpose appropriation lapses by major
- 2 departmental program or program areas. The report shall be
- 3 transmitted to the office of the state budget, the chairpersons of
- 4 the senate and house appropriations committees, and the senate and
- 5 house fiscal agencies.

6 STATE BOARD/OFFICE OF THE SUPERINTENDENT

- 7 Sec. 301. (1) The appropriations in part 1 may be used for per
- 8 diem payments to the state board for meetings at which a quorum is
- 9 present or for performing official business authorized by the state
- 10 board. The per diem payments shall be at a rate as follows:
- 11 (a) State board of education president \$110.00 per day.
- 12 (b) State board of education member other than president -
- 13 \$100.00 per day.
- 14 (2) A state board of education member shall not be paid a per
- 15 diem for more than 30 days per year.
- 16 (3) The state board executive shall report to the public, the
- 17 senate and house fiscal agencies, and the state budget director the
- 18 previous quarter's expenses by fund source for members of the state
- 19 board of education.
- 20 Sec. 302. From the amount appropriated in part 1 to the state
- 21 board of education, not more than \$35,000.00 shall be expended for
- 22 in-state travel and out-of-state travel directly related to the
- 23 duties of the state board of education.

24 MICHIGAN SCHOOLS FOR THE DEAF AND BLIND

25 Sec. 401. The employees at the Michigan schools for the deaf

- 1 and blind who work on a school year basis shall be considered
- 2 annual employees for purposes of service credits, retirement, and
- 3 insurance benefits.
- 4 Sec. 402. For each student enrolled at the Michigan schools
- 5 for the deaf and blind, the department shall assess the
- 6 intermediate school district of residence 100% of the cost of
- 7 operating the student's instructional program. The amount shall
- 8 exclude room and board related costs and the cost of weekend
- 9 transportation between the school and the student's home.
- 10 Sec. 404. (1) The department may assess rent or lease excess
- 11 property located on the campus of the Michigan schools for the deaf
- 12 and blind in Flint to private or publicly funded organizations.
- 13 (2) In addition to those funds appropriated in part 1, the
- 14 department may receive and expend additional funds from lease
- 15 agreements at the Michigan schools for the deaf and blind Flint
- 16 campus that have been negotiated with the approval of the
- 17 department of management and budget. These funds are appropriated
- 18 to the department for the operation, maintenance, and renovation
- 19 expenses associated with the leased space.
- 20 (3) From the unexpended balances of appropriations for the
- 21 schools for the deaf and blind operations, up to \$250,000.00 of any
- 22 unexpended and unencumbered funds remaining on September 30, 2010
- 23 may be carried forward as a work project and expended for special
- 24 maintenance and repairs of facilities at the campus of the Michigan
- 25 schools for the deaf and blind in Flint. The work shall be carried
- 26 out by state employees, or by contract as necessary, at an
- 27 estimated cost of \$250,000.00. The estimated completion date of the

- 1 work is September 30, 2011.
- 2 (4) From the tenant rent appropriation for Fay hall, up to
- 3 \$100,000.00 of any unexpended and unencumbered funds remaining on

- 4 September 30, 2010 may be carried forward as a work project or as
- 5 restricted revenue and expended for special maintenance and repairs
- 6 of facilities at Fay hall. The work project may be performed by
- 7 state employees, or by contract when necessary, at an estimated
- 8 cost of \$100,000.00. The estimated completion date of the work
- 9 project is September 30, 2011.
- 10 Sec. 405. The department may assist the department of
- 11 community health, other departments, and local school districts to
- 12 secure reimbursement for eligible services provided in Michigan
- 13 schools from the federal Medicaid program. The department may
- 14 submit reports of direct expenses related to this effort to the
- 15 department of community health for reimbursement.
- 16 Sec. 406. (1) The Michigan schools for the deaf and blind may
- 17 promote its residential program as a possible appropriate option
- 18 for children who are deaf or hard of hearing or who are blind or
- 19 visually impaired. The Michigan schools for the deaf and blind
- 20 shall distribute information detailing its services to all
- 21 intermediate school districts in the state.
- 22 (2) Upon knowledge of or recognition by an intermediate school
- 23 district that a child in the district is deaf or hard of hearing or
- 24 blind or visually impaired, the intermediate school district shall
- 25 provide to the parents of the child the literature distributed by
- 26 the Michigan schools for the deaf and blind to intermediate school
- 27 districts under subsection (1).

- 1 (3) Parents will continue to have a choice regarding the
- 2 educational placement of their deaf or hard of hearing children.
- 3 Sec. 407. Revenue received from gifts, bequests, and donations
- 4 that is unexpended at the end of the state fiscal year may be
- 5 carried over to the succeeding fiscal year and shall not revert to
- 6 the general fund.

7 PROFESSIONAL PREPARATION SERVICES

- 8 Sec. 501. From the funds appropriated in part 1 for
- 9 professional preparation services, the department shall maintain
- 10 the professional personnel register and certificate
- 11 revocation/felony conviction files.
- Sec. 502. The department shall authorize teacher preparation
- 13 institutions to provide an alternative program by which up to 1/2
- 14 of the required student internship or student teaching credits may
- 15 be earned through substitute teaching. The department shall require
- 16 that teacher preparation institutions collaborate with school
- 17 districts to ensure that the quality of instruction provided to
- 18 student teachers is comparable to that required in a traditional
- 19 student teaching program.
- 20 Sec. 503. (1) Of the funds appropriated in part 1 for
- 21 professional preparation operations, \$100,000.00 shall be allocated
- 22 to Central Michigan University for the alternative route to
- 23 certification program. Of the funds appropriated in part 1 for
- 24 professional preparation operations, \$100,000.00 shall be allocated
- 25 to Wayne State University for the pathways to teaching program. Not
- 26 later than March 1, 2010, the department shall provide the senate

- 1 and house appropriations committees, the state budget director, and
- 2 senate and house fiscal agencies with a report including all of the
- 3 following:
- 4 (a) How many teachers were certified under the programs.
- 5 (b) How long participating teachers served in the classroom.
- 6 (c) A comparison of teacher evaluations of participating
- 7 teachers and teachers with traditional teacher certifications.
- 8 (2) The department will work with Central Michigan University
- 9 and Wayne State University to review the report results to
- 10 determine subsequent funding strategies.
- 11 Sec. 505. From the funds appropriated in part 1 for national
- 12 board certification, the department shall pay 1/2 of the
- 13 application fee for teachers who are considered by the department
- 14 to be qualified to apply to the national board for professional
- 15 teaching standards for professional teaching certificates or
- 16 licenses and to provide grants to recognize and reward teachers who
- 17 receive certification or licensure.
- 18 Sec. 506. Revenue received from teacher testing fees that is
- 19 unexpended at the end of the state fiscal year may be carried over
- 20 to the succeeding fiscal year and shall not revert to the general
- **21** fund.

OFFICE OF SCHOOL IMPROVEMENT

- 23 Sec. 601. From the amount appropriated in part 1 for the
- 24 office of school improvement, there is allocated \$350,000.00 and
- 25 3.5 FTE positions to operate a charter school office to administer
- 26 charter school legislation and associated regulations, and to

- 1 coordinate the activities of the department relating to charter
- 2 schools.
- 3 Sec. 603. The funds appropriated in part 1 for subject area
- 4 content expectations and quidelines shall be used for the
- 5 development, approval, and implementation of subject area content
- 6 expectations and guidelines that apply to the credit requirements
- 7 of the Michigan merit standard, as required under section 1278b of
- 8 the revised school code, 1976 PA 451, MCL 380.1278b.

9 INFORMATION TECHNOLOGY

- 10 Sec. 701. The department shall work in collaboration with the
- 11 center for educational performance and information to support the
- 12 comprehensive educational information system and all data
- 13 collection and reporting efforts of the department.

14 GRANTS ADMINISTRATION AND SCHOOL SUPPORT SERVICES

- 15 Sec. 901. Within 10 days of the receipt of a grant
- 16 appropriated in the federal and private grants line item in part 1,
- 17 the department shall notify the house and senate chairpersons of
- 18 the appropriations subcommittees responsible for the department
- 19 budget, the house and senate fiscal agencies, and the state budget
- 20 director of the receipt of the grant, including the funding source,
- 21 purpose, and amount of the grant.
- 22 Sec. 903. The department shall work with the legislature to
- 23 examine the feasibility of removing the barriers to operation of
- 24 cyber schools that focus on special student populations such as
- 25 dropouts or expelled students. Not later than December 31, 2009,

- 1 the department shall prepare and submit to the appropriations
- subcommittees on education and K-12 school aid a report on these 2
- 3 matters.
