4 GENERAL SECTIONS

- 5 Sec. 201. Pursuant to section 30 of article IX of the state
- 6 constitution of 1963, total state spending from state resources
- 7 under this act for fiscal year 2009-2010 is <<\$1,534,105,500.00>> and
- 8 state spending from state resources to be paid to local units of
- 9 government for fiscal year 2009-2010 is \$0.
- 10 Sec. 202. The appropriations authorized under this act are
- 11 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- **12** to 18.1594.
- Sec. 203. As used in this act, "research university" means a
- 14 public university classified as a "research university (very high
- 15 research activity) " under the 2005 classification of institutions
- 16 of higher education conducted by the Carnegie foundation for the
- 17 advancement of teaching.
- 18 Sec. 208. Unless otherwise specified, public universities
- 19 receiving appropriations in part 1 shall use the Internet to
- 20 fulfill the reporting requirements of this act. This requirement
- 21 may include transmission of reports via electronic mail to the
- 22 recipients identified for each reporting requirement, or it may
- 23 include placement of reports on an Internet or Intranet site.
- Sec. 209. Funds appropriated in part 1 shall not be used for
- 25 the purchase of foreign goods or services, or both, if

- 1 competitively priced and of comparable quality American goods and
- 2 services, or both, are available. Preference should be given to
- 3 goods or services, or both, manufactured or provided by Michigan

- 15 Sec. 212. (1) The funds appropriated in part 1 to public
- 16 universities shall be paid out of the state treasury and
- 17 distributed by the state treasurer to the respective institutions
- 18 in 11 equal monthly installments on the sixteenth of each month, or
- 19 the next succeeding business day, beginning with October 16, 2009.
- 20 Except for Wayne State University, each institution shall accrue

- 14 university are appropriated for the purposes for which they are
- 15 provided. The acceptance and use of federal or private funds do not
- 16 place an obligation upon the legislature to continue the purposes
- 17 for which the funds are made available.
- 18 Sec. 214. If section 274 of the income tax act of 1967, 1967
- 19 PA 281, MCL 206.274, is not repealed and if a public university
- 20 that receives funds under this act notifies the department of
- 21 treasury regarding its tuition and fee rates in order to qualify as
- 22 an eligible institution for the Michigan tuition tax credit under

- 14 (2) The Michigan higher education assistance authority shall
- 15 implement a proportional competitive scholarship maximum award
- 16 level for recipients enrolled less than full-time in a given
- 17 semester or term.
- 18 (3) If a student who receives an award under this section has
- 19 his or her tuition and fees paid under the Michigan educational
- 20 trust program, pursuant to the Michigan education trust act, 1986
- 21 PA 316, MCL 390.1421 to 390.1442, and still has financial need, the
- 22 funds awarded under this section may be used for educational
- 23 expenses other than tuition and fees.
- 24 (4) If the Michigan higher education assistance authority
- 25 increases the maximum award per eligible student from that provided
- 26 in the previous fiscal year, it shall not have the effect of

- 1 reducing the number of eligible students receiving awards in
- 2 relation to the total number of eligible applicants. Any increase
- 3 in the maximum grant shall be proportional for all eligible
- 4 students receiving awards.
- 5 (5) Students who receive aid under 1964 PA 208, MCL 390.971 to
- 6 390.981, shall be awarded scholarships on the basis of merit and
- 7 financial need. Veterans administration benefits shall not be
- 8 considered in determining eligibility under 1964 PA 208, MCL
- **9** 390.971 to 390.981.
- 10 Sec. 302. (1) The amounts appropriated in part 1 for the state
- 11 tuition grant program shall be distributed pursuant to 1966 PA 313,
- 12 MCL 390.991 to 390.997a.
- 13 (2) Tuition grant awards shall be made to all eligible
- 14 Michigan residents enrolled in undergraduate degree programs who
- 15 apply before July 1, 2009 and who are qualified. Tuition grant
- 16 awards shall not be made to students newly enrolled in a juris
- 17 doctor law degree program after the 1995-1996 academic year.
- 18 (3) Subject to subsection (7), the Michigan higher education
- 19 assistance authority shall determine an actual maximum tuition
- 20 grant award per student, which shall be no less than \$2,100.00,
- 21 that ensures that the aggregate payments for the tuition grant
- 22 program do not exceed the appropriation contained in part 1 for the
- 23 state tuition grant program. If the authority determines that
- 24 insufficient funds are available to establish a maximum award
- amount of \$2,100.00, the authority shall immediately report to the
- 26 house and senate appropriations subcommittees on higher education,
- 27 the house and senate fiscal agencies, and the state budget

- 1 director, regarding the estimated amount of additional funds
- 2 necessary to establish a \$2,100.00 maximum award amount. By

- 25 in the previous fiscal year, it shall not have the effect of
- 26 reducing the number of eligible students receiving awards in
- 27 relation to the total number of eligible applicants. Any increase

- 1 in the maximum grant shall be proportional for all eligible
- 2 students receiving awards for fiscal year 2009-2010.
- 3 (7) The Michigan higher education assistance authority shall
- 4 not award more than \$3,000,000.00 in tuition grants to eligible
- 5 students enrolled in the same independent nonprofit college or
- 6 university in this state. Any decrease in the maximum grant shall
- 7 be proportional for all eligible students enrolled in that college
- 8 or university, as determined by the department.
- 9 Sec. 307. The auditor general may audit selected enrollments,
- 10 degrees, and awards at selected independent colleges and
- 11 universities receiving awards administered by the department of
- 12 treasury. The audits shall be based upon definitions and
- 13 requirements established by the Michigan higher education
- 14 assistance authority, the state budget director, and the senate and
- 15 house fiscal agencies. The auditor general shall accept the Free
- 16 Application for Federal Student Aid (FAFSA) form as the standard of
- 17 residency documentation. The auditor general shall submit a report
- 18 of findings to the senate and house appropriations committees and
- 19 state budget director by May 1, 2010.
- Sec. 308. The sums appropriated in part 1 for the student
- 21 financial aid programs shall be paid out of the state treasury and
- 22 shall be distributed to the respective institutions under a
- 23 quarterly payment system as follows:
- (a) For the state competitive scholarship, nursing
- 25 scholarship, tuition incentive, and tuition grant programs, 40%
- 26 shall be paid at the beginning of the state's first fiscal quarter,

- 5 (ii) Be less than 20 years of age at the time of high school
- 6 graduation or GED completion.
- 7 (iii) Be a United States citizen and a resident of Michigan
- 8 according to institutional criteria.
- 9 (iv) Be at least a half-time student, earning less than 80
- 10 semester or 120 term credits at a participating educational
- 11 institution within 4 years of high school graduation or GED
- 12 certificate completion.
- 13 (v) Request information on filing a FAFSA.
- 14 (b) To be eligible for phase II, a person shall meet either of
- 15 the following criteria in addition to the criteria in subdivision
- **16** (a):
- (i) Complete at least 56 transferable semester or 84
- 18 transferable term credits.
- 19 (ii) Obtain an associate degree or certificate at a
- 20 participating institution.
- 21 (c) To be eligible for phase I or phase II, a person must be
- 22 financially eligible as determined by the department. A person is
- 23 financially eligible for the tuition incentive program if that
- 24 person was Medicaid eligible for 24 months within the 36 months
- 25 before application. Certification of eligibility may begin in the
- 26 sixth grade.
- 27 (4) For phase I, the department shall provide payment on

- 1 behalf of a person eligible under subsection (3). The department
- 2 shall reject billings that are excessive or outside the guidelines
- 3 for the type of educational institution.
- **4** (5) For phase I, all of the following apply:
- 5 (a) Payments for associate degree or certificate programs
- 6 shall not be made for more than 80 semester or 120 term credits for
- 7 any individual student at any participating institution.
- 8 (b) For persons enrolled at a Michigan community college, the
- 9 department shall pay the current in-district tuition and mandatory
- 10 fees. For persons residing in an area that is not included in any
- 11 community college district, the out-of-district tuition rate may be
- 12 authorized.
- 13 (c) For persons enrolled at a Michigan public university, the
- 14 department shall pay lower division resident tuition and mandatory
- 15 fees for the current year.
- 16 (d) For persons enrolled at a Michigan independent, nonprofit
- 17 degree-granting college or university, or a Michigan federal
- 18 tribally controlled community college, or Focus: HOPE, the
- 19 department shall pay mandatory fees for the current year and a per-
- 20 credit payment that does not exceed the average community college
- 21 in-district per-credit tuition rate as reported on August 1, for
- 22 the immediately preceding academic year.
- 23 (6) A person participating in phase II may be eligible for
- 24 additional funds not to exceed \$500.00 per semester or \$400.00 per
- 25 term up to a maximum of \$2,000.00 subject to the following
- 26 conditions:
- 27 (a) Credits are earned in a 4-year program at a Michigan

- 1 degree-granting 4-year college or university.
- 2 (b) The tuition reimbursement is for coursework completed

- 3 within 30 months of completion of the phase I requirements.
- 4 (7) The department shall work closely with participating
- 5 institutions to develop an application and eligibility
- 6 determination process that will provide the highest level of
- 7 participation and ensure that all requirements of the program are
- 8 met.
- 9 (8) Applications for the tuition incentive program may be
- 10 approved at any time after the student begins the sixth grade. If a
- 11 determination of financial eligibility is made, that determination
- 12 is valid as long as the student meets all other program
- 13 requirements and conditions.
- 14 (9) Each institution shall ensure that all known available
- 15 restricted grants for tuition and fees are used prior to billing
- 16 the tuition incentive program for any portion of a student's
- 17 tuition and fees.
- 18 (10) The department shall ensure that the tuition incentive
- 19 program is well publicized and that potentially eligible Medicaid
- 20 clients are provided information on the program. The department
- 21 shall provide the necessary funding and staff to fully operate the
- 22 program.
- 23 Sec. 311. To enable the legislature and the state budget
- 24 director to evaluate the appropriation needs of higher education,
- 25 each independent college and university shall make available to the
- 26 legislature or state budget director, upon request, data regarding
- 27 grants for the preceding, current, and ensuing fiscal years.

3 UNIVERSITY OPERATIONS

Sec. 402. The University of Michigan biological station at
Douglas Lake in Cheboygan County is regarded as a unique resource
and is designated as a special research reserve. It is the intent

research value and capabilities of the biological station area and

- 9 Douglas Lake. The legislature further intends that no state

- 9 conducted by the agricultural experiment station and cooperative
- 10 extension service.
- Sec. 434. Included in the appropriation in part 1 for Michigan
- 12 State University is \$80,000.00 for the Michigan future farmers of
- 13 America association. This \$80,000.00 appropriation shall not
- 14 supplant any existing support that Michigan State University
- 15 provides to the Michigan future farmers of America association.
- 16 Sec. 436. (1) The funds appropriated to public universities in
- 17 part 1 from the education portion of the state fiscal stabilization
- 18 funds received under the American recovery and reinvestment act of
- 19 2009, Public Law 111-5, shall be used by the public universities,

- 16 fee charges to HEIDI within 15 days of being adopted.
- Sec. 450. (1) For the fiscal year ending September 30, 2010,
- 18 it is the intent of the legislature that an amount calculated under
- 19 subsection (2) be allocated for per-student floor funding from the
- 20 general fund/general purpose unreserved balances at the close of
- 21 the 2008-2009 fiscal year.
- 22 (2) The amount allocated under subsection (1) for per-student
- 23 floor funding is equal to \$3,775.00 per 2007-2008 fiscal-year-

- 25 students at a university is determined by reference to the higher
- 26 education institutional data inventory (HEIDI).
- Sec. 460. From the amount appropriated in part 1 to Central

- 1 Michigan University for operations, \$29,700.00 shall be paid to
- 2 Saginaw Chippewa Tribal College for the costs of waiving tuition
- 3 for North American Indians under 1976 PA 174, MCL 390.1251 to
- **4** 390.1253.
- 5 Sec. 461. From the amount appropriated in part 1 to Lake
- 6 Superior State University for operations, \$100,000.00 shall be paid
- 7 to Bay Mills Community College for the costs of waiving tuition for
- 8 North American Indians under 1976 PA 174, MCL 390.1251 to 390.1253.
- 9 Sec. 464. Each public university receiving an appropriation in
- 10 part 1 shall submit a plan by January 15, 2010 to the state budget
- 11 director, the house and senate appropriations subcommittees on
- 12 higher education, and the house and senate fiscal agencies on its
- 13 process to inform both the private and public sectors regarding
- 14 research and technology that could be developed commercially.
- 15 Sec. 466. Public universities shall coordinate their purchases
- 16 of goods and services whenever possible. This may include, but is
- 17 not limited to, group purchases for vehicles, utilities, supplies,
- 18 electronic equipment, maintenance equipment, books, and contractual

- 26 Luther King, Jr. Cesar Chavez Rosa Parks select student support
- 27 services program for developing academically or economically

- 1 disadvantaged student retention programs for 4-year public and
- 2 independent educational institutions in this state. Preference may
- 3 not be given to participants on the basis of race, color,
- 4 ethnicity, gender, or national origin. Institutions should
- 5 encourage participation from those who would otherwise not
- 6 adequately be represented in the student population.
- 7 (2) An award made under this program to any 1 institution
- 8 shall not be greater than \$150,000.00, and the amount awarded shall
- 9 be matched on a 70% state, 30% college or university basis.
- 10 (3) The program described in this section shall be
- 11 administered by the Michigan department of energy, labor, and
- 12 economic growth.
- Sec. 504. (1) Included in part 1 is funding for the Martin
- 14 Luther King, Jr. Cesar Chavez Rosa Parks college/university
- 15 partnership program between 4-year public and independent colleges
- 16 and universities and public community colleges, which is intended
- 17 to increase the number of academically or economically
- 18 disadvantaged students who transfer from community colleges into
- 19 baccalaureate programs. Preference may not be given to participants
- 20 on the basis of race, color, ethnicity, gender, or national origin.
- 21 Institutions should encourage participation from those who would
- 22 otherwise not adequately be represented in the transfer student
- 23 population.
- 24 (2) The grants shall be made under the program described in
- 25 this section to Michigan public and independent colleges and
- 26 universities. An award to any 1 institution shall not be greater
- 27 than \$150,000.00, and the amount awarded shall be matched on a 70%

- 1 state, 30% college or university basis.
- 2 (3) The program described in this section shall be
- 3 administered by the Michigan department of energy, labor, and
- 4 economic growth.
- 5 Sec. 505. (1) Included in the appropriation for each public

- 6 university in part 1 is funding for the Martin Luther King, Jr. -
- 7 Cesar Chavez Rosa Parks visiting professors program which is
- 8 intended to increase the number of instructors in the classroom to
- 9 provide role models for academically or economically disadvantaged
- 10 students. Preference may not be given to participants on the basis
- 11 of race, color, ethnicity, gender, or national origin. Public
- 12 universities should encourage participation from those who would
- 13 otherwise not adequately be represented in the student population.
- 14 (2) The program described in this section shall be
- 15 administered by the Michigan department of energy, labor, and
- 16 economic growth.
- 17 Sec. 506. (1) Included in the appropriation in part 1 is
- 18 funding under the Martin Luther King, Jr. Cesar Chavez Rosa
- 19 Parks initiative for the Morris Hood, Jr. educator development
- 20 program which is intended to increase the number of academically or
- 21 economically disadvantaged students who enroll in and complete K-12
- 22 teacher education programs at the baccalaureate level. Preference
- 23 may not be given to participants on the basis of race, color,
- 24 ethnicity, gender, or national origin. Institutions should
- 25 encourage participation from those who would otherwise not
- 26 adequately be represented in the teacher education student
- 27 population.

- 1 (2) The program described in this section shall be
- 2 administered by each state-approved teacher education institution
- 3 in a manner prescribed by the Michigan department of energy, labor,
- 4 and economic growth.
- 5 (3) Approved teacher education institutions may and are
- 6 encouraged to use student support services funding in coordination
- 7 with the Morris Hood, Jr. funding to achieve the goals of the
- 8 program described in this section.

- $\mathbf{4}$ (v) Do not require funding from the state other than that
- 5 provided by the student credit hours generated within the program,
- 6 either before program initiation or within the first 3 years of
- 7 program operation.
- 8 (3) The auditor general shall periodically audit higher
- 9 education institutional data inventory (HEIDI) data as submitted by
- 10 the public universities for compliance with the definitions
- 11 established by the state budget director in consultation with the
- 12 HEIDI advisory committee for the HEIDI database.
- 13 (4) "Distance learning instruction" as used in subsection (2)
- 14 means instruction that occurs solely in other than a traditional
- 15 classroom setting where the student and instructor are in the same
- 16 physical location and for which a student receives course credits
- 17 and is charged tuition and fees. Examples of distance learning
- 18 instruction are instruction delivered solely through the Internet,

- 15 (FERPA), 20 USC 1232g, 34 CFR part 99, shall, when requested,
- 16 provide information from the records of a student to any person or
- 17 persons to whom the student has authorized disclosure on a written
- 18 consent form pursuant to 34 CFR 99.30.
