- **27** 1961(1).

- 1 (NN) (kk) An offense committed within this state or another
- 2 state in violation of a law of the United States that is
- 3 substantially similar to a violation listed in subdivisions (a)
- 4 through (ii) (MM).
- 5 (OO) (#)—An offense committed in another state in violation of
- 6 a statute of that state that is substantially similar to a
- 7 violation listed in subdivisions (a) through (ii) (MM).
- 8 (PP) (mm)—A felony violation of section 909(4) of the Michigan
- 9 liquor control code of 1998, 1998 PA 58, MCL 436.1909, concerning
- 10 the illegal sale, delivery, or importation of spirits.
