HOUSE BILL No. 5998

March 25, 2010, Introduced by Reps. Nathan, Byrnes, Liss, Donigan, Wayne Schmidt and Stanley and referred to the Committee on Intergovernmental and Regional Affairs.

A bill to amend 1974 PA 338, entitled

"Economic development corporations act,"

by amending section 3 (MCL 125.1603), as amended by 1985 PA 154.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. As used in this act:
- 2 (a) "Corporation" means a corporation organized pursuant to
- 3 this act.
- 4 (b) "Employee-owned corporation" means an employee-owned
- 5 corporation as defined by the employee-owned corporation act.
- 6 (c) "Governing body" means the body in which the legislative7 powers of a municipality are vested.
 - (d) "Municipality" means a county, city, village, or township.
 - (e) "Local public agency" means the official body of a

- 1 municipality authorized to plan and implement the development and
- 2 redevelopment of the municipality.
- 3 (f) "Project" means land or an interest in land, existing or
- 4 planned improvements, machinery, furnishings, or equipment suitable
- 5 for use by any of the following:
- 6 (i) An industrial or commercial enterprise, including
- 7 agricultural and forestry enterprises and enterprises designed to
- 8 produce energy from renewable resources. Projects of such an
- 9 enterprise may include any of the following:
- 10 (A) Necessary buildings, improvements, or structures suitable
- 11 for and intended for or incidental to use as an industrial or
- 12 commercial enterprise.
- 13 (B) Industrial park or industrial site improvements or port
- 14 improvements.
- 15 (C) A replacement housing project incidental to an industrial
- 16 or commercial enterprise.
- 17 (D) The machinery, furnishings, leasehold improvements, or
- 18 equipment necessary, suitable, intended for or incidental to a
- 19 commercial, industrial, or residential use in connection with the
- 20 buildings, improvements, or structures.
- 21 (E) Machinery, furnishings, leasehold improvements, or
- 22 equipment, including pollution control facilities, to be installed
- 23 or used primarily within a project area.
- 24 (ii) An enterprise in relation to a housing and neighborhood
- 25 improvement program, which program involves either the clearing of
- 26 land or the rehabilitation or construction of housing for the
- 27 immediate sale of single family SINGLE-FAMILY or multi-family

- 1 MULTIFAMILY units at fair market value, or both. Housing and
- 2 neighborhood improvement programs identified by this subparagraph
- 3 shall constitute a project for purposes of this subparagraph if the
- 4 area in which these improvement programs are to be undertaken are
- 5 located in, or are eligible to be included in, blighted or
- 6 redevelopment areas identified pursuant to Act No. 344 of the
- 7 Public Acts of 1945, as amended, being sections 125.71 to 125.84 of
- 8 the Michigan Compiled Laws 1945 PA 344, MCL 125.71 TO 125.84; the
- 9 urban redevelopment corporations law, Act No. 250 of the Public
- 10 Acts of 1941, as amended, being sections 125.901 to 125.922 of the
- 11 Michigan Compiled Laws 1941 PA 250, MCL 125.901 TO 125.922; Act No.
- 12 197 of the Public Acts of 1975, as amended, being sections 125.1651
- 13 to 125.1680, of the Michigan Compiled Laws 1975 PA 197, MCL
- 14 125.1651 TO 125.1681, or the tax increment finance authority act,
- 15 Act No. 450 of the Public Acts of 1980, being sections 125.1801 to
- 16 125.1828 of the Michigan Compiled Laws 1980 PA 450, MCL 125.1801 TO
- 17 125.1830.
- 18 (iii) A TRANSIT-ORIENTED DEVELOPMENT.
- 19 (iv) A TRANSIT-ORIENTED FACILITY.
- 20 (g) "Project area" means that land area or an interest in a
- 21 land area within the municipality which will be acquired in the
- 22 implementation of a project or which will be the permanent site of
- 23 machinery, furnishings, or equipment constituting all or part of a
- 24 project.
- 25 (h) "Project citizens district council" means a project
- 26 citizens district council established pursuant to this act.
- (i) "Project cost" or "costs" means the cost of purchasing,

- 1 acquiring, constructing, improving, enlarging, extending, or
- 2 repairing a project. Project cost or costs includes any
- 3 engineering, architectural, legal, accounting, financial, and other
- 4 expenses incidental to the purchasing, acquiring, constructing,
- 5 improving, enlarging, extending, or repairing of a project. Project
- 6 cost or costs also includes the interest on the bonds and other
- 7 obligations issued to pay project costs during the period of
- 8 construction and after the period of construction until sufficient
- 9 revenues have developed. Project cost or costs also includes a
- 10 reserve or addition to a reserve for payment of principal and
- 11 interest on the bonds and the amount required for operation and
- 12 maintenance until sufficient revenues have developed.
- 13 (j) "Project district area" means that portion of a
- 14 municipality and any area adjacent to a municipality, as determined
- 15 by its governing body, which contains a project area and the
- 16 surrounding territory that will be significantly affected by a
- 17 project.
- 18 (k) "Project plan" means that information and those
- 19 requirements for a project set forth in section 8.
- (l) "Pollution control facilities" means water or air pollution
- 21 control equipment or solid waste disposal facilities located within
- 22 or without the limits of the municipality.
- (m) "Solid waste disposal facilities" means buildings, plants,
- 24 structures, equipment, or facilities and their appurtenances,
- 25 together with land or an interest in land or a portion of land, for
- 26 the purpose of treating, shredding, compression, high temperature
- 27 incineration, pyrolization, separation, or any other technology for

- 1 recovery, transporting, storing, or the final placement and
- 2 disposal of solid wastes resulting from any process of industry,
- 3 manufacture, trade, or business, from the development, processing,
- 4 or recovery of any natural resources, or from the operation of any
- 5 public utility. Solid waste disposal facilities includes buildings,
- 6 plants, structures, equipment, or facilities and their
- 7 appurtenances, together with land or an interest in land or a
- 8 portion of land, which qualify as solid waste disposal facilities
- 9 under section 103(b)(4) of the internal revenue code.
- 10 (N) "TRANSIT-ORIENTED DEVELOPMENT" MEANS INFRASTRUCTURE
- 11 IMPROVEMENTS THAT ARE LOCATED WITHIN 1/2 MILE OF A TRANSIT STATION
- 12 OR TRANSIT-ORIENTED FACILITY THAT PROMOTES TRANSIT RIDERSHIP OR
- 13 PASSENGER RAIL USE.
- 14 (O) "TRANSIT-ORIENTED FACILITY" MEANS A FACILITY THAT HOUSES A
- 15 TRANSIT STATION IN A MANNER THAT PROMOTES TRANSIT RIDERSHIP OR
- 16 PASSENGER RAIL USE.
- 17 (P) (n) "Water and air pollution control equipment" means
- 18 buildings, plants, structures, equipment, or facilities and their
- 19 appurtenances, together with land or an interest in land or a
- 20 portion of land, for the purpose of controlling, eliminating,
- 21 recovering, removing, reducing, dispersing, treating, or
- 22 neutralizing atmospheric or water pollutants, including liquid,
- 23 gaseous, or solid substances or discharges or radiation, or cooling
- 24 the temperature of atmospheric or water pollutants, or any liquid,
- 25 gas, or solid, resulting from any process of industry, manufacture,
- 26 trade, or business; the development, processing, or recovery of any
- 27 natural resources; or the operation of any public utility, any of

- 1 which may pollute or may tend to pollute or affect the water or air
- 2 of this state or adjacent to this state. Water and air pollution
- 3 control equipment includes buildings, plants, structures,
- 4 facilities, and equipment and their appurtenances, together with
- 5 land or an interest in land or a portion of land, used or to be
- 6 used as a change in a manufacturing, production, generation,
- 7 transmission, or distribution process to prevent, reduce, recover,
- 8 remove, disperse, neutralize, control, or eliminate air or water
- 9 pollution. Water and air pollution control equipment includes
- 10 buildings, plants, structures, equipment, or facilities and their
- 11 appurtenances, together with land or an interest in land or a
- 12 portion of land, which qualify as air or water pollution control
- 13 facilities under section 103(b)(4) of the internal revenue code.
