## SUBSTITUTE FOR HOUSE BILL NO. 6128

## A bill to amend 1964 PA 286, entitled

"An act to provide for the organization, powers, and duties of the state transportation commission and the state transportation department; to provide for the appointment, powers, and duties of the state transportation director; to abolish the office of state highway commissioner and the commissioner's advisory board and to transfer their powers and duties; to provide for penalties and remedies; and to repeal certain acts and parts of acts,"

(MCL 247.801 to 247.816) by adding section 6c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 6C. (1) THE DEPARTMENT SHALL PROVIDE, WHEREVER POSSIBLE,
- 2 TECHNICAL SUPPORT, ADVICE, AND RESOURCES TO ASSIST COMMUNITY
- 3 REPRESENTATIVES IN COMMUNITIES AFFECTED BY AN INTERNATIONAL BRIDGE
- 4 CROSSING THAT DOES NOT EXIST ON THE EFFECTIVE DATE OF THE

- 1 AMENDATORY ACT THAT ADDED THIS SECTION TO ENTER INTO COMMUNITY
- 2 BENEFITS AGREEMENTS WITH THIS STATE, CONTRACTORS, DEVELOPERS, OR
- 3 CONCESSIONAIRES WHO ARE IMPLEMENTING AN INTERNATIONAL BRIDGE
- 4 CROSSING PROJECT THAT DOES NOT EXIST ON THE EFFECTIVE DATE OF THE
- 5 AMENDATORY ACT THAT ADDED THIS SECTION.
- 6 (2) IF A CONTRACTOR, DEVELOPER, OR CONCESSIONAIRE WHO ENTERS
- 7 INTO A COMMUNITY BENEFITS AGREEMENT UNDER SUBSECTION (1) DEFAULTS
- 8 IN THE PERFORMANCE OF ITS DUTIES UNDER THAT AGREEMENT, THE
- 9 DEPARTMENT SHALL PERFORM THE DUTIES OF THE CONTRACTOR, DEVELOPER,
- 10 OR CONCESSIONAIRE UNDER THAT AGREEMENT.
- 11 (3) WHENEVER THE DEPARTMENT ISSUES A REQUEST FOR PROPOSALS FOR
- 12 CONSTRUCTION OF AN INTERNATIONAL BRIDGE CROSSING PROJECT THAT DOES
- 13 NOT EXIST ON THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 14 THIS SECTION, THE REQUEST SHALL INCLUDE THE REQUIREMENTS OF A
- 15 COMMUNITY BENEFITS AGREEMENT DESCRIBED IN THIS SECTION THAT WILL BE
- 16 REQUIRED OF THE CONTRACTOR, DEVELOPER, OR CONCESSIONAIRE.
- 17 (4) DURING THE REQUEST FOR PROPOSALS SELECTION PROCESS, THE
- 18 DEPARTMENT SHALL CONSULT WITH THE HOST COMMUNITY AS REPRESENTED BY
- 19 A NONPROFIT ORGANIZATION WITH MEMBERS IN THE HOST COMMUNITY THAT
- 20 HAS ENGAGED RESIDENTS AND STAKEHOLDERS AND WHOSE ORGANIZATIONAL
- 21 PURPOSE IS TO ENSURE THAT THE INTERESTS OF RESIDENTS, BUSINESSES,
- 22 AND ORGANIZATIONS PROXIMATE TO THE HOST COMMUNITY ARE RECOGNIZED
- 23 AND PROTECTED AS RELATED TO THE DEVELOPMENT OF THE PROJECT FOR
- 24 WHICH THE REQUEST FOR PROPOSALS IS INITIATED. AS USED IN THIS
- 25 SUBSECTION, "HOST COMMUNITY" ENCOMPASSES THE BOUNDARIES OF ALL
- 26 CONSTRUCTION IN THIS STATE FOR AN INTERNATIONAL BRIDGE CROSSING
- 27 PROJECT THAT DOES NOT EXIST ON THE EFFECTIVE DATE OF THE AMENDATORY

## House Bill No. 6128 (H-3) as amended May 26, 2010

- 1 ACT THAT ADDED THIS SECTION, INCLUDING THE BRIDGE, PLAZA, AND
- 2 DIRECT ACCESS ROAD CHANGES. THE DEPARTMENT SHALL PROVIDE
- 3 INFORMATION TO THE NONPROFIT ORGANIZATION THAT THE DEPARTMENT IS
- 4 CONSULTING WITH CONCERNING THE PROPOSALS THE DEPARTMENT RECEIVED.
- 5 AFTER RECEIVING THAT INFORMATION FROM THE DEPARTMENT BUT BEFORE THE
- 6 SELECTION OF THE WINNING PROPOSAL, THE NONPROFIT ORGANIZATION SHALL
- 7 PROVIDE ITS ADVISORY RECOMMENDATIONS TO THE DEPARTMENT WITHIN A
- 8 REASONABLE TIME FRAME SET BY THE DEPARTMENT AND CONSISTENT WITH THE
- 9 TIMELINE OF THE SELECTION PROCESS.
- 10 (5) AS USED IN THIS SECTION, A "COMMUNITY BENEFITS AGREEMENT"
- 11 IS A CONTRACT BETWEEN THIS STATE OR A CONTRACTOR, DEVELOPER, OR
- 12 CONCESSIONAIRE AND THE NONPROFIT ORGANIZATION IDENTIFIED BY THE
- 13 DEPARTMENT UNDER SUBSECTION (4). THE AGREEMENT SHALL IMPLEMENT
- 14 SUSTAINABLE BENEFITS TO THE COMMUNITY, IN ADDITION TO ANY BENEFITS
- 15 REQUIRED BY EXISTING FEDERAL, STATE, OR LOCAL LAWS, WHICH MAY
- 16 INCLUDE, BUT NOT BE LIMITED TO, ANY OF THE FOLLOWING:
- 17 (A) PRESERVATION, RESTORATION, OR REPLACEMENT OF COMMUNITY
- 18 RESOURCES DIRECTLY AFFECTED BY THE PROJECT.
- 19 (B) JOBS, EMPLOYMENT TRAINING, AND RELATED FACILITIES.
- 20 (C) MODIFICATIONS OR REMEDIES FOR STRUCTURES OR EQUIPMENT
- 21 DIRECTLY IMPACTED BY THE PROJECT.
- 22 (D) ECONOMIC DEVELOPMENT.
- 23 (E) HOUSING AND HOME REPAIR PROGRAMS.
- 24 (F) AIR QUALITY PROGRAMS.
- 25 (G) GREEN DEVELOPMENT INITIATIVES.
