## SENATE SUBSTITUTE FOR HOUSE BILL NO. 6099

## A bill to amend 1981 PA 118, entitled

"An act to regulate motor vehicle manufacturers, distributors, wholesalers, dealers, and their representatives; to regulate dealings between manufacturers and distributors or wholesalers and their dealers; to regulate dealings between manufacturers, distributors, wholesalers, dealers, and consumers; to prohibit unfair practices; to provide remedies and penalties; and to repeal certain acts and parts of acts,"

by amending sections 2, 3, and 4 (MCL 445.1562, 445.1563, and 445.1564), sections 2 and 3 as amended by 1998 PA 456 and section 4 as amended by 2000 PA 240.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. (1) "Closed dealership" means a new motor vehicle
- 2 dealer whose dealer agreement has been terminated, canceled,
- 3 discontinued, or not renewed.
- 4 (2) "COERCE" MEANS TO COMPEL OR ATTEMPT TO COMPEL A PERSON TO
- 5 ACT IN A GIVEN MANNER OR TO REFRAIN FROM ACTING IN A GIVEN MANNER

- 1 BY PRESSURE, INTIMIDATION, OR THREAT OF HARM, DAMAGE, BREACH OF
- 2 CONTRACT, OR OTHER ADVERSE CONSEQUENCES, INCLUDING, BUT NOT LIMITED
- 3 TO, THE LOSS OF ANY BENEFIT AVAILABLE TO OTHER NEW MOTOR VEHICLE
- 4 DEALERS OF THE SAME LINE MAKE IN THIS STATE. THE TERM DOES NOT
- 5 INCLUDE ANY OF THE FOLLOWING ACTIONS BY A MANUFACTURER:
- 6 (A) WITHOUT CONDITIONS, MAKING A GOOD FAITH RECOMMENDATION,
- 7 EXPOSITION, OR ARGUMENT OR PERSUADING OR ATTEMPTING TO PERSUADE A
- 8 PERSON.
- 9 (B) GIVING NOTICE IN GOOD FAITH TO A NEW MOTOR VEHICLE DEALER
- 10 OF THAT DEALER'S VIOLATION OF THE TERMS OR PROVISIONS OF A DEALER
- 11 AGREEMENT.
- 12 (C) ENGAGING IN ANY CONDUCT THE MANUFACTURER IS PERMITTED TO
- 13 ENGAGE IN UNDER THIS ACT.
- 14 (3) (2) "Dealer agreement" means the AN agreement or contract
- 15 in writing between a distributor and a new motor vehicle dealer,
- 16 between a manufacturer and a distributor or a new motor vehicle
- 17 dealer, or between an importer and a distributor or a new motor
- 18 vehicle dealer, which THAT purports to establish the legal rights
- 19 and obligations of the parties to the agreement or contract with
- 20 regard to the purchase and sale or resale of new and unaltered
- 21 motor vehicles and accessories for motor vehicles AND UNDER WHICH
- 22 THE DEALER PURCHASES AND RESELLS NEW MOTOR VEHICLES AND CONDUCTS
- 23 SERVICE OPERATIONS. THE TERM INCLUDES THE SALES AND SERVICE
- 24 AGREEMENT, REGARDLESS OF THE TERMINOLOGY USED TO DESCRIBE THAT
- 25 AGREEMENT, AND ANY ADDENDA TO THE DEALER AGREEMENT, INCLUDING ALL
- 26 SCHEDULES, ATTACHMENTS, EXHIBITS, AND AGREEMENTS INCORPORATED BY
- 27 REFERENCE INTO THE DEALER AGREEMENT.

- 1 (4) (3) "Designated family member" means ANY OF THE FOLLOWING:
- 2 (A) IF A NEW MOTOR VEHICLE DEALER WHO DIES OR BECOMES
- 3 INCAPACITATED HAS DESIGNATED A SUCCESSOR UNDER SECTION 15(6), THAT
- 4 DESIGNATED SUCCESSOR.
- 5 (B) IF A NEW MOTOR VEHICLE OWNER DIES AND HAS NOT DESIGNATED A
- 6 SUCCESSOR UNDER SECTION 15(6), the spouse —OR A child, grandchild,
- 7 parent, brother, or sister of a deceased new motor vehicle dealer,
- 8 who is entitled to inherit the deceased dealer's ownership interest
- 9 in the new motor vehicle dealership under the terms of the dealer's
- 10 will, or who has otherwise been designated in writing by a deceased
- 11 dealer to succeed the deceased dealer in the new motor vehicle
- 12 dealership, or WHO is entitled to inherit under the laws of
- 13 intestate succession of this state . With respect to an
- 14 incapacitated new motor vehicle dealer, the term means the person
- 15 appointed by a court as the legal representative of the new motor
- 16 vehicle dealer's property. The term also includes OR the appointed
- 17 and qualified personal representative and the OR testamentary
- 18 trustee of a-THE deceased new motor vehicle dealer. However, the
- 19 term shall mean only that designated successor nominated by the new
- 20 motor vehicle dealer in a written document filed by the dealer with
- 21 the manufacturer or distributor, if such a document is filed.
- 22 (C) IF A NEW MOTOR VEHICLE DEALER BECOMES INCAPACITATED AND
- 23 HAS NOT DESIGNATED A SUCCESSOR UNDER SECTION 15(6), THE PERSON
- 24 APPOINTED BY THE COURT AS THE LEGAL REPRESENTATIVE OF THE DEALER.
- 25 Sec. 3. (1) "Distributor" means any person, including an
- 26 importer, resident or nonresident, who THAT IS LOCATED IN OR
- 27 OUTSIDE OF THIS STATE AND is engaged in the business pursuant to a

- 1 dealer agreement, in whole or in part, of offering for sale,
- 2 selling, or distributing new and unaltered motor vehicles to a new
- 3 motor vehicle dealer , who UNDER A DEALER AGREEMENT, THAT maintains
- 4 a factory representative for such purposes, resident or
- 5 nonresident, THAT IS LOCATED IN OR OUTSIDE OF THIS STATE FOR
- 6 PURPOSES OF CONDUCTING THAT BUSINESS, or who THAT controls any A
- 7 person , resident or nonresident, who in whole or in part THAT IS
- 8 LOCATED IN OR OUTSIDE OF THIS STATE AND offers for sale, sells, or
- 9 distributes new and unaltered motor vehicles to a new motor vehicle
- 10 dealer. Distributor does not include a person who THAT alters or
- 11 converts motor vehicles for sale to a new motor vehicle dealer.
- 12 (2) "Established place of business" means a permanent,
- 13 enclosed commercial building located within IN this state THAT IS
- 14 easily accessible and open to the public at all reasonable times
- 15 and at which the business of a new motor vehicle dealer MAY LEGALLY
- 16 CONDUCT BUSINESS, including the display and repair of motor
- 17 vehicles, may be lawfully carried on in accordance COMPLIANCE with
- 18 the terms of all applicable buildings codes, zoning, and other
- 19 land-use regulatory ordinances.
- 20 (3) "EXECUTIVE MANAGER" MEANS AN INDIVIDUAL EMPLOYED BY A NEW
- 21 MOTOR VEHICLE DEALER IN AN EXECUTIVE CAPACITY AND WHO HAS A WRITTEN
- 22 EMPLOYMENT AGREEMENT WITH THE DEALER THAT INCLUDES A RIGHT FOR THE
- 23 EXECUTIVE MANAGER TO PURCHASE A CONTROLLING INTEREST IN THE
- 24 DEALERSHIP AT A FUTURE TIME OR ON THE DEATH OR INCAPACITY OF THE
- 25 DEALER.
- 26 (4) (3)—"Factory branch" means an office maintained by a
- 27 manufacturer or distributor for the purpose of selling or offering

- 1 for sale TO SELL vehicles to a distributor, wholesaler, or new
- 2 motor vehicle dealer or for directing or supervising in whole or
- 3 in part ANY factory or distributor representatives. The term
- 4 includes any sales promotion organization maintained by a
- 5 manufacturer or distributor which THAT is engaged in promoting the
- 6 sale of a particular make of new motor vehicles in this state to
- 7 new motor vehicle dealers.
- 8 (5) (4) "Factory representative" means an agent or employee of
- 9 a manufacturer, distributor, or factory branch retained or employed
- 10 for the purpose of making or promoting the sale of new motor
- 11 vehicles or for supervising or contracting with new motor vehicle
- 12 dealers or proposed motor vehicle dealers.
- Sec. 4. (1) "Good faith" means honesty in fact and the
- 14 observation of reasonable commercial standards of fair dealing in
- 15 the trade, as defined and interpreted under THAT TERM AS DEFINED IN
- 16 section 2103 of the uniform commercial code, 1962 PA 174, MCL
- **17** 440.2103.
- 18 (2) "Manufacturer" means any A person who THAT manufactures or
- 19 assembles new motor vehicles ; or any A distributor, factory
- 20 branch, or factory representative.
- 21 (3) "Motor vehicle" means that term as defined in section 33
- 22 of the Michigan vehicle code, 1949 PA 300, MCL 257.33, but does not
- 23 include a bus, A tractor, or farm equipment.
- 24 (4) "MOTOR VEHICLE SERVICE AND REPAIR FACILITY" MEANS A MOTOR
- 25 VEHICLE REPAIR FACILITY, AS DEFINED IN SECTION 2 OF THE MOTOR
- 26 VEHICLE SERVICE AND REPAIR ACT, 1974 PA 300, MCL 257.1302. THE TERM
- 27 DOES NOT INCLUDE A MOTOR VEHICLE DEALER PERFORMING MAINTENANCE,

- 1 DIAGNOSIS, VEHICLE BODY WORK, REPAIRS, OR OTHER SERVICE OR REPAIR
- 2 WORK ON MOTOR VEHICLES UNDER THE TERMS OF A DEALER AGREEMENT.
- 3 Enacting section 1. This amendatory act does not take effect
- 4 unless all of the following bills of the 95th Legislature are
- 5 enacted into law:
