

SUBSTITUTE FOR  
HOUSE BILL NO. 6232

A bill to amend 1954 PA 116, entitled  
"Michigan election law,"  
by amending section 642a (MCL 168.642a), as amended by 2010 PA 182.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

- 1       Sec. 642a. (1) After December 31, 2004, a city council that  
2       adopted a resolution so that its regular election is held on the  
3       May regular election date may change its regular election to the  
4       odd year general election by adopting a resolution in compliance  
5       with section 642. If a city council adopts the resolution in  
6       compliance with section 642 to hold its regular election at the odd  
7       year general election, after December 31 of the year in which the  
8       resolution is adopted, the city's regular election is at the odd  
9       year general election.
- 10       (2) After December 31, 2004, a city council that holds its

1 regular election for city offices annually or in the even year on  
2 the November regular election date may change its regular election  
3 schedule to the odd year general election and the odd year primary  
4 election by adopting a resolution in compliance with section 642.  
5 If a city council adopts the resolution in compliance with section  
6 642, the city's regular election is at the odd year general  
7 election and its primary is at the odd year primary election.

8 (3) After December 31, 2010, a city that adopted a resolution  
9 so that its regular election primary is held at the September  
10 election shall hold its regular election primary at the odd year  
11 primary election.

12 (4) After December 31, 2004, a school district's school board  
13 that adopted a resolution so that its regular election is held on a  
14 date other than at the odd year general election may change its  
15 regular election to the odd year general election, the general  
16 November election, the November regular election date in both even  
17 and odd years, or the odd year May regular election date by  
18 adopting a resolution in compliance with section 642. If a school  
19 board adopts the resolution in compliance with section 642 to hold  
20 its regular election at the odd year general election, the general  
21 November election, the November regular election date in both even  
22 and odd years, or the odd year May regular election date, after  
23 December 31 of the year in which the resolution is adopted, the  
24 school board's school district shall hold its regular election on  
25 the election date adopted in the resolution.

26 (5) AFTER DECEMBER 31, 2009, A SCHOOL DISTRICT'S SCHOOL BOARD  
27 THAT HOLDS ITS REGULAR ELECTION FOR THE OFFICE OF SCHOOL BOARD

1 MEMBER AT THE ODD YEAR GENERAL ELECTION MAY CHANGE ITS REGULAR  
2 ELECTION TO THE GENERAL NOVEMBER ELECTION BY ADOPTING A RESOLUTION  
3 IN COMPLIANCE WITH SECTION 642. IF A SCHOOL BOARD ADOPTS THE  
4 RESOLUTION IN COMPLIANCE WITH SECTION 642 TO HOLD ITS REGULAR  
5 ELECTION AT THE GENERAL NOVEMBER ELECTION, AFTER DECEMBER 31 OF THE  
6 YEAR IN WHICH THE RESOLUTION IS ADOPTED, THE SCHOOL BOARD'S SCHOOL  
7 DISTRICT SHALL HOLD ITS REGULAR ELECTION AT THE GENERAL NOVEMBER  
8 ELECTION.

9 (6) ~~(5)~~—After December 31, 2004, a village council that  
10 adopted a resolution so that its regular election is held on the  
11 September election date may change its regular election to the  
12 November regular election date by adopting a resolution in  
13 compliance with section 642. If a village council adopts the  
14 resolution in compliance with section 642 to hold its regular  
15 election at the November regular election date, after December 31  
16 of the year in which the resolution is adopted, the village's  
17 regular election is at the November regular election date.
