6 PROVISIONS CONCERNING APPROPRIATIONS

7 GENERAL SECTIONS

8 Sec. 201. In accordance with the provisions of section 30 of
 9 article IX of the state constitution of 1963, total state spending
 10 from state resources in this appropriation act for the fiscal year
 11 ending September 30, 2009 is \$(980,588,500.00) and state
 12 appropriations paid to local units of government are
 13 \$(186,946,100.00). The itemized statement below identifies
 14 appropriations from which spending to local units of government
 15 will occur:

21 Sec. 202. The appropriations made and expenditures authorized
 22 under this act and the departments, commissions, boards, offices,
 23 and programs for which appropriations are made under this act are
 24 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 25 to 18.1594.

1 Sec. 203. The line-item appropriations in part 1 financed by
2 federal funds designated as ARRA funding represent federal funds
3 associated with the American recovery and reinvestment act of 2009,
4 Public Law 111-5. These federal funds are temporary in nature. It
5 is the intent of the legislature that when these temporary federal
6 funds are fully expended, the program funding levels and any state
7 employees supported by these temporary federal funds will not be
8 continued.

9 Sec. 210. (1) In addition to the funds appropriated in part 1,
10 there is appropriated an amount equal to any additional federal
11 funding awarded to this state through recalculation of formulas and
12 under the redistribution provisions of the American recovery and
13 reinvestment act of 2009, Public Law 111-5.

14 (2) Within 30 days of receiving such an award, a department
15 shall report to the senate and house appropriations subcommittees,
16 senate and house fiscal agencies, state budget director, and the
17 governor on the amount of funds received and the purposes for which
18 they will be spent.

19 Sec. 211. The unexpended funds appropriated in part 1 and in
20 section 210 and any unencumbered or unallotted funds are carried
21 forward into the succeeding fiscal year. The following is in
22 compliance with section 451a(1) of the management and budget act,
23 1984 PA 431, MCL 18.1451a:

24 (a) The purposes of the projects to be carried forward are to
25 provide assistance to low-income families with their day care needs
26 while working or participating in employment and training
27 activities and to protect and invest in the natural resources,

1 infrastructure, and people of the state of Michigan in accordance
2 with the provisions of the American recovery and reinvestment act
3 of 2009, Public Law 111-5.

4 (b) The projects will be accomplished by state employees and
5 by contract.

6 (c) The total estimated cost of all projects is identified in
7 each line-item appropriation.

8 (d) The tentative completion date is September 30, 2012.

9 Sec. 212. (1) In a form and manner determined by the recipient
10 department, local governments and other eligible sub-recipients
11 receiving funds through this act shall comply will all requirements
12 corresponding to the receipt of funds, including, but not limited
13 to, any certifications, assurances, and accountability and
14 transparency provisions required in the American recovery and
15 reinvestment act of 2009, Public Law 111-5.

16 (2) Funds appropriated in part 1 may be transferred to sub-
17 recipient state departments or agencies in an interdepartmental
18 grant consistent with the requirements of the American recovery and
19 reinvestment act of 2009, Public Law 111-5.
