- 26 and agencies at the end of the first fiscal quarter for the 1%

- 3 Sec. 205. (1) A hiring freeze is imposed on the state

- 5 fund/general purpose dollars in compliance with section 26 of
- 6 article I of the state constitution of 1963.
- 7 Sec. 213. From the funds appropriated in part 1 for
- 8 information technology, departments and agencies shall pay user
- 9 fees to the department of information technology for technology-
- 10 related services and projects. The user fees are subject to
- 11 provisions of an interagency agreement between the department and

- Sec. 214. Amounts appropriated in part 1 for information
- 14 technology may be designated as work projects and carried forward

- 25 judicial branch of government, other organizations, and patrons of
- 26 department facilities. Fees for services shall be reasonably
- 27 related to the cost of providing the services and shall be used to

- 1 offset the costs of the services. The department may receive and
- 2 expend funds in addition to those authorized in part 1 which may
- 3 include, but are not limited to, the following:
- 4 (a) Supplying census-related information and technical
- 5 services, publications, statistical studies, population projections
- 6 and estimates, and other demographic products.
- 7 (b) Document and data imaging services, media, storage, and
- 8 copies.
- 9 (c) Patron copier and document reproduction services and
- 10 copies.
- 11 (d) Conferences, training classes, exhibits, programs, and
- 12 workshops conducted as part of the department's mission.
- 13 (e) Use of specialized equipment, facilities, and software
- 14 that permit distance learning and meetings, and group decision
- 15 making.
- 16 (f) Special services including the rental of department
- 17 exhibits and collections.
- 18 (g) Application and other fees.
- 19 (h) Grants, gifts, and bequests from private or public
- 20 sources, including those for capital projects.
- 21 (2) The funds received under this section shall be deposited
- 22 in and expended from the history, arts, and libraries fund
- 23 established in section 216 of this act.
- Sec. 216. (1) A fund known as the history, arts, and libraries
- 25 fund is created in the department. The fund shall be used to
- 26 receive and expend funds identified in sections 215 and 404(a). All
- 27 funds in excess of those funds appropriated in part 1 are

- 1 appropriated for expenditure upon receipt. The fund balance may be
- 2 carried forward for expenditure in subsequent fiscal years.
- 3 (2) The department shall provide a report to the senate and
- 4 house of representatives appropriations subcommittees on history,
- 5 arts, and libraries, and to the state budget director, of all
- 6 revenues to and expenditures from the history, arts, and libraries
- 7 fund in excess of those amounts appropriated in part 1. The report
- 8 shall include an estimated fund balance for the fiscal year ending
- 9 September 30, 2010. The report is due November 1, 2010.
- 10 Sec. 217. (1) Due to the current budgetary problems in this
- 11 state, out-of-state travel for the fiscal year ending September 30,
- 12 2010 shall be limited to situations in which 1 or more of the
- 13 following conditions apply:
- 14 (a) The travel is required by legal mandate or court order or
- 15 for law enforcement purposes.
- 16 (b) The travel is necessary to protect the health or safety of
- 17 Michigan citizens or visitors or to assist other states in similar
- 18 circumstances.
- 19 (c) The travel is necessary to produce budgetary savings or to
- 20 increase state revenues, including protecting existing federal
- 21 funds or securing additional federal funds.
- (d) The travel is necessary to comply with federal
- 23 requirements.
- (e) The travel is necessary to secure specialized training for
- 25 staff that is not available within this state.
- (f) The travel is financed entirely by federal or nonstate
- 27 funds.

- 1 (2) If out-of-state travel is necessary but does not meet 1 or
- 2 more of the conditions in subsection (1), the state budget director
- 3 may grant an exception to allow the travel. Any exceptions granted
- 4 by the state budget director shall be reported on a monthly basis
- 5 to the senate and house of representatives standing committees on
- 6 appropriations.
- 7 (3) Not later than January 1 of each year, each department
- 8 shall prepare a travel report listing all travel by classified and
- 9 unclassified employees outside this state in the immediately
- 10 preceding fiscal year that was funded in whole or in part with
- 11 funds appropriated in the department's budget. The report shall be
- 12 submitted to the senate and house of representatives standing
- 13 committees on appropriations, the senate and house fiscal agencies,
- 14 and the state budget director. The report shall include the
- 15 following information:
- 16 (a) The name of each person receiving reimbursement for travel
- 17 outside this state or whose travel costs were paid by this state.
- 18 (b) The destination of each travel occurrence.
- 19 (c) The dates of each travel occurrence.
- (d) A brief statement of the reason for each travel
- 21 occurrence.
- 22 (e) The transportation and related costs of each travel
- 23 occurrence, including the proportion funded with state general
- 24 fund/general purpose revenues, the proportion funded with state
- 25 restricted revenues, the proportion funded with federal revenues,
- 26 and the proportion funded with other revenues.
- 27 (f) A total of all out-of-state travel funded for the

- 1 immediately preceding fiscal year.
- 2 Sec. 217a. The department shall not approve the travel of more

- 3 than 1 departmental employee to a specific professional development
- 4 conference or training seminar that is located outside of this
- 5 state unless the professional development conference or training
- 6 seminar is funded by a federal or private funding source and
- 7 requires more than 1 person from a department to attend, or the
- 8 conference or training seminar includes multiple issues in which 1
- 9 employee from the department does not have expertise.
- 10 Sec. 218. It is the intent of the legislature to explore
- 11 supplemental fund sourcing options for the department.
- Sec. 219. The department shall not take disciplinary action
- 13 against an employee for communicating with a member of the
- 14 legislature or his or her staff.
- 15 Sec. 222. The director shall take all reasonable steps to
- 16 ensure businesses in deprived and depressed communities compete for
- 17 and perform contracts to provide services or supplies, or both. The
- 18 director shall strongly encourage firms with which the department
- 19 contracts to subcontract with certified businesses in depressed and
- 20 deprived communities for services, supplies, or both.
- 21 Sec. 223. Funds appropriated in part 1 shall not be used by a
- 22 principal executive department, state agency, or authority to hire
- 23 a person to provide legal services that are the responsibility of
- 24 the attorney general. This prohibition does not apply to legal
- 25 services for bonding activities or for those activities that the
- 26 attorney general authorizes.
- 27 Sec. 224. (1) The department shall collaborate with the state

- 1 board of education, the department of human services, the
- 2 department of community health, and the department of labor and
- 3 economic growth to extend the duration of the Michigan after-school
- 4 partnership and to oversee its efforts to implement the policy
- 5 recommendations and strategic next steps identified in the Michigan
- 6 after-school initiative's report of December 15, 2003.
- 7 (2) From the funds appropriated in part 1, \$25,000.00 may be
- 8 used to support the Michigan after-school partnership. Funds shall
- 9 be used to leverage other private and public funding to engage the

- 19 (4) In addition to the funds appropriated in part 1, there is
- 20 appropriated an amount not to exceed \$750,000.00 for private
- 21 contingency funds. These funds are not available for expenditure
- 22 until they have been transferred to another line item in this act
- 23 under section 393(2) of the management and budget act, 1984 PA 431,
- **24** MCL 18.1393.
- Sec. 227. From the funds appropriated in part 1, the
- 26 department shall implement continuous improvement efficiency
- 27 mechanisms in the programs administered by the department. The

- 1 continuous improvement efficiency mechanisms shall identify changes
- 2 made in programs to increase efficiency and reduce expenditures in
- 3 the programs. On March 31, 2010 and September 30, 2010, the
- 4 department shall submit a report to the state budget director, the
- 5 senate and house appropriation subcommittees, and the senate and
- 6 house fiscal agencies on the progress made toward increased
- 7 efficiencies in department programs. At a minimum, each report
- 8 shall include information on the program review process, the type
- 9 of improvement mechanisms implemented, and actual and projected
- 10 expenditure savings as a result of the increased program
- 11 efficiencies.
- Sec. 228. Within 10 days of the receipt of a grant
- 13 appropriated in the federal, local and private grants line item in
- 14 part 1, the department shall notify the house and senate
- 15 chairpersons of the appropriations subcommittees responsible for
- 16 the department budget, the house and senate fiscal agencies, and
- 17 the state budget director of the receipt of the grant, including
- 18 the funding source, purpose, and amount of the grant.
- 19 Sec. 229. Based on the public testimony provided in hearings
- 20 on the budget for the department, it is the intent of the
- 21 legislature that in any proposed reorganization of the department
- 22 the component programs currently within the library of Michigan
- 23 shall be kept together in a state department and the component
- 24 programs currently within the Michigan historical programs shall be
- 25 kept together in a state department.
- Sec. 230. Not later than September 30, 2010, the department
- 27 shall prepare and transmit a report that provides for estimates of

- 1 the total general fund/general purpose appropriation lapses at the
- 2 close of the fiscal year. This report shall summarize the projected
- 3 year-end general fund/general purpose appropriation lapses by major
- 4 departmental program or program areas. The report shall be
- 5 transmitted to the office of the state budget, the chairpersons of
- 6 the senate and house appropriations committees, and the senate and
- 7 house fiscal agencies.
- 8 Sec. 231. It is the intent of the legislature that the
- 9 reorganization of this department shall not jeopardize any federal
- 10 funding that the Michigan council for arts and cultural affairs,
- 11 the library of Michigan, or the Michigan historical programs may be
- 12 eliqible for.
- Sec. 232. From the funds appropriated in part 1, the
- 14 department shall use an amount not to exceed \$10,000.00 to develop,
- 15 post, and maintain, on a publicly accessible Internet site, all
- 16 expenditures made by the department within a fiscal year. The
- 17 posting shall include the purpose for which each expenditure is
- 18 made. The department is not required to hire additional employees
- in order to comply with this section.
- Sec. 233. On a bimonthly basis, the department shall report on
- 21 the number of FTEs in pay status by civil service classification to
- 22 the senate and house of representatives standing committees on
- 23 appropriations subcommittees on history, arts, and libraries and
- 24 the senate and house fiscal agencies.

25 MICHIGAN COUNCIL FOR ARTS AND CULTURAL AFFAIRS

26 Sec. 401. (1) The MCACA in the department shall administer the

- 1 arts and cultural grants appropriated in part 1.
- 2 (2) The MCACA shall render fair and independent decisions
- 3 concerning arts and cultural grant requests and shall do all of the

- 4 following:
- 5 (a) Use published criteria to evaluate program quality,
- 6 including all of the following:
- 7 (i) The department's intended goals and outcomes for each
- 8 program.
- 9 (ii) The department's quantifiable measures of success in
- 10 meeting the intended goals and outcomes.
- 11 (b) Seek to award grants on an equitable geographic basis to
- 12 the extent possible given the quality of grant applications
- 13 received.
- 14 (c) Give priority to projects that serve multiple counties,
- 15 leverage significant additional public and private investment, or
- 16 demonstrate a significant potential to increase tourism or attract
- 17 or retain businesses or residents.
- 18 (3) No payment shall be made under part 1 except upon
- 19 application submitted in accordance with MCACA published criteria
- 20 and procedures, which shall ensure both of the following:
- 21 (a) Artistic excellence and artistic merit are the criteria by
- 22 which applications will be judged, taking into consideration
- 23 general standards of decency and respect for the diverse beliefs
- 24 and values of the people of this state.
- 25 (b) Criteria clearly indicate that obscenity is without
- 26 artistic merit, is not protected speech, and will not be funded by
- 27 a grant from appropriations under part 1.

- 1 (4) The MCACA shall provide for fair, equitable, and efficient
- 2 distribution of funds granted through the regional regranting
- 3 program. The MCACA shall provide for an annual assessment of grant
- 4 management and distribution of mini-grant awards by designated
- 5 regional regranting agencies and review the methodology employed.
- 6 (5) The MCACA shall continue and expand its efforts to
- 7 encourage and support nonprofit arts and cultural organizations to
- 8 transition from solely volunteer-based organizations to
- 9 professionally directed operations. Criteria for support include
- 10 the requirement of collaboration between these organizations and
- 11 other community organizations.
- 12 (6) The department shall withhold undistributed grant payments
- 13 from a grant recipient who violates the requirements for funding in
- 14 subsection (3) and may disqualify the grant recipient from award of
- 15 future grants for a period of not more than 3 years.
- 16 Sec. 402. The MCACA may award grants to counties, cities,
- 17 villages, townships, community foundations and organizations in the
- 18 following categories:
- 19 (a) Anchor organization program for organizations that serve
- 20 regional and statewide audiences. Anchor organizations shall
- 21 demonstrate a commitment to education, to mentoring smaller
- 22 organizations, and to reaching underserved audiences.
- 23 (b) Arts projects program.
- (c) Arts and learning program.
- 25 (d) Artists in residence for education program.
- (e) Arts organization development program.
- (f) Capital improvement program.

- 1 (g) Local arts agencies services program.
- 2 (h) Regional regranting program.
- 3 (i) Partnership program.
- 4 (j) Rural arts and cultural program.
- 5 (k) Cultural projects program.
- 6 (l) Historical society projects program.
- 7 (m) Discretionary grants program.
- 8 (n) Cultural and ethnic heritage centers and museums.
- 9 Sec. 403. (1) From the state funds appropriated in part 1 for
- 10 arts and cultural grants, no 1 organization may receive more than
- 11 15% of this funding.
- 12 (2) The MCACA shall make every effort to provide total grant
- 13 awards in the anchor organization program at a level not to exceed
- 14 70% of the total amount appropriated for arts and cultural grants.
- 15 (3) As documented in the audit report that is submitted as
- 16 part of the grant application process, the total of all grants
- 17 awarded to any organization receiving grants within the anchor
- 18 organization program may not exceed 15% of their "total
- 19 unrestricted revenues, gains, and other support", as defined by the
- 20 financial accounting standards board in the accounting standards
- 21 for not-for-profit organizations or equivalent accounting standards
- 22 for other types of eligible organizations.
- 23 (4) Before any amount appropriated for arts and cultural
- 24 grants in part 1 may be expended for a grant to an eligible
- 25 recipient, the department shall execute a grant agreement with the
- 26 recipient. The grant agreement shall identify the projects funded,
- 27 specify the category in section 402 under which the grant is

- 1 awarded, and include the prohibitions and sanctions identified in
- 2 section 401(3) and (6).
- 3 Sec. 404. Grant applicants shall meet and adhere to the
- 4 following requirements:
- 5 (a) Each applicant shall pay a nonrefundable application fee
- 6 of \$300.00 or 3% of the desired grant amount, whichever is less.
- 7 Application fees shall be deposited in the history, arts, and
- 8 libraries fund established in section 216. The department may use
- 9 the application fee to offset its direct and indirect costs.
- 10 (b) An applicant for a grant under the anchor organization
- 11 program shall submit with the application the applicant's most
- 12 recent annual audit report which states their "total unrestricted
- 13 revenues, gains, and other support", as defined by the financial
- 14 accounting standards board in the accounting standards for not-for-
- 15 profit organizations or equivalent accounting standards for other
- 16 types of eligible organizations. The audit report shall cover an
- 17 audit period that ends within 18 months of the date of the
- 18 application.
- 19 (c) Each applicant shall identify proposed matching funds from
- 20 local and/or private sources on a minimum of a dollar-for-dollar
- 21 basis. The match may include the reasonable value of services,
- 22 materials, and equipment as allowed under the federal internal
- 23 revenue code for charitable contributions.
- 24 (d) Each applicant for a grant that charges admission to their
- 25 institution may offer a discounted rate for admission to current
- 26 and former United States servicemen and servicewomen, firefighters,
- 27 police officers, and first responders.

1 Sec. 405. Each grant recipient shall provide the MCACA with

- 2 the following:
- 3 (a) Proof of the entire amount of the matching funds,
- 4 services, materials, or equipment by the end of the award period.
- 5 (b) Within 30 days following the end of the grant period, a
- 6 final report that includes the following:
- 7 (i) Project revenues and expenditures, including grant matching
- 8 fund amounts.
- 9 (ii) Number of patrons attracted or benefiting during the grant
- 10 period.
- 11 (iii) A narrative summary of each project and its outcome.
- 12 (c) By April 7 of the grant year, each recipient of a grant
- 13 greater than \$100,000.00 shall submit an interim report that
- 14 includes the items identified in subdivision (b).
- 15 Sec. 406. (1) The department shall make the following reports:
- 16 (a) A report identifying the web site location that contains a
- 17 list of all grant recipients, sorted by county. This report shall
- 18 be provided to each legislator within 1 business day of the
- 19 announcement of annual awards by the MCACA.
- 20 (b) A report to the senate and house of representatives
- 21 appropriations subcommittees, the state budget director, and the
- 22 fiscal agencies, within 30 days after the MCACA announces the
- 23 annual grant awards, that includes all of the following:
- 24 (i) A listing of each applicant.
- 25 (ii) The county of residence or domicile of the applicant.
- 26 (iii) The amount requested.
- 27 (iv) The amount awarded.

- 1 (v) The grant category under which an applicant applied.
- 2 (vi) A summary of projects funded for each recipient.
- 3 (vii) The expected number of patrons for an applicant during
- 4 the grant period.
- 5 (viii) The amount of matching funds proposed by each applicant.
- 6 (ix) A listing containing the applicant, county of residence or
- 7 domicile of the applicant, and amount awarded for any regranted
- 8 funds in the preceding fiscal year.
- 9 (c) An annual report to the appropriations subcommittees, the
- 10 state budget director, and the fiscal agencies is due when
- 11 materials are first distributed by the MCACA seeking grant
- 12 applications for the subsequent fiscal year. The report shall
- 13 contain the following:
- 14 (i) The MCACA guidelines for awarding grants.
- 15 (ii) A summary of any changes in the program guidelines from
- 16 the previous fiscal year.
- 17 (2) The MCACA shall report to the chairpersons of the senate
- 18 and house of representatives appropriations subcommittees on
- 19 history, arts, and libraries by August 1 all unexpended or
- 20 unencumbered discretionary grant funding that is available. The
- 21 council shall not redistribute any unexpended or unencumbered grant
- 22 funds during the fiscal year without a 10-day notice to the
- 23 chairpersons of the senate and house of representatives
- 24 appropriations subcommittees on history, arts, and libraries.

25 MICHIGAN HISTORICAL PROGRAM

Sec. 502. Funds collected by the department under sections 6,

- 1 7, and 7a of 1913 PA 271, MCL 399.6, 399.7, and 399.7a, are
- 2 appropriated to the department for the purposes for which they were
- 3 received, upon receipt.
- 4 Sec. 503. For the purposes of administering the museum store
- 5 as provided in section 7a of 1913 PA 271, MCL 399.7a, the
- 6 department is exempt from section 261 of the management and budget
- 7 act, 1984 PA 431, MCL 18.1261.
- 8 Sec. 505. From the funds appropriated in part 1 for historical
- 9 administration and services, \$18,300.00 shall be allocated to
- 10 support the operations of the Michigan freedom trail commission as
- 11 specified in section 4 of the Michigan freedom trail commission
- 12 act, 1998 PA 409, MCL 399.84. These funds shall be used to
- 13 reimburse commission members, to pay for necessary contractual
- 14 services of the commission, and to hire not more than 1.0 FTE
- 15 position in the department's Michigan historical center to support
- 16 commission operations.
- 17 Sec. 506. Proceeds in excess of costs incurred in the conduct
- 18 of auctions, sales, or transfers of artifacts no longer considered
- 19 suitable for the collections of the state historical museum are
- 20 appropriated to the department and may be expended upon receipt for
- 21 additional material for the collection. The department shall notify
- 22 the chairpersons, vice chairpersons, and minority vice chairpersons
- 23 of the senate and house appropriations subcommittees on history,
- 24 arts, and libraries 1 week prior to any auctions or sales.
- Sec. 507. Unless prohibited by law, the department shall make
- 26 available to the historical society of Michigan the use of the
- 27 Michigan history magazine subscriber list, or a portion of the

- 1 Michigan history magazine subscriber list, at a cost not to exceed
- 2 the actual expense incurred for providing a single mailing.

LIBRARY OF MICHIGAN

- 4 Sec. 601. In order to receive subregional state aid as
- 5 appropriated in part 1 to the library of Michigan, a subregional
- 6 library's fiscal agency shall agree to maintain local funding
- 7 support at the same level in the current fiscal year as in the
- 8 fiscal agency's preceding fiscal year. If a reduction in
- 9 expenditures equally affects all agencies in a local unit of
- 10 government that is the subregional library's fiscal agency, that
- 11 reduction shall not be interpreted as a reduction in local support
- 12 and shall not disqualify a subregional library from receiving state
- 13 aid under part 1. If a reduction in income affects a library
- 14 cooperative or district library that is a subregional library's
- 15 fiscal agency or a reduction in expenditures for the subregional
- 16 library's fiscal agency, a reduction in expenditures for the
- 17 subregional library shall not be interpreted as a reduction in
- 18 local support and shall not disqualify a subregional library from
- 19 receiving state aid under part 1.
- 20 Sec. 602. The funds appropriated in part 1 for a subregional
- 21 library shall not be released until a budget for that subregional
- 22 library has been approved by the department for expenditures for
- 23 library services directly serving the blind and persons with
- 24 disabilities.
- 25 Sec. 603. The funds appropriated in part 1 for book
- 26 distribution centers shall be distributed equally to the public

 ${f 1}$ enrichment foundation and the Michigan friends of education.
