SUBSTITUTE FOR SENATE BILL NO. 325

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 5391.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 539l. (1) A PERSON WHO DOES EITHER OF THE FOLLOWING IS
- 2 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 3 THAN 1 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH:
- 4 (A) INSTALLS OR PLACES A TRACKING DEVICE, OR CAUSES A TRACKING
- 5 DEVICE TO BE INSTALLED OR PLACED, IN OR ON A MOTOR VEHICLE WITHOUT
- 6 THE KNOWLEDGE AND CONSENT OF THE OWNER OF THAT MOTOR VEHICLE OR, IF
- 7 THE MOTOR VEHICLE IS LEASED, THE LESSEE OF THAT MOTOR VEHICLE.
- 8 (B) TRACKS THE LOCATION OF A MOTOR VEHICLE WITH A TRACKING
- 9 DEVICE WITHOUT THE KNOWLEDGE AND CONSENT OF EITHER THE OWNER OR THE
- 10 AUTHORIZED OPERATOR OF THAT MOTOR VEHICLE OR, IF THE MOTOR VEHICLE

- 1 IS LEASED, EITHER THE LESSEE OR THE AUTHORIZED OPERATOR OF THAT
- 2 MOTOR VEHICLE.
- 3 (2) SUBSECTION (1) DOES NOT APPLY TO ANY OF THE FOLLOWING:
- 4 (A) THE USE OF ANY DEVICE THAT PROVIDES VEHICLE TRACKING ONLY
- 5 FOR PURPOSES OF PROVIDING MECHANICAL, OPERATIONAL, DIRECTIONAL,
- 6 NAVIGATION, WEATHER, OR TRAFFIC INFORMATION TO THE OPERATOR OF THE
- 7 VEHICLE.
- 8 (B) THE USE OF ANY DEVICE FOR PROVIDING EMERGENCY ASSISTANCE
- 9 TO THE OPERATOR OR PASSENGERS OF THE VEHICLE UNDER THE TERMS AND
- 10 CONDITIONS OF A SUBSCRIPTION SERVICE, INCLUDING ANY TRIAL PERIOD OF
- 11 THAT SUBSCRIPTION SERVICE.
- 12 (C) THE USE OF ANY DEVICE ONLY FOR PROVIDING MISSING VEHICLE
- 13 ASSISTANCE FOR THE BENEFIT OF THE OWNER OF THE VEHICLE.
- 14 (D) THE USE OF ANY DEVICE ONLY TO PROVIDE DIAGNOSTIC SERVICES
- 15 REGARDING THE MECHANICAL OPERATION OF A VEHICLE UNDER THE TERMS AND
- 16 CONDITIONS OF A SUBSCRIPTION SERVICE, INCLUDING ANY TRIAL PERIOD OF
- 17 THE SUBSCRIPTION SERVICE.
- 18 (E) THE USE OF ANY DEVICE OR SERVICE THAT PROVIDES THE
- 19 OCCUPANTS OF THE VEHICLE WITH CLEAR NOTICE THAT THE VEHICLE MAY BE
- 20 TRACKED.
- 21 (F) A POLICE OFFICER WHILE PERFORMING HIS OR HER DUTIES AS A
- 22 POLICE OFFICER.
- 23 (G) A PERSON LICENSED UNDER THE PROFESSIONAL INVESTIGATOR
- 24 LICENSURE ACT, 1965 PA 285, MCL 338.821 TO 338.851, OR AN EMPLOYEE
- 25 OF A PERSON LICENSED UNDER THAT ACT, WHILE PERFORMING HIS OR HER
- 26 DUTIES AS A PROFESSIONAL INVESTIGATOR OR EMPLOYEE OF A PROFESSIONAL
- 27 INVESTIGATOR. THIS EXEMPTION DOES NOT APPLY IF THE PROFESSIONAL

- INVESTIGATOR OR EMPLOYEE IS WORKING ON BEHALF OF A PERSON WHO IS 1
- THE SUBJECT OF AN ORDER ISSUED BY A COURT FOR THE PROTECTION OF 2
- 3 ANOTHER PERSON, THE PROFESSIONAL INVESTIGATOR OR EMPLOYEE KNOWS OF
- THE EXISTENCE OF THE ORDER OR FAILS TO USE DUE DILIGENCE IN 4
- 5 DETERMINING WHETHER THE ORDER EXISTS, AND THE SERVICES OF THE
- 6 PROFESSIONAL INVESTIGATOR OR EMPLOYEE ARE TO PROVIDE INFORMATION TO
- THE PERSON WHO IS THE SUBJECT OF THE ORDER ABOUT THE LOCATION OF 7
- ANY OTHER PERSON NAMED IN THE ORDER. 8
- 9 (H) A PERSON LAWFULLY PERFORMING HIS OR HER DUTIES AS A BAIL
- 10 AGENT AS AUTHORIZED UNDER SECTION 167B OR AS AN EMPLOYEE OR
- 11 CONTRACTOR OF THAT BAIL AGENT.
- 12 (3) AS USED IN THIS SECTION:
- (A) "MOTOR VEHICLE" MEANS THAT TERM AS DEFINED IN SECTION 412. 13
- (B) "TRACKING DEVICE" MEANS ANY ELECTRONIC DEVICE THAT IS 14
- 15 DESIGNED OR INTENDED TO BE USED TO TRACK THE LOCATION OF A MOTOR
- VEHICLE ON A STREET OR HIGHWAY OF THIS STATE REGARDLESS OF WHETHER 16
- 17 THAT INFORMATION IS RECORDED.
