- 8 CLASSIFICATION.
- 9 (C) A LISTING OF STATE CONTRACTS THAT INCLUDES, BUT IS NOT
- 10 LIMITED TO, ALL OF THE FOLLOWING:

- 1 (i) THE FUNDING STATE AGENCY.
- 2 (ii) VENDOR NAME.
- 3 (iii) CATEGORY CODE.
- 4 (iv) CONTRACT AMOUNT.
- 5 (v) CONTRACT DESCRIPTION.
- 6 (vi) A HYPERLINK TO THE CONTRACT.
- 7 (D) THE EXECUTIVE BUDGET.
- 8 (E) THE COMPREHENSIVE ANNUAL FINANCIAL REPORT, THE
- 9 CONSTITUTIONAL REVENUE LIMIT REPORT, THE CONSTITUTIONAL LOCAL

- 10 SPENDING REQUIREMENTS REPORT, ANNUAL WORK PROJECTS REPORTS,

- 13 (G) JOB SPECIFICATIONS AND WAGE RATES.
- 14 (2) BEGINNING OCTOBER 1, 2011, THE WEBSITE DEVELOPED AND
- 15 OPERATED UNDER SUBSECTION (1) SHALL ALSO INCLUDE A LISTING OF
- 16 FISCAL YEAR-TO-DATE PAYMENTS DISPLAYABLE BY VENDOR THAT INCLUDES,
- 17 BUT IS NOT LIMITED TO, ALL OF THE FOLLOWING:
- 18 (A) THE FUNDING STATE AGENCY.
- 19 (B) VENDOR NAME.
- 20 (C) PAYMENT DATE.
- 21 (D) PAYMENT AMOUNT.
- 22 (E) PAYMENT DESCRIPTION.
- 23 (3) WHEN THE DEPARTMENT REPLACES THE STATE'S CENTRALIZED
- 24 ACCOUNTING SYSTEM (MICHIGAN ADMINISTRATIVE INFORMATION NETWORK),
- 25 THE DEPARTMENT SHALL DEVELOP AND OPERATE A REPLACEMENT SEARCHABLE
- 26 WEBSITE ACCESSIBLE BY THE PUBLIC AT NO COST THAT, IN ADDITION TO
- 27 THE CONTENT SPECIFIED IN SUBSECTIONS (1) AND (2), INCLUDES THE

- 1 FOLLOWING INFORMATION REGARDING THE EXPENDITURE OF STATE FUNDS:
- 2 (A) NAME AND PRINCIPAL LOCATION OF THE ENTITY RECEIVING THE
- 3 FUNDS.
- 4 (B) AMOUNT OF STATE FUNDS.
- 5 (C) TYPE OF TRANSACTION.
- 6 (D) FUNDING STATE AGENCY.
- 7 (E) BUDGET SOURCE OF THE FUNDS.
- 8 (F) A DESCRIPTION OF THE PURPOSE OF THE FUNDING ACTION OR
- 9 EXPENDITURE.
- 10 (4) THIS SECTION DOES NOT REQUIRE DISCLOSURE OF INFORMATION
- 11 THAT IS CONSIDERED CONFIDENTIAL UNDER STATE OR FEDERAL LAW.
- 12 (5) AS USED IN THIS SECTION:
- 13 (A) "EXPENDITURE OF STATE FUNDS" MEANS THE EXPENDITURE OF ALL
- 14 APPROPRIATED OR NONAPPROPRIATED FUNDS BY A STATE AGENCY THAT
- 15 INCLUDES, BUT IS NOT LIMITED TO, ALL OF THE FOLLOWING:
- 16 (i) STATE PURCHASES.
- 17 (ii) CONTRACTS AND SUBCONTRACTS.
- 18 (iii) GRANTS.
- 19 (B) "SEARCHABLE WEBSITE" MEANS A WEBSITE THAT ALLOWS THE
- 20 PUBLIC TO SEARCH AND REVIEW THE INFORMATION SPECIFIED IN THIS
- 21 SECTION.
