A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 811k (MCL 257.811k), as amended by 2006 PA 298.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 811k. (1) The Michigan lighthouse preservation grant fund
- 2 is created as a separate fund in the department of treasury. The
- 3 fund shall be expended only as provided in this section. The state
- 4 treasurer may receive money or other assets from any source for
- 5 deposit into the fund. The state treasurer shall direct the
- 6 investment of the fund. The state treasurer shall credit to the
- fund interest and earnings from fund investments. The state
- 8 treasurer shall annually present to the department of history,

- 1 arts, and libraries STATE an accounting of the amount of money in
- 2 the fund. Money in the fund at the close of the fiscal year shall
- 3 remain in the fund and shall not lapse to the general fund.
- 4 (2) The department of history, arts, and libraries STATE shall
- 5 administer the Michigan lighthouse preservation fund and may expend
- 6 money from that fund through discretionary historical grants to
- 7 preserve Michigan lighthouses. The department of history, arts, and
- 8 libraries STATE shall use not more than 10% of the funds for costs
- 9 that occur from fund administration and grant project coordination.
- 10 (3) The department of history, arts, and libraries STATE may
- 11 award grants under subsection (2) for the preparation of plans and
- 12 specifications for restoration and stabilization and for
- 13 stabilization, rehabilitation, or other preservation work on a

- 2 shall be transferred under section 811h by the secretary of state
- 3 to the state treasurer, who shall credit the donation money to the

- 6 Enacting section 1. This amendatory act does not take effect
- 7 unless Senate Bill No. 503
