## **SENATE BILL No. 675**

June 25, 2009, Introduced by Senators BARCIA, CROPSEY and PAPPAGEORGE and referred to the Committee on Economic Development and Regulatory Reform.

A bill to amend 1955 PA 233, entitled

"An act to provide for the incorporation of certain municipal authorities to acquire, own, extend, improve, and operate sewage disposal systems, water supply systems, and solid waste management systems; to prescribe the rights, powers, and duties thereof; to authorize contracts between such authorities and public corporations; to provide for the issuance of bonds to acquire, construct, extend, or improve the systems; and to prescribe penalties and provide remedies,"

by amending section 1 (MCL 124.281), as amended by 1981 PA 154.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. As used in this act:

- (A) "AUTHORITY", UNLESS THE CONTEXT CLEARLY IMPLIES A
  DIFFERENT MEANING, MEANS AN AUTHORITY INCORPORATED UNDER SECTION 2.
- (B) "CONSTITUENT MUNICIPALITY" OR "CONSTITUENT MUNICIPALITIES"
- INCLUDES ALL OF THE MUNICIPALITIES THAT SIGNED OR BECAME

- 1 SIGNATORIES OF ARTICLES OF INCORPORATION OF ANY AUTHORITY
- 2 INCORPORATED UNDER THIS ACT. HOWEVER, IF AN AUTHORITY IS
- 3 INCORPORATED BY 2 OR MORE COUNTIES, EACH MUNICIPALITY WITHIN THE

- 12 (D) "MUNICIPALITY" MEANS A COUNTY, TOWNSHIP, CITY, OR VILLAGE.
- 13 (E) (a) "Sewage disposal system" / includes all interceptor
- 14 sewers, storm sewers, sanitary sewers, combined sanitary and storm
- 15 sewers, sewage treatment plants, and all other plants, works,
- 16 instrumentalities, and properties used or useful in connection with
- 17 the collection, treatment, or disposal of sewage or industrial
- 18 wastes.
- 19 (b) "Water supply system," includes all plants, works,
- 20 instrumentalities, and properties used or useful in connection with
- 21 obtaining a water supply, the treatment of water, or the
- 22 distribution of water.
- **(F)** (c) "Solid waste management system" includes all plants,
- 24 works, instrumentalities, and properties used or useful in
- 25 connection with the collection, transportation, processing, or
- 26 disposal of discarded or waste materials of any sort, including
- 27 access roads and facilities for resource recovery. —Solid waste

- 1 management system "-does not include the storage or disposal of
- 2 toxic materials.
- 3 (d) "Municipality," includes each county, township, city, or
- 4 village.
- 5 (e) "Constituent municipality" or "constituent municipalities"
- 6 includes all of the municipalities which signed or became
- 7 signatories of articles of incorporation of any authority
- 8 incorporated under this act, except if the authority is
- 9 incorporated by 2 or more counties, in which event each
- 10 municipality within the respective territorial limits of the
- 11 counties as are either original incorporators or subsequently
- 12 become a constituent part of the authorities under section 6, shall
- 13 be considered to be a constituent municipality for the purposes of
- 14 this act.
- 15 (G) "WATER SUPPLY SYSTEM" INCLUDES ALL PLANTS, WORKS,
- 16 INSTRUMENTALITIES, AND PROPERTIES USED OR USEFUL IN CONNECTION WITH
- 17 OBTAINING A WATER SUPPLY, THE TREATMENT OF WATER, OR THE
- 18 DISTRIBUTION OF WATER.
