SUBSTITUTE FOR

SENATE BILL NO. 682

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 811e (MCL 257.811e), as amended by 2009 PA 99, and by adding section 811r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 811e. (1) Beginning January 1, 2007, the THE secretary of
- 2 state may develop a fund-raising plate as provided in this section.
- 3 (2) A start-up fee of \$15,000.00 shall be paid for any new
- 4 fund-raising plate authorized under this section. The fee shall be
- 5 deposited in the transportation administration collection fund
- 6 through October 1, 2011 to be used for the cost of creating,
- 7 producing, and issuing fund-raising plates. If the fee described in
- 8 this subsection is not paid within 18 months of AFTER the effective
- 9 date of the public act that authorizes the development and issuance

- 1 of a fund-raising plate, then the related fund-raising plate shall
- 2 not be created, produced, or issued. A start-up fee paid under this
- 3 subsection is nonrefundable.
- 4 (3) Not less than 3 years after the secretary of state first
- 5 issues 1 of the fund-raising plates as described in subsection (1)
- 6 and upon payment of \$2,000.00, the Michigan university or other
- 7 person sponsoring that fund-raising plate may redesign it as
- 8 approved by the secretary of state. The payment required under this
- 9 subsection shall be deposited in the transportation administration
- 10 collection fund through October 1, 2011 to be used for the cost of
- 11 creating, producing, and issuing fund-raising plates. A payment
- 12 under this subsection is nonrefundable.
- 13 (4) The secretary of state may develop 1 or more limited term
- 14 registration plates to recognize a Michigan university or an
- 15 accomplishment or occasion of a Michigan university.
- 16 (5) The secretary of state may , at any 1 time, develop not
- 17 more than 8 different state sponsored fund-raising registration
- 18 plates as described in this section, and matching state-sponsored
- 19 collector plates as described in section 811g.
- 20 (6) The secretary of state shall not develop or issue a fund-
- 21 raising plate unless a public act authorizing the fund-raising
- 22 plate, at a minimum, does all of the following:
- 23 (a) Identifies the purpose of the fund-raising plate.
- 24 (b) Creates a nonprofit fund or designates an existing
- 25 nonprofit fund to receive the money raised through the sale of
- 26 fund-raising plates and matching collector plates.
- (c) If a fund is created, names the person or entity

- 1 responsible for administering the fund.
- 2 SEC. 811R. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE 3
- 4 RECOGNIZING THE BICENTENNIAL OF THE WAR OF 1812. THE SECRETARY OF
- 5 STATE SHALL DESIGN THE FUND-RAISING PLATES AUTHORIZED IN THIS
- 6 SECTION.
- 7 (2) THE MACKINAC ISLAND STATE PARK COMMISSION FUND IS CREATED
- WITHIN THE STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR 8
- OTHER ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE 9
- TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE 10
- 11 TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
- 12 INVESTMENTS. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR
- SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND. 13
- (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY 14
- FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE BICENTENNIAL 15
- OF THE WAR OF 1812 TO THE STATE TREASURER, WHO SHALL CREDIT THE 16
- DONATION MONEY TO THE MACKINAC ISLAND STATE PARK COMMISSION FUND 17
- ESTABLISHED UNDER SUBSECTION (2). 18
- 19 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 20 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE
- 21 MACKINAC ISLAND STATE PARK COMMISSION. BEGINNING NOT LATER THAN
- 22 FEBRUARY 1, 2011, THE MACKINAC ISLAND STATE PARK COMMISSION SHALL
- SUBMIT TO THE STATE TREASURER A SUMMARY OF THE EXPENDITURES DURING 23
- THE PRECEDING YEAR OF THE MONEY RECEIVED UNDER THIS SECTION. 24
- (5) THE SECRETARY OF STATE SHALL BE THE ADMINISTRATOR OF THE 25
- 26 FUND FOR AUDITING PURPOSES.
