## SUBSTITUTE FOR

## SENATE BILL NO. 751

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 642c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 642C. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (3),
- 2 (4), OR (5), BEGINNING MARCH 31, 2011, A SCHOOL DISTRICT THAT IS
- 3 NOT LOCATED WHOLLY OR PARTLY IN A COUNTY WITH A POPULATION OF
- 4 750,000 OR MORE SHALL HOLD ITS REGULAR ELECTION FOR THE OFFICE OF
- 5 SCHOOL BOARD MEMBER ON 1 OF THE FOLLOWING:
- 6 (A) THE GENERAL NOVEMBER ELECTION.
- 7 (B) THE EVEN YEAR AUGUST ELECTION.
- 8 (C) THE ODD YEAR GENERAL ELECTION, BUT ONLY IF ALL OF THE
- 9 FOLLOWING CONDITIONS ARE MET:
- 10 (i) AT LEAST 1 CITY OR COMMUNITY COLLEGE THAT IS LOCATED EITHER

- 1 WHOLLY OR PARTLY IN THE SCHOOL DISTRICT CONDUCTS AN ODD YEAR
- 2 GENERAL ELECTION.
- 3 (ii) THE CITY, CITIES, OR COMMUNITY COLLEGE DISTRICT DESCRIBED
- 4 IN SUBPARAGRAPH (i) CONTAIN MORE THAN 50% OF THE REGISTERED ELECTORS
- 5 WHO ARE ELIGIBLE TO VOTE IN THE SCHOOL DISTRICT ELECTION.
- 6 (2) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4) OR (5),
- 7 BEGINNING MARCH 31, 2011, A SCHOOL DISTRICT THAT IS LOCATED WHOLLY
- 8 OR PARTLY IN A COUNTY WITH A POPULATION OF 750,000 OR MORE SHALL
- 9 HOLD ITS REGULAR ELECTION FOR THE OFFICE OF SCHOOL BOARD MEMBER ON
- 10 1 OF THE FOLLOWING:
- 11 (A) THE GENERAL NOVEMBER ELECTION.
- 12 (B) THE ODD YEAR GENERAL ELECTION, BUT ONLY IF ALL OF THE
- 13 FOLLOWING CONDITIONS ARE MET:
- 14 (i) AT LEAST 1 CITY OR COMMUNITY COLLEGE THAT IS LOCATED EITHER
- 15 WHOLLY OR PARTLY IN THE SCHOOL DISTRICT CONDUCTS AN ODD YEAR
- 16 GENERAL ELECTION.
- 17 (ii) THE CITY, CITIES, OR COMMUNITY COLLEGE DISTRICT DESCRIBED
- 18 IN SUBPARAGRAPH (i) CONTAIN MORE THAN 50% OF THE REGISTERED ELECTORS
- 19 WHO ARE ELIGIBLE TO VOTE IN THE SCHOOL DISTRICT ELECTION.
- 20 (3) IF BEFORE THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 21 ADDED THIS SECTION A SCHOOL DISTRICT THAT IS NOT LOCATED WHOLLY OR
- 22 PARTLY IN A COUNTY WITH A POPULATION OF 750,000 OR MORE HOLDS IT
- 23 REGULAR ELECTION ON THE NOVEMBER REGULAR ELECTION DATE IN BOTH EVEN
- 24 AND ODD YEARS, THE SCHOOL DISTRICT SHALL HOLD ITS REGULAR ELECTION
- 25 FOR THE OFFICE OF SCHOOL BOARD MEMBER ON 1 OF THE FOLLOWING:
- 26 (A) THE GENERAL NOVEMBER ELECTION.
- 27 (B) THE ODD YEAR GENERAL ELECTION, BUT ONLY IF ALL OF THE

- 1 FOLLOWING CONDITIONS ARE MET:
- 2 (i) AT LEAST 1 CITY OR COMMUNITY COLLEGE THAT IS LOCATED WHOLLY
- 3 OR PARTLY IN THE SCHOOL DISTRICT CONDUCTS AN ODD YEAR GENERAL
- 4 ELECTION.
- 5 (ii) THE CITY, CITIES, OR COMMUNITY COLLEGE DISTRICT DESCRIBED
- 6 IN SUBPARAGRAPH (i) CONTAIN MORE THAN 50% OF THE REGISTERED ELECTORS
- 7 WHO ARE ELIGIBLE TO VOTE IN THE SCHOOL DISTRICT ELECTION.
- 8 (4) IF BEFORE THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 9 ADDED THIS SECTION A SCHOOL DISTRICT HOLDS ITS REGULAR ELECTION AT
- 10 THE GENERAL NOVEMBER ELECTION, THAT SCHOOL DISTRICT SHALL CONTINUE
- 11 TO HOLD ITS REGULAR ELECTION AT THE GENERAL NOVEMBER ELECTION. A
- 12 SCHOOL DISTRICT THAT IS SUBJECT TO THIS SUBSECTION DOES NOT NEED TO
- 13 ADOPT A RESOLUTION AS PROVIDED IN SUBSECTION (6).
- 14 (5) IF BEFORE THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 15 ADDED THIS SECTION A SCHOOL DISTRICT HOLDS ITS REGULAR ELECTION AT
- 16 THE ODD YEAR GENERAL ELECTION, THE SCHOOL DISTRICT'S SCHOOL BOARD
- 17 MAY CHOOSE TO CONTINUE HOLDING ITS REGULAR ELECTION AT THE ODD YEAR
- 18 GENERAL ELECTION BY ADOPTING A RESOLUTION IN COMPLIANCE WITH THIS
- 19 SECTION. IF A SCHOOL DISTRICT'S SCHOOL BOARD ADOPTS A RESOLUTION IN
- 20 COMPLIANCE WITH THIS SECTION TO HOLD ITS REGULAR ELECTION AT THE
- 21 ODD YEAR GENERAL ELECTION, AFTER MARCH 31, 2011, THE SCHOOL
- 22 DISTRICT'S REGULAR ELECTION IS AT THE ODD YEAR GENERAL ELECTION.
- 23 (6) BEFORE FEBRUARY 28, 2011, A SCHOOL DISTRICT'S SCHOOL BOARD
- 24 THAT IS THE BOARD OF TRUSTEES OF A COMMUNITY COLLEGE SHALL ADOPT A
- 25 RESOLUTION AT A PUBLIC HEARING TO HOLD ITS REGULAR ELECTION ON A
- 26 DATE IN COMPLIANCE WITH THIS SECTION. BEFORE MARCH 31, 2011, A
- 27 SCHOOL DISTRICT'S SCHOOL BOARD THAT IS NOT THE BOARD OF TRUSTEES OF

- 1 A COMMUNITY COLLEGE SHALL ADOPT A RESOLUTION AT A PUBLIC HEARING TO
- 2 HOLD ITS REGULAR ELECTION ON A DATE IN COMPLIANCE WITH THIS
- 3 SECTION. WITHIN 30 DAYS AFTER ADOPTING THE RESOLUTION, THE SCHOOL
- 4 BOARD SHALL FILE THE RESOLUTION WITH THE SECRETARY OF STATE AND A
- 5 COPY OF THE RESOLUTION WITH THE COUNTY CLERK OF THE COUNTY IN WHICH
- 6 THE SCHOOL DISTRICT OR A MAJORITY OF THE SCHOOL DISTRICT IS
- 7 LOCATED.
- 8 (7) IF A SCHOOL DISTRICT'S SCHOOL BOARD FAILS TO ADOPT A
- 9 RESOLUTION AS PROVIDED IN SUBSECTION (6) TO HOLD ITS REGULAR
- 10 ELECTION ON A DATE IN COMPLIANCE WITH THIS SECTION, BEGINNING MARCH
- 11 31, 2011, THAT SCHOOL DISTRICT SHALL HOLD ITS REGULAR ELECTION AT
- 12 THE GENERAL NOVEMBER ELECTION.
- 13 (8) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (9), AFTER
- 14 MARCH 30, 2011, A SCHOOL DISTRICT IS NOT PERMITTED TO CHANGE THE
- 15 DATE OF ITS REGULAR ELECTION.
- 16 (9) AFTER MARCH 30, 2011, A SCHOOL DISTRICT THAT HOLDS ITS
- 17 REGULAR ELECTION AT A TIME OTHER THAN AT THE GENERAL NOVEMBER
- 18 ELECTION MAY CHANGE ITS REGULAR ELECTION TO THE GENERAL NOVEMBER
- 19 ELECTION BY ADOPTING A RESOLUTION AT A PUBLIC HEARING TO HOLD ITS
- 20 REGULAR ELECTION AT THE GENERAL NOVEMBER ELECTION. WITHIN 30 DAYS
- 21 AFTER ADOPTING THE RESOLUTION, THE SCHOOL BOARD SHALL FILE THE
- 22 RESOLUTION WITH THE SECRETARY OF STATE AND A COPY OF THE RESOLUTION
- 23 WITH THE COUNTY CLERK OF THE COUNTY IN WHICH THE SCHOOL DISTRICT OR
- 24 A MAJORITY OF THE SCHOOL DISTRICT IS LOCATED. IF A SCHOOL DISTRICT
- 25 ADOPTS A RESOLUTION IN COMPLIANCE WITH THIS SUBSECTION TO HOLD ITS
- 26 REGULAR ELECTION AT THE GENERAL NOVEMBER ELECTION, AFTER DECEMBER
- 27 31 OF THE YEAR IN WHICH THE RESOLUTION IS ADOPTED, THE SCHOOL

- 1 DISTRICT SHALL HOLD ITS REGULAR ELECTION AT THE GENERAL NOVEMBER
- 2 ELECTION.
- (10) IF A SCHOOL DISTRICT ADOPTS A RESOLUTION TO HOLD ITS 3
- REGULAR ELECTION AT THE ODD YEAR GENERAL ELECTION BECAUSE IT MEETS
- THE CONDITIONS OF SUBSECTION (1) (C) (i) AND (ii), (2) (B) (i) AND (ii), OR 5
- (3) (B) (i) AND (ii) AND THE COMMUNITY COLLEGE DISTRICT THAT IS LOCATED
- EITHER WHOLLY OR PARTLY IN THAT SCHOOL DISTRICT CHANGES ITS REGULAR 7
- ELECTION UNDER SUBSECTION (9) TO THE GENERAL NOVEMBER ELECTION, THE 8
- SCHOOL DISTRICT IS NOT REQUIRED TO CHANGE ITS REGULAR ELECTION EVEN 9
- THOUGH IT NO LONGER MEETS THE CONDITIONS OF SUBSECTION (1)(C)(i) AND 10
- 11 (ii) , (2) (B) (i) AND (ii) , OR (3) (B) (i) AND (ii) TO HOLD ITS REGULAR
- 12 ELECTION AT THE ODD YEAR GENERAL ELECTION.
- 13 Enacting section 1. This amendatory act does not take effect
