A bill to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 2011; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, employees, and officers.

- 11 Sec. 201. Pursuant to section 30 of article IX of the state
- 12 constitution of 1963, total state spending from state resources
- 13 under this act for fiscal year 2010-2011 is \$1,621,134,800.00 and
- 14 state spending from state resources to be paid to local units of
- 15 government for fiscal year 2010-2011 is \$0.
- 16 Sec. 202. The appropriations authorized under this act are
- 17 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- **18** to 18.1594.
- 19 Sec. 203. As used in this act, "research university" means a
- 20 public university classified as a "research university (very high
- 21 research activity) " under the 2005 classification of institutions
- 22 of higher education conducted by the Carnegie foundation for the
- 23 advancement of teaching.
- 24 Sec. 208. Unless otherwise specified, public universities
- 25 receiving appropriations in part 1 shall use the Internet to

- 1 fulfill the reporting requirements of this act. This requirement
- 2 may include transmission of reports via electronic mail to the
- 3 recipients identified for each reporting requirement, or it may
- 4 include placement of reports on an Internet or Intranet site.
- 5 Sec. 209. Funds appropriated in part 1 shall not be used for
- 6 the purchase of foreign goods or services, or both, if
- 7 competitively priced and of comparable quality American goods and
- 8 services, or both, are available. Preference shall be given to
- 9 goods or services, or both, manufactured or provided by Michigan
- 10 businesses if they are competitively priced and of comparable
- 11 value. In addition, preference shall be given to goods or services,
- 12 or both, that are manufactured or provided by Michigan businesses
- 13 owned and operated by veterans if they are competitively priced and
- 14 of comparable quality.
- Sec. 210. It is the intent of the legislature that the funds

- 21 Sec. 211. The principal executive officer of each public
- 22 university receiving appropriations in part 1 shall take all
- 23 reasonable steps to ensure that businesses in deprived and
- 24 depressed communities compete for and perform contracts to provide
- 25 services, supplies, or both. Each principal executive officer shall
- 26 strongly encourage firms with which the university contracts to
- 27 subcontract with businesses in depressed and deprived communities

- 1 for services, supplies, or both.
- 2 Sec. 212. (1) The funds appropriated in part 1 to public
- 3 universities shall be paid out of the state treasury and
- 4 distributed by the state treasurer to the respective institutions
- 5 in 11 equal monthly installments on the sixteenth of each month, or
- 6 the next succeeding business day, beginning with October 16, 2010.
- 7 Except for Wayne State University, each institution shall accrue
- 8 its July and August 2011 payments to its institutional fiscal year
- 9 ending June 30, 2011.
- 10 (2) All public universities shall submit higher education
- 11 institutional data inventory (HEIDI) data and associated financial

- 7 that receives funds under this act notifies the department of

- 9 an eligible institution for the Michigan tuition tax credit under

[Sec. 218. In an effort to better improve transparency and to further identify effective educational practices, it is the intent of the legislature that a public university receiving an appropriation in part 1 shall develop, post, and maintain a user-friendly and publicly accessible Internet site, with all expenditures made by the college within a fiscal year. The posting must include the purpose for which the expenditure is made. A public university shall not provide financial information on its website under this section if doing so would violate a federal or state law, rule, regulation, or guideline that establishes privacy or security standards applicable to that section. A public university shall not expend more than \$100.00 from the appropriations in part 1 to implement the requirements of this section.]

Sec. 301. (1) Payments of the amounts included in part 1 for the state competitive scholarship program shall be distributed pursuant to 1964 PA 208, MCL 390.971 to 390.981.

- 1 (2) Pursuant to section 6 of 1964 PA 208, MCL 390.976, the
- 2 department of treasury shall determine an actual maximum state
- 3 competitive scholarship award per student that ensures that the
- 4 aggregate payments for the state competitive scholarship program do
- 5 not exceed the appropriation contained in part 1 for the state
- 6 competitive scholarship program. If the department determines that
- 7 insufficient funds are available to establish a maximum award
- 8 amount equal to at least \$800.00, the department shall immediately

- 20 funds awarded under this section may be used for educational
- 21 expenses other than tuition and fees.
- 22 (5) If the department of treasury increases the maximum award
- 23 per eligible student from that provided in the previous fiscal
- 24 year, it shall not have the effect of reducing the number of
- 25 eligible students receiving awards in relation to the total number
- 26 of eligible applicants. Any increase in the maximum grant shall be
- 27 proportional for all eligible students receiving awards.

- 1 (6) Veterans administration benefits shall not be considered
- 2 in determining eligibility for the award of scholarships under 1964
- 3 PA 208, MCL 390.971 to 390.981.
- 4 Sec. 302. (1) The amounts appropriated in part 1 for the state
- 5 tuition grant program shall be distributed pursuant to 1966 PA 313,
- 6 MCL 390.991 to 390.997a.
- 7 (2) Tuition grant awards shall be made to all eligible
- 8 Michigan residents enrolled in undergraduate degree programs who
- 9 apply before July 1, 2010 and who are qualified.
- 10 (3) Pursuant to section 5 of 1966 PA 313, MCL 390.995, and
- 11 subject to subsection (7), the department of treasury shall
- 12 determine an actual maximum tuition grant award per student that
- 13 ensures that the aggregate payments for the tuition grant program
- 14 do not exceed the appropriation contained in part 1 for the state
- 15 tuition grant program. If the department determines that
- 16 insufficient funds are available to establish a maximum award
- amount equal to at least \$1,610.00, the department shall

- 27 The determination and actions shall be reported to the state budget

- 1 director and the house and senate fiscal agencies no later than
- 2 February 15, 2011. If award adjustments are necessary, the students
- 3 shall be notified of the adjustment by the third Monday in
- 4 February.
- 5 (4) Any unexpended and unencumbered funds remaining on
- 6 September 30, 2011 from the amounts appropriated in part 1 for the
- 7 tuition grant program shall not lapse on September 30, 2011, but
- 8 shall continue to be available for expenditure for tuition grants
- 9 provided in the 2011-2012 fiscal year under a work project account.
- 10 The use of these unexpended fiscal year 2010-2011 funds shall
- 11 terminate at the end of the 2011-2012 fiscal year.
- 12 (5) The department of treasury shall continue a proportional
- 13 tuition grant maximum award level for recipients enrolled less than
- 14 full-time in a given semester or term.
- 15 (6) If the department of treasury increases the maximum award
- 16 per eligible student from that provided in the previous fiscal

- 1 Sec. 307. The auditor general may audit selected enrollments,
- 2 degrees, and awards at selected independent colleges and
- 3 universities receiving awards administered by the department of
- 4 treasury. The audits shall be based upon definitions and
- 5 requirements established by the department of treasury, the state
- 6 budget director, and the senate and house fiscal agencies. The
- 7 auditor general shall accept the Free Application for Federal

- 17 financial thresholds to be eligible for tuition incentive benefits:
- 18 (a) To be eligible for phase I, a person shall meet all of the
- 19 following criteria:
- 20 (i) Apply for certification to the department before graduating
- 21 from high school or completing the general education development
- 22 (GED) certificate.
- 23 (ii) Be less than 20 years of age at the time of high school
- 24 graduation or GED completion.
- 25 (iii) Be a United States citizen and a resident of Michigan
- 26 according to institutional criteria.
- 27 (iv) Be at least a half-time student, earning less than 80

- 1 semester or 120 term credits at a participating educational
- 2 institution within 4 years of high school graduation or GED
- 3 certificate completion.
- 4 (v) Request information on filing a FAFSA.
- 5 (b) To be eligible for phase II, a person shall meet either of
- 6 the following criteria in addition to the criteria in subdivision
- **7** (a):
- 8 (i) Complete at least 56 transferable semester or 84
- 9 transferable term credits.
- 10 (ii) Obtain an associate degree or certificate at a
- 11 participating institution.
- 12 (c) To be eligible for phase I or phase II, a person must not
- 13 be incarcerated and must be financially eligible as determined by
- 14 the department. A person is financially eligible for the tuition
- 15 incentive program if that person was Medicaid eligible for 24
- 16 months within the 36 months before application. Certification of
- 17 eligibility may begin in the sixth grade.
- 18 (4) For phase I, the department shall provide payment on
- 19 behalf of a person eligible under subsection (3). The department
- 20 shall reject billings that are excessive or outside the guidelines
- 21 for the type of educational institution.
- 22 (5) For phase I, all of the following apply:
- 23 (a) Payments for associate degree or certificate programs
- 24 shall not be made for more than 80 semester or 120 term credits for
- 25 any individual student at any participating institution.
- 26 (b) For persons enrolled at a Michigan community college, the
- 27 department shall pay the current in-district tuition and mandatory

- 1 fees. For persons residing in an area that is not included in any
- 2 community college district, the out-of-district tuition rate may be
- 3 authorized.
- 4 (c) For persons enrolled at a Michigan public university, the
- 5 department shall pay lower division resident tuition and mandatory
- 6 fees for the current year.
- 7 (d) For persons enrolled at a Michigan independent, nonprofit
- 8 degree-granting college or university, or a Michigan federal
- 9 tribally controlled community college, or Focus: HOPE, the
- 10 department shall pay mandatory fees for the current year and a per-
- 11 credit payment that does not exceed the average community college
- 12 in-district per-credit tuition rate as reported on August 1, for
- 13 the immediately preceding academic year.
- 14 (6) A person participating in phase II may be eligible for
- additional funds not to exceed \$500.00 per semester or \$400.00 per
- 16 term up to a maximum of \$2,000.00 subject to the following
- 17 conditions:
- 18 (a) Credits are earned in a 4-year program at a Michigan
- 19 degree-granting 4-year college or university.
- 20 (b) The tuition reimbursement is for coursework completed
- 21 within 30 months of completion of the phase I requirements.
- 22 (7) The department shall work closely with participating
- 23 institutions to develop an application and eligibility
- 24 determination process that will provide the highest level of
- 25 participation and ensure that all requirements of the program are
- **26** met.
- 27 (8) Applications for the tuition incentive program may be

- 1 approved at any time after the student begins the sixth grade. If a
- 2 determination of financial eligibility is made, that determination
- 3 is valid as long as the student meets all other program
- 4 requirements and conditions.
- 5 (9) Each institution shall ensure that all known available
- 6 restricted grants for tuition and fees are used prior to billing
- 7 the tuition incentive program for any portion of a student's
- 8 tuition and fees.
- 9 (10) The department shall ensure that the tuition incentive
- 10 program is well publicized and that potentially eligible Medicaid
- 11 clients are provided information on the program. The department
- 12 shall provide the necessary funding and staff to fully operate the
- 13 program.
- 14 Sec. 311. To enable the legislature and the state budget

- 25 employment and the number of patents generated as a result of work
- 26 conducted by the agricultural experiment station and cooperative
- 27 extension service.

- 1 Sec. 434. Included in the appropriation in part 1 for Michigan
- 2 State University is \$80,000.00 for the Michigan future farmers of
- 3 America association. This \$80,000.00 appropriation shall not
- 4 supplant any existing support that Michigan State University
- 5 provides to the Michigan future farmers of America association.
- 6 Sec. 436. (1) It is the intent of the legislature that, if any

- 6 (3) The state budget director shall, in consultation with the
- 7 house and senate fiscal agencies, develop a uniform reporting
- 8 mechanism based on standard definitions for public universities to
- 9 comply with the reporting requirements of subsection (2).
- 10 Sec. 440. All public universities shall submit the amount of
- 11 tuition and fees actually charged to a full-time resident

- 26 for North American Indians under 1976 PA 174, MCL 390.1251 to
- **27** 390.1253.

- 1 Sec. 461. From the amount appropriated in part 1 to Lake
- 2 Superior State University for operations, \$100,000.00 shall be paid
- 3 to Bay Mills Community College for the costs of waiving tuition for
- 4 North American Indians under 1976 PA 174, MCL 390.1251 to 390.1253.
- 5 Sec. 463. Not later than February 1, 2011, each of the public
- 6 universities receiving appropriations in part 1 shall submit to the
- 7 state budget director, members of the house of representatives and
- 8 the senate, and the house and senate fiscal agencies a report on
- 9 the number of residents from an eligible county enrolled at the
- 10 university and the quantifiable increase from the 2009-2010
- 11 academic year to the 2010-2011 academic year in outreach efforts to
- 12 enroll students at the university from an eligible county. As used

- 20 economically disadvantaged students who enroll in and complete K-12

- 6 program operation.
- 7 (3) The auditor general shall periodically audit higher
- 8 education institutional data inventory (HEIDI) data as submitted by
