## SUBSTITUTE FOR SENATE BILL NO. 1313

A bill to amend 1931 PA 328, entitled "The Michigan penal code," (MCL 750.1 to 750.568) by adding section 81e.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81E. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN INDIVIDUAL
- 3 WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS AN EMPLOYEE
- 4 OR CONTRACTOR OF A PUBLIC UTILITY OR BECAUSE OF THE INDIVIDUAL'S
- 5 STATUS AS AN EMPLOYEE OR CONTRACTOR OF A PUBLIC UTILITY IS GUILTY
- 6 OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1
- 7 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.

- 1 (2) A PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN
- 2 INDIVIDUAL WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS
- 3 AN EMPLOYEE OR CONTRACTOR OF A PUBLIC UTILITY OR BECAUSE OF THE
- 4 INDIVIDUAL'S STATUS AS AN EMPLOYEE OR CONTRACTOR OF A PUBLIC
- 5 UTILITY CAUSING THE INDIVIDUAL BODILY INJURY REQUIRING MEDICAL
- 6 ATTENTION OR MEDICAL CARE IS GUILTY OF A FELONY PUNISHABLE BY
- 7 IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN
- 8 \$1,000.00, OR BOTH.
- 9 (3) A PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN
- 10 INDIVIDUAL WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS
- 11 AN EMPLOYEE OR CONTRACTOR OF A PUBLIC UTILITY OR BECAUSE OF THE
- 12 INDIVIDUAL'S STATUS AS AN EMPLOYEE OR CONTRACTOR OF A PUBLIC
- 13 UTILITY CAUSING THE INDIVIDUAL SERIOUS IMPAIRMENT OF A BODY
- 14 FUNCTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
- 15 MORE THAN 5 YEARS OR A FINE OF NOT LESS THAN \$1,000.00 OR MORE THAN
- 16 \$5,000.00, OR BOTH.
- 17 (4) THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING CHARGED
- 18 WITH, CONVICTED OF, OR PUNISHED FOR ANY OTHER VIOLATION OF LAW
- 19 ARISING OUT OF THE SAME TRANSACTION AS THE VIOLATION OF THIS
- 20 SECTION.
- 21 (5) AS USED IN THIS SECTION:
- 22 (A) "PUBLIC UTILITY" MEANS A UTILITY THAT PROVIDES STEAM, GAS,
- 23 HEAT, ELECTRICITY, WATER, CABLE TELEVISION, TELECOMMUNICATIONS
- 24 SERVICES, OR PIPELINE SERVICES, WHETHER PRIVATELY, MUNICIPALLY, OR
- 25 COOPERATIVELY OWNED.
- 26 (B) "SERIOUS IMPAIRMENT OF A BODY FUNCTION" MEANS THAT TERM AS
- 27 DEFINED IN SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300,
