

# SENATE BILL No. 1135

February 10, 2010, Introduced by Senator ALLEN and referred to the Committee on Commerce and Tourism.

A bill to amend 1996 PA 376, entitled  
"Michigan renaissance zone act,"  
by amending section 8d (MCL 125.2688d), as amended by 2008 PA 495.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 8d. (1) The board of the Michigan strategic fund  
2       described in section 4 of the Michigan strategic fund act, 1984 PA  
3       270, MCL 125.2004, may designate not more than 35 tool and die  
4       renaissance recovery zones within this state in 1 or more cities,  
5       villages, or townships if that city, village, or township or  
6       combination of cities, villages, or townships consents to the  
7       creation of a recovery zone within their boundaries. A recovery  
8       zone shall have a duration of renaissance zone status for a period  
9       of not less than 5 years and not more than 15 years as determined  
10      by the board of the Michigan strategic fund. If the Michigan

1 strategic fund determines that the duration of renaissance zone  
2 status for a recovery zone is less than 15 years, then the Michigan  
3 strategic fund, with the consent of the city, village, or township  
4 or combination of cities, villages, or townships in which the  
5 qualified tool and die business is located, may extend the duration  
6 of renaissance zone status for the recovery zone for 1 or more  
7 periods that when combined do not exceed 15 years. Not less than 1  
8 of the recovery zones shall consist of 1 or more qualified tool and  
9 die businesses that have a North American industrial classification  
10 system (NAICS) of 332997.

11 (2) The board of the Michigan strategic fund may designate a  
12 recovery zone within this state if the recovery zone consists of  
13 not less than 4 and not more than 20 qualified tool and die  
14 businesses at the time of designation. If the board of the Michigan  
15 strategic fund designated 1 or more recovery zones that contain  
16 less than 20 qualified tool and die businesses before December 19,  
17 2005, the board of the Michigan strategic fund may add additional  
18 qualified tool and die businesses to that recovery zone subject to  
19 the limitations contained in this subsection. A recovery zone shall  
20 consist of only qualified tool and die business property. The board  
21 of the Michigan strategic fund may combine existing recovery zones  
22 that are comprised solely of tool and die businesses that are  
23 parties to the same qualified collaborative agreement. Where 2 or  
24 more recovery zones have been combined, the board of the Michigan  
25 strategic fund may continue to designate additional recovery zones,  
26 provided that no more than ~~25~~35 tool and die recovery zones exist  
27 at 1 time.

1           (3) The board of the Michigan strategic fund may revoke the  
2 designation of all or a portion of a recovery zone with respect to  
3 1 or more qualified tool and die businesses if those qualified tool  
4 and die businesses fail or cease to participate in or comply with a  
5 qualified collaborative agreement. A qualified tool and die  
6 business may enter into another qualified collaborative agreement  
7 once it is designated part of a recovery zone.

8           (4) One or more qualified tool and die businesses subject to a  
9 qualified collaborative agreement may merge into another group of  
10 qualified tool and die businesses subject to a different qualified  
11 collaborative agreement upon application to and approval by the  
12 Michigan strategic fund.

13           (5) A qualified tool and die business in a recovery zone may  
14 have a different period of renaissance zone status than other  
15 qualified tool and die businesses in the same recovery zone.

16           (6) The board of the Michigan strategic fund may modify an  
17 existing recovery zone to add 1 or more qualified tool and die  
18 businesses with the consent of all other qualified tool and die  
19 businesses that are participating in the recovery zone.

20           (7) The board of the Michigan strategic fund may modify an  
21 existing recovery zone to add additional property under the same  
22 terms and conditions as the existing recovery zone if all of the  
23 following are met:

24           (a) The additional real property is contiguous to existing  
25 qualified tool and die business property and will become qualified  
26 tool and die business property once it is brought into operation as  
27 determined by the board of the Michigan strategic fund.

1 (b) The city, village, or township in which the qualified tool  
2 and die business is located consents to the modification.

3 (8) Beginning on ~~the effective date of the amendatory act that~~  
4 ~~added this subsection~~ **JANUARY 13, 2009**, a recovery zone may include  
5 a qualified tool and die business that has 75 or more full-time  
6 employees if that qualified tool and die business has entered into  
7 a written agreement with the board of the Michigan strategic fund  
8 and the city, village, or township, or a combination of cities,  
9 villages, or townships, in which the qualified tool and die  
10 business is located.

11 (9) As used in this section:

12 (a) "Qualified collaborative agreement" means an agreement  
13 that demonstrates synergistic opportunities, including, but not  
14 limited to, all of the following:

15 (i) Sales and marketing efforts.

16 (ii) Development of standardized processes.

17 (iii) Development of tooling standards.

18 (iv) Standardized project management methods.

19 (v) Improved ability for specialized or small niche shops to  
20 develop expertise and compete successfully on larger programs.

21 (b) "Qualified tool and die business" means a business entity  
22 that meets all of the following:

23 (i) Has a North American industrial classification system  
24 (NAICS) of 332997, 333511, 333512, 333513, 333514, or 333515; or  
25 has a North American industrial classification system (NAICS) of  
26 337215 and operates a facility within an existing renaissance zone,  
27 which facility is adjacent to real property not located in a

1 renaissance zone and is located within 1/4 mile of a Michigan  
2 technical education center.

3 (ii) Has entered into a qualified collaboration agreement as  
4 approved by the Michigan strategic fund consisting of not fewer  
5 than 4 or more than 20 other business entities at the time of  
6 designation that have a North American industrial classification  
7 system (NAICS) of 332997, 333511, 333512, 333513, 333514, or  
8 333515.

9 (iii) Except as otherwise provided by the board of the Michigan  
10 strategic fund, has fewer than 75 full-time employees.

11 (c) "Qualified tool and die business property" means 1 or more  
12 of the following:

13 (i) Property owned by 1 or more qualified tool and die  
14 businesses and used by those qualified tool and die businesses  
15 primarily for tool and die business operations. Qualified tool and  
16 die business property is used primarily for tool and die business  
17 operations if the qualified tool and die businesses that own the  
18 qualified tool and die business property generate 75% or more of  
19 the qualified tool and die businesses' gross revenue from tool and  
20 die operations that take place on the qualified tool and die  
21 business property at the time of designation.

22 (ii) Property leased by 1 or more qualified tool and die  
23 business for which the qualified tool and die business is liable  
24 for ad valorem property taxes and which is used by those qualified  
25 tool and die businesses primarily for tool and die business  
26 operations. Qualified tool and die business property is used  
27 primarily for tool and die business operations if the qualified

1 tool and die businesses that lease the qualified tool and die  
2 business property generate 75% or more of the qualified tool and  
3 die businesses' gross revenue from tool and die operations that  
4 take place on the qualified tool and die business property at the  
5 time of designation. The qualified tool and die business shall  
6 furnish proof of its ad valorem property tax liability to the  
7 department of treasury.
