

**SUBSTITUTE FOR
SENATE BILL NO. 1346**

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 20101, 20104, and 20104a (MCL 324.20101,
324.20104, and 324.20104a), section 20101 as amended and section
20104a as added by 1996 PA 383 and section 20104 as amended by 1995
PA 71.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20101. (1) As used in this part:
- 2 (a) "Act of God" means an unanticipated grave natural disaster
- 3 or other natural phenomenon of an exceptional, inevitable, and
- 4 irresistible character, the effects of which could not have been
- 5 prevented or avoided by the exercise of due care or foresight.

(b) "Agricultural property" means real property used for farming in any of its branches, including cultivating of soil; growing and harvesting of any agricultural, horticultural, or floricultural commodity; dairying; raising of livestock, bees, fish, fur-bearing animals, or poultry; turf and tree farming; and performing any practices on a farm as an incident to, or in conjunction with, these farming operations. Agricultural property does not include property used for commercial storage, processing, distribution, marketing, or shipping operations.

(C) "ALL APPROPRIATE INQUIRY" MEANS AN EVALUATION OF ENVIRONMENTAL CONDITIONS AT A PROPERTY AT THE TIME OF PURCHASE, OCCUPANCY, OR FORECLOSURE THAT REASONABLY DEFINES THE EXISTING CONDITIONS AND CIRCUMSTANCES AT THE PROPERTY IN CONFORMANCE WITH 40 CFR 312.

(D) ~~(e)~~—"Attorney general" means the department of the attorney general.

(E) "BACKGROUND CONCENTRATION" MEANS THE CONCENTRATION OR LEVEL OF A HAZARDOUS SUBSTANCE THAT EXISTS IN THE ENVIRONMENT AT OR REGIONALLY PROXIMATE TO A FACILITY THAT IS NOT ATTRIBUTABLE TO ANY RELEASE AT OR REGIONALLY PROXIMATE TO THE FACILITY.

(F) ~~(d)~~—"Baseline environmental assessment" means an ~~evaluation of environmental conditions which exist at a facility at the time of purchase, occupancy, or foreclosure that reasonably defines the existing conditions and circumstance at the facility so that, in the event of a subsequent release, there is a means of distinguishing the new release from existing contamination.~~ A WRITTEN DOCUMENT THAT DESCRIBES THE RESULTS OF AN ALL APPROPRIATE

1 INQUIRY AND THE SAMPLING AND ANALYSIS THAT CONFIRM THAT THE
2 PROPERTY IS A FACILITY. HOWEVER, FOR PURPOSES OF A BASELINE
3 ENVIRONMENTAL ASSESSMENT, THE ALL APPROPRIATE INQUIRY UNDER 40 CFR
4 312.20 (A) MAY BE CONDUCTED WITHIN 45 DAYS AFTER THE DATE OF
5 ACQUISITION OF A PROPERTY AND THE COMPONENTS OF AN ALL APPROPRIATE
6 INQUIRY UNDER 40 CFR 312.20 (B) AND 40 CFR 312.20 (C) (3) MAY BE
7 CONDUCTED OR UPDATED WITHIN 45 DAYS AFTER THE DATE OF ACQUISITION
8 OF A PROPERTY.

9 (G) ~~(e)~~—"Board" means the brownfield redevelopment board
10 created in section 20104a.

11 (H) "CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE" MEANS
12 EITHER OF THE FOLLOWING:

13 (i) CLEANUP CRITERIA THAT SATISFY THE REQUIREMENTS FOR THE
14 RESIDENTIAL CATEGORY IN SECTION 20120A(1) (A) OR (16) .

15 (ii) CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE UNDER
16 PART 213 .

17 (I) ~~(f)~~—"Department" means the director of the department of
18 ~~environmental quality~~ **NATURAL RESOURCES AND ENVIRONMENT** or his or
19 her designee to whom the director delegates a power or duty by
20 written instrument.

21 (J) ~~(g)~~—"Director" means the director of the department of
22 ~~environmental quality~~ **NATURAL RESOURCES AND ENVIRONMENT**.

23 (K) ~~(h)~~—"Directors" means the directors or their designees of
24 the departments of ~~environmental quality~~ **NATURAL RESOURCES AND**

26 (L) ~~(i)~~—"Disposal" means the discharge, deposit, injection,
27 dumping, spilling, leaking, or placing of any hazardous substance

 2 constituent of the hazardous substance may enter the environment or
 3 be emitted into the air or discharged into any groundwater or
 4 surface water.

5 (M) ~~(j)~~ "Enforcement costs" means court expenses, reasonable
 6 attorney fees of the attorney general, and other reasonable
 7 expenses of an executive department that are incurred in relation
 8 to enforcement under this part. ~~or rules promulgated under this~~
 9 ~~part, or both.~~

10 (N) ~~(k)~~ "Environment" or "natural resources" means land,
 11 surface water, groundwater, subsurface, strata, air, fish,
 12 wildlife, or biota within the state.

13 (O) ~~(l)~~ "Environmental contamination" means the release of a
 14 hazardous substance, or the potential release of a discarded
 15 hazardous substance, in a quantity which is or may become injurious
 16 to the environment or to the public health, safety, or welfare.

17 (P) ~~(m)~~ "Evaluation" means those activities including, but not
 18 limited to, investigation, studies, sampling, analysis, development
 19 of feasibility studies, and administrative efforts that are needed
 20 to determine the nature, extent, and impact of a release or threat
 21 of release and necessary response activities.

22 (Q) ~~(n)~~ "Exacerbation" means the occurrence of either of the
 23 following caused by an activity undertaken by the person who owns
 24 or operates the property, with respect to ~~existing~~ contamination
 25 **FOR WHICH THE PERSON IS NOT LIABLE:**

26 (i) Contamination that has migrated beyond the boundaries of
 27 the property which is the source of the release at levels above

cleanup criteria ~~specified in section 20120a(1)(a)~~ **FOR UNRESTRICTED RESIDENTIAL USE** unless a criterion is not relevant because exposure is reliably restricted ~~pursuant to section 20120b~~ **AS OTHERWISE PROVIDED IN THIS PART.**

(ii) A change in facility conditions that increases response activity costs.

~~(o) "Facility" means any area, place, or property where a hazardous substance in excess of the concentrations which satisfy the requirements of section 20120a(1)(a) or (17) or the cleanup criteria for unrestricted residential use under part 213 has been released, deposited, disposed of, or otherwise comes to be located. Facility does not include any area, place, or property at which response activities have been completed which satisfy the cleanup criteria for the residential category provided for in section 20120a(1)(a) and (17) or at which corrective action has been completed under part 213 which satisfies the cleanup criteria for unrestricted residential use.~~

(R) "FACILITY" MEANS ANY AREA, PLACE, OR PROPERTY WHERE A HAZARDOUS SUBSTANCE IN EXCESS OF THE CONCENTRATIONS THAT SATISFY THE CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE HAS BEEN RELEASED, DEPOSITED, DISPOSED OF, OR OTHERWISE COMES TO BE LOCATED. FACILITY DOES NOT INCLUDE ANY AREA, PLACE, OR PROPERTY WHERE ANY OF THE FOLLOWING CONDITIONS ARE SATISFIED:

(i) RESPONSE ACTIVITIES HAVE BEEN COMPLETED UNDER THIS PART THAT SATISFY THE CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE.

(ii) CORRECTIVE ACTION HAS BEEN COMPLETED UNDER PART 213 THAT SATISFIES THE CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE.

1 (iii) SITE-SPECIFIC CRITERIA THAT HAVE BEEN APPROVED BY THE
2 DEPARTMENT FOR APPLICATION AT THE AREA, PLACE, OR PROPERTY ARE MET
3 OR SATISFIED AND BOTH OF THE FOLLOWING CONDITIONS ARE MET:

4 (A) THE SITE-SPECIFIC CRITERIA DO NOT DEPEND ON ANY LAND USE
5 OR RESOURCE USE RESTRICTION TO ENSURE PROTECTION OF THE PUBLIC
6 HEALTH, SAFETY, OR WELFARE OR THE ENVIRONMENT.

7 (B) HAZARDOUS SUBSTANCES AT THE AREA, PLACE, OR PROPERTY THAT
8 ARE NOT ADDRESSED BY SITE-SPECIFIC CRITERIA SATISFY THE CLEANUP
9 CRITERIA FOR UNRESTRICTED RESIDENTIAL USE.

10 (S) ~~(p)~~ "Feasibility study" means a process for developing,
11 evaluating, and selecting appropriate response activities.

12 (T) "FINANCIAL ASSURANCE" MEANS A PERFORMANCE BOND, ESCROW,
13 CASH, CERTIFICATE OF DEPOSIT, IRREVOCABLE LETTER OF CREDIT,
14 CORPORATE GUARANTEE, OR OTHER EQUIVALENT SECURITY, OR ANY
15 COMBINATION THEREOF.

16 (U) ~~(q)~~ "Foreclosure" means possession of a property by a
17 lender on which it has foreclosed on a security interest or the
18 expiration of a lawful redemption period, whichever occurs first.

19 (V) ~~(r)~~ "Free product" means a hazardous substance in a liquid
20 phase equal to or greater than 1/8 inch of measurable thickness
21 that is not dissolved in water and that has been released into the
22 environment.

23 (W) ~~(s)~~ "Fund" means the cleanup and redevelopment fund
24 established in section 20108.

25 (X) ~~(t)~~ "Hazardous substance" means 1 or more of the
26 following, but does not include fruit, vegetable, or field crop
27 residuals or processing by-products, or aquatic plants, that are

1 applied to the land for an agricultural use or for use as an animal
 2 feed, if the use is consistent with generally accepted agricultural
 3 management practices developed pursuant to the Michigan right to
 4 farm act, ~~Act No. 93 of the Public Acts of 1981, being sections~~
 5 ~~286.471 to 286.474 of the Michigan Compiled Laws 1981 PA 93, MCL~~
 6 **286.471 TO 286.474:**

7 (i) Any substance that the department demonstrates, on a case

 13 environmental response, compensation, and liability act, ~~of 1980,~~

15 (iii) Hazardous waste as defined in part 111.

16 (iv) Petroleum as described in part 213.

17 **(Y)** ~~(u)~~ "Interim response activity" means the cleanup or
 18 removal of a released hazardous substance or the taking of other
 19 actions, prior to the implementation of a remedial action, as may
 20 be necessary to prevent, minimize, or mitigate injury to the public
 21 health, safety, or welfare, or to the environment. Interim response
 22 activity also includes, but is not limited to, measures to limit
 23 access, replacement of water supplies, and temporary relocation of
 24 people as determined to be necessary by the department. In
 25 addition, interim response activity means the taking of other
 26 actions as may be necessary to prevent, minimize, or mitigate a
 27 threatened release.

(Z) ~~(v)~~ "Lender" means any of the following:

(i) A state or nationally chartered bank.

(ii) A state or federally chartered savings and loan association or savings bank.

(iii) A state or federally chartered credit union.

(iv) Any other state or federally chartered lending institution or regulated affiliate or regulated subsidiary of any entity listed in this subparagraph or subparagraphs (i) to (iii).

(v) An insurance company authorized to do business in this state pursuant to the insurance code of 1956, ~~Act No. 218 of the Public Acts of 1956, being sections 500.100 to 500.8302 of the Michigan Compiled Laws 1956~~ **PA 218, MCL 500.100 TO 500.8302.**

(vi) A motor vehicle finance company subject to the motor vehicle finance act, ~~Act No. 27 of the Extra Session of 1950, being sections 492.101 to 492.141 of the Michigan Compiled Laws 1950~~ **(EX SESS) PA 27, MCL 492.101 TO 492.141**, with net assets in excess of \$50,000,000.00.

(vii) A foreign bank.

(viii) A retirement fund regulated pursuant to state law or a pension fund regulated pursuant to federal law with net assets in excess of \$50,000,000.00.

(ix) A state or federal agency authorized by law to hold a security interest in real property or a local unit of government holding a reversionary interest in real property.

(x) A nonprofit tax exempt organization created to promote economic development in which a majority of the organization's assets are held by a local unit of government.

9 (BB) ~~(x)~~ "Local unit of government" means a county, city,
10 township, or village, an agency of a local unit of government, an
11 authority or any other public body or entity created by or pursuant
12 to state law. Local unit of government does not include the state
13 or federal government or a state or federal agency.

14 (CC) "METHOD DETECTION LIMIT" MEANS THE MINIMUM CONCENTRATION
15 OF A HAZARDOUS SUBSTANCE WHICH CAN BE MEASURED AND REPORTED WITH
16 99% CONFIDENCE THAT THE ANALYTE CONCENTRATION IS GREATER THAN ZERO
17 AND IS DETERMINED FROM ANALYSIS OF A SAMPLE IN A GIVEN MATRIX THAT
18 CONTAINS THE ANALYTE.

19 (DD) "NO FURTHER ACTION LETTER" MEANS A WRITTEN RESPONSE
20 PROVIDED BY THE DEPARTMENT UNDER SECTION 20114D CONFIRMING THAT A
21 NO FURTHER ACTION REPORT HAS BEEN APPROVED AFTER REVIEW BY THE
22 DEPARTMENT.

23 (EF) "NO FURTHER ACTION REPORT" MEANS A REPORT UNDER SECTION
24 20114D DETAILING THE COMPLETION OF REMEDIAL ACTIONS AND INCLUDING A
25 POSTCLOSURE PLAN AND A POSTCLOSURE AGREEMENT, IF APPROPRIATE.

27 responsible for the operation of a facility. Operator does not

3 REPORT THAT PRESCRIBES, AS APPROPRIATE, ACTIVITIES REQUIRED TO BE

13 transaction creates or establishes an interest in real property for

16 (TT) "TARGET DETECTION LIMIT" MEANS THE DETECTION LIMIT FOR A
17 HAZARDOUS SUBSTANCE IN A GIVEN ENVIRONMENTAL MEDIUM THAT IS
18 SPECIFIED BY THE DEPARTMENT ON A LIST THAT IT PUBLISHES NOT MORE
19 THAN ONCE A YEAR. THE DEPARTMENT SHALL IDENTIFY 1 OR MORE
20 ANALYTICAL METHODS, WHEN A METHOD IS AVAILABLE, THAT ARE JUDGED TO
21 BE CAPABLE OF ACHIEVING THE TARGET DETECTION LIMIT FOR A HAZARDOUS
22 SUBSTANCE IN A GIVEN ENVIRONMENTAL MEDIUM. THE TARGET DETECTION
