SUBSTITUTE FOR SENATE BILL NO. 1443

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 5204a (MCL 324.5204a), as added by 2005 PA 254, and by adding section 5317.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5204a. (1) The authority, in conjunction with the
- 2 department, shall establish a strategic water quality initiatives
- 3 grant program that provides grants totaling not more than
- 4 \$40,000,000.00 \$80,000,000.00 to eligible municipalities. The grant
- 5 program shall provide assistance to municipalities to complete the
- 6 loan application requirements of section 5308 OR TO COMPLETE THE
- 7 LOAN APPLICATION REQUIREMENTS FOR OTHER SOURCES OF FINANCING FOR
- 8 SEWAGE TREATMENT WORKS PROJECTS, STORM WATER TREATMENT PROJECTS, OR
- 9 NONPOINT SOURCE PROJECTS.

- 1 (2) The grant program is subject to all of the following:
- 2 (a) The grant program shall provide grants to cover not more
- 3 than 90% of the costs incurred by a municipality to complete an
- 4 application for loan assistance from the state water pollution
- 5 control revolving fund or the fund OR TO COMPLETE AN APPLICATION
- 6 FOR LOAN ASSISTANCE FROM ANOTHER SOURCE OF FINANCING FOR A SEWAGE
- 7 TREATMENT WORKS PROJECT, A STORM WATER TREATMENT PROJECT, OR A
- 8 NONPOINT SOURCE PROJECT.
- 9 (b) The 10% local match is not eligible for loan assistance
- 10 from the state water pollution control revolving fund or the fund
- 11 OR OTHER SOURCE OF FINANCING FOR THE PROJECT.
- 12 (c) Grant funds shall not be used for general local government
- 13 administrative activities or activities performed by municipal
- 14 employees.
- (d) A municipality shall not receive more than \$1,000,000.00
- 16 in total grant assistance under this section.
- 17 (e) Grants under this section shall be available for projects
- 18 seeking or intending to seek loan assistance after September 30,
- **19** 2006.
- 20 (f) The department shall cease accepting grant applications
- 21 under this section 2 years after the date the first grant agreement
- 22 is entered into under subsection (3).
- 23 (3) Within 6 months after the effective date of the amendatory
- 24 act that added this section, the THE department shall establish an
- 25 application and review process for considering grant applications
- 26 under this section. The application shall contain the information
- 27 required by the department and the authority. Within 30-60 days

- 1 after receipt of an application, the department shall publish
- 2 notice of the application on the department's calendar. Within 60
- 3 days after receipt of an administratively complete grant
- 4 application, the department shall, in writing, notify the applicant
- 5 whether the application is approved or rejected. If the department
- 6 approves a grant under this section, the department and the
- 7 authority shall enter into a grant agreement with the recipient

- 22 FOR 2 CONSECUTIVE FISCAL YEARS UNLESS THE APPLICANT PROCEEDS WITH
- 23 FUNDING FROM ANOTHER SOURCE.
- 24 (c) The applicant is unable to, or decides not to, proceed
- 25 with constructing the project. or opts to finance construction by
- 26 means other than a grant from the state water pollution control
- 27 revolving fund or the fund.

- 1 (4) For each year in which the department receives grant
- 2 applications under this section, the department shall report by
- 3 July 1 of each year to the standing committees of the senate and
- 4 the house of representatives with primary jurisdiction over issues
- 5 pertaining to natural resources and the environment and to the

- 7 the utilization of funds under this part that were received from
- 8 the Great Lakes water quality bond fund created in section 19706.

- 17 (d) A summary of loan assistance, by year, tendered from the
- 18 state water pollution control revolving fund and the fund.
- 19 (5) The senate and house appropriations committees shall
- 20 annually review whether there is sufficient money in the fund to
- 21 implement this section and section 5202.
- 22 SEC. 5317. (1) THE STATE WATER POLLUTION CONTROL REVOLVING
- 23 FUND ADVISORY COMMITTEE IS CREATED WITHIN THE DEPARTMENT OF NATURAL

- 8 (F) THE MICHIGAN MUNICIPAL LEAGUE WITH REGARD TO APPOINTING

- 14 FUNCTION IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442,

- 16 (10) MEMBERS OF THE COMMITTEE SHALL SERVE WITHOUT
- 17 COMPENSATION.
- 18 (11) STAFF FROM THE DEPARTMENT OF NATURAL RESOURCES AND
- 19 ENVIRONMENT SHALL ASSIST WITH THE ADMINISTRATIVE TASKS OF THE
- 20 COMMITTEE, INCLUDING MEETING NOTICES, MINUTES, AND COMPILATION OF
- 21 RESOURCE MATERIALS AND REPORTS.
- 22 (12) THE COMMITTEE SHALL EVALUATE THIS PART AND MAKE
- 23 RECOMMENDATIONS ON HOW THIS PART COULD BE AMENDED TO ACHIEVE THE

- 6 (A) REVISING PROCEDURES TO ACCOMMODATE CONCURRENT DESIGN AND
- 7 BUILD TYPE PROCUREMENT AND OTHER NONTRADITIONAL CONTRACTING
- 8 PROCEDURES.
- 9 (B) ALLOWING PROJECT PLANNING AND PRECONSTRUCTION AS COSTS
- 10 ELIGIBLE FOR ASSISTANCE FROM THE FUND.
- 11 (C) REDUCING AND STREAMLINING THE COST-EFFECTIVENESS REVIEW
- 12 REQUIREMENTS TO BE MORE CONSISTENT WITH LOCAL PLANNING NEEDS.
- 13 (D) UPDATING THE SCORING SYSTEM TO TAKE INTO ACCOUNT
- 14 INFRASTRUCTURE ASSET MANAGEMENT.
- 15 (E) SIMPLIFYING APPLICATION PROCEDURES.
- 16 (F) REVIEWING OPTIONS TO PROVIDE GRANTS TO MUNICIPALITIES FOR
- 17 TIMELY AND APPROPRIATE PROJECT PLANNING, INCLUDING DISINCENTIVES
- 18 FOR FAILURE TO DEMONSTRATE PROGRESS.
- 19 (G) ESTABLISHING PROTOCOLS FOR A PREMEETING PROCESS FOR THE
- 20 DEPARTMENT OF NATURAL RESOURCES AND ENVIRONMENT TO PROVIDE INFORMAL
- 21 FEEDBACK TO REVIEW THE APPLICATION AND DETERMINE THE LIKELIHOOD OF
- 22 RECEIVING FUNDING.
- 23 (H) RECOMMENDING A NEW MODEL FOR ESTABLISHING INTEREST RATES
- 24 ON A SLIDING SCALE BASED ON THE PERCENTAGE OF INCOME PAID IN
- 25 UTILITY FEES.
- 26 (I) REVIEWING OPTIONS TO ALLOW MUNICIPALITIES TO BE ABLE TO
- 27 ROLL PROJECT PLAN EXPENSES INTO THE LOANS.
