A bill to amend 1984 PA 274, entitled

"Michigan antitrust reform act,"

by amending the title and section 2 (MCL 445.772), the title as amended by 1987 PA 243.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE
