HOUSE BILL No. 4278

February 17, 2009, Introduced by Reps. Valentine, Liss, Byrnes, Miller, Scripps, Smith, Robert Jones, Roberts and Lisa Brown and referred to the Committee on Great Lakes and Environment.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 17201 (MCL 324.17201), as amended by 2006 PA 494, and by adding section 17208.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17201. As used in this part:
- 2 (a) "Appliance" means a refrigerator, dehumidifier, freezer,
- 3 oven, range, microwave oven, washer, dryer, dishwasher, trash
- 4 compactor, window room air conditioner, television, or computer.
- 5 Appliance does not include a home heating or central air-
- 6 conditioning system.
 - (b) "Manufacturer" means a person that produces, imports, or distributes mercury thermometers MERCURY-ADDED PRODUCTS in this
- 9 state.

- 1 (C) "MERCURY-ADDED NOVELTY" MEANS A MERCURY-ADDED PRODUCT
- 2 INTENDED MAINLY FOR PERSONAL OR HOUSEHOLD ENJOYMENT OR ADORNMENT.
- 3 MERCURY-ADDED NOVELTY INCLUDES AN ITEM INTENDED FOR USE AS A
- 4 PRACTICAL JOKE, FIGURINE, ADORNMENT, TOY, GAME, CARD, ORNAMENT,
- 5 YARD STATUE OR FIGURE, CANDLE, JEWELRY, HOLIDAY DECORATION, ITEM OF

- 10 PRODUCT MAY INCLUDE, BUT IS NOT LIMITED TO, A LABORATORY CHEMICAL,
- 11 CLEANING PRODUCT, COSMETIC, PHARMACEUTICAL, COATING MATERIAL,
- 12 MEASURING DEVICE, LAMP, OR SWITCH. MERCURY-ADDED PRODUCT DOES NOT
- 13 INCLUDE A BUTTON CELL BATTERY OR A PRODUCT THAT DOES NOT CONTAIN
- 14 MERCURY EXCEPT WITHIN A BUTTON CELL BATTERY.
- **(E)** (C) "Mercury fever thermometer" means a mercury
- 16 thermometer used for measuring body temperature.
- (F) (d) "Mercury thermometer" means a product or component,
- 18 other than a dry cell battery, of a product used for measuring
- 19 temperature that contains mercury or a mercury compound
- 20 intentionally added to the product or component. Mercury
- 21 thermometer does not include a product or component of a product
- 22 that is used as a replacement for an existing thermometer that
- 23 measures temperature as part of a manufacturing process.
- 24 (G) (e) "Thermostat" means a consumer product that uses a
- 25 switch that contains mercury or a mercury compound to sense and
- 26 control room temperature, including room temperature in
- 27 residential, commercial, industrial, and other buildings, by

- 4 SEC. 17208. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 5 BEGINNING JULY 1, 2010, A MANUFACTURER OF A MERCURY-ADDED PRODUCT
- 6 SHALL AFFIX TO EACH MERCURY-ADDED PRODUCT INTENDED FOR SALE IN THIS
- 7 STATE OR FOR USE IN THIS STATE A LABEL THAT MEETS ALL OF THE
- 8 FOLLOWING REOUIREMENTS, AS APPLICABLE:
- 9 (A) CONTAINS A STATEMENT USING WORDS OR SYMBOLS, IN A MINIMUM
- 10 OF 10-POINT FONT TYPE, THAT INFORMS THE PURCHASER OR USER THAT THE
- 11 PRODUCT CONTAINS MERCURY OR A MERCURY COMPOUND.
- 12 (B) IS CLEARLY VISIBLE TO THE PURCHASER OR USER BEFORE THE
- 13 SALE OR USE OF THE PRODUCT. IF THE PRODUCT IS ENCLOSED WITHIN A
- 14 PACKAGE THAT PREVENTS THE LABEL AFFIXED TO THE PRODUCT FROM BEING
- 15 CLEARLY VISIBLE BEFORE SALE OR OTHER DISTRIBUTION, THE MANUFACTURER
- 16 SHALL ALSO AFFIX A LABEL THAT MEETS THE REQUIREMENTS OF THIS
- 17 SUBSECTION TO THE PACKAGE. THE REQUIREMENT OF THIS SUBDIVISION TO
- 18 AFFIX A LABEL TO A PACKAGE DOES NOT APPLY TO A MERCURY-ADDED
- 19 PRODUCT THAT IS A REFRIGERATOR, FREEZER, OVEN, RANGE, WASHER, OR
- 20 DRYER.
- 21 (C) IF THE PRODUCT CONSISTS OF MORE THAN 1 COMPONENT THAT
- 22 CONTAINS MERCURY OR A MERCURY COMPOUND, IS AFFIXED TO EACH
- 23 COMPONENT THAT CONTAINS MERCURY OR A MERCURY COMPOUND. HOWEVER, THE
- 24 MANUFACTURER OF A MOTOR VEHICLE MAY COMPLY WITH THIS SUBDIVISION BY
- 25 AFFIXING A LABEL ON THE DOORPOST THAT LISTS THE COMPONENTS OF THE
- 26 MOTOR VEHICLE THAT CONTAIN MERCURY OR A MERCURY COMPOUND.
- 27 (D) IS SUFFICIENTLY DURABLE TO REMAIN LEGIBLE FOR THE USEFUL

- 2 (E) USING WORDS OR SYMBOLS, INFORMS THE PURCHASER OR USER THAT
- 3 THE PRODUCT SHOULD NOT BE DISPOSED OF OR PLACED IN A WASTE STREAM
- 4 THAT IS DESTINED FOR DISPOSAL IN A LANDFILL OR INCINERATOR.

- 13 (3) IF A PERSON OFFERS A MERCURY-ADDED PRODUCT FOR FINAL SALE
- 14 OR OTHER DISTRIBUTION TO AN ADDRESS IN THIS STATE UNDER
- 15 CIRCUMSTANCES IN WHICH THE PURCHASER OR RECIPIENT IS NOT ABLE TO
- 16 VIEW THE LABELS REQUIRED UNDER THIS SECTION ON THE PRODUCT OR THE
- 17 PACKAGE BEFORE THE PURCHASE OR RECEIPT, INCLUDING, BUT NOT LIMITED
- 18 TO, CATALOGUE, TELEPHONE, AND INTERNET SALES OR PROMOTIONAL
- 19 TRANSACTIONS, THE PERSON SHALL CLEARLY ADVISE THE PURCHASER OR
- 20 RECIPIENT AT THE POINT OF SALE OR OTHER DISTRIBUTION THAT THE
- 21 PRODUCT CONTAINS MERCURY OR A MERCURY COMPOUND.
