A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

by amending section 811e (MCL 257.811e), as amended by 2006 PA 562, and by adding section 811r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 811e. (1) Beginning January 1, 2007, the THE secretary of
- 2 state may develop a fund-raising plate as provided in this section.
- 3 (2) A-EXCEPT AS PROVIDED IN SUBSECTION (7), A start-up fee of
- 4 \$15,000.00 shall be paid for any new fund-raising plate authorized
