- 1 SEC. 3205C. (1) IF A BORROWER HAS CONTACTED A HOUSING
- 2 COUNSELOR UNDER SECTION 3205B BUT THE PROCESS HAS NOT RESULTED IN
- 3 AN AGREEMENT TO MODIFY THE MORTGAGE LOAN, THE BORROWER, HOUSING
- 4 COUNSELOR, MORTGAGE HOLDER, OR MORTGAGE SERVICER SHALL CALCULATE A
- 5 MODIFIED PAYMENT AMOUNT UNDER THE FDIC WORKOUT PROGRAM. THE
- 6 MORTGAGE HOLDER OR MORTGAGE SERVICER SHALL PROVIDE THE BORROWER
- 7 WITH A COPY OF ANY CALCULATION MADE BY THE MORTGAGE HOLDER OR
 - MORTGAGE SERVICER UNDER THIS SUBSECTION.
