19 (2) Determination of sanctions for violations under this
 20 section shall be made by a disciplinary subcommittee. If, during
 21 judicial review, the court of appeals determines that a final
 22 decision or order of a disciplinary subcommittee prejudices
 23 substantial rights of the petitioner for 1 or more of the grounds
 24 listed in section 106 of the administrative procedures act of
 25 1969, 1969 PA 306, MCL 24.306, and holds that the final decision
 26 or order is unlawful and is to be set aside, the court shall
 27 state on the record the reasons for the holding and may remand
 28 the case to the disciplinary subcommittee for further

1 consideration.

2 (3) A disciplinary subcommittee may impose a fine of up to,
3 but not exceeding, \$250,000.00 for a violation of section
4 16221(a) or (b).

5 (4) A disciplinary subcommittee may require a licensee or
6 registrant or an applicant for licensure or registration who has
7 violated this article or article 7 or a rule promulgated under
8 this article or article 7 to satisfactorily complete an
9 educational program, a training program, or a treatment program,
10 a mental, physical, or professional competence examination, or a
11 combination of those programs and examinations.
