## **HOUSE BILL No. 4476**

February 26, 2009, Introduced by Reps. Angerer, Switalski, Liss, Sheltrown and Melton and referred to the Committee on Health Policy.

A bill to amend 1980 PA 350, entitled
"The nonprofit health care corporation reform act,"
(MCL 550.1101 to 550.1704) by adding section 416e.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 416E. (1) A HEALTH CARE CORPORATION GROUP OR NONGROUP
- 2 CERTIFICATE SHALL PROVIDE COVERAGE FOR THE SCREENING, DIAGNOSIS,
- 3 AND TREATMENT OF AUTISM SPECTRUM DISORDER, INCLUDING, BUT NOT
- 4 LIMITED TO, COVERAGE FOR SPEECH THERAPY, OCCUPATIONAL THERAPY,
- 5 PHYSICAL THERAPY, PSYCHOLOGICAL SERVICES, PSYCHIATRIC SERVICES, AND
- 6 APPLIED BEHAVIOR ANALYSIS, AS PRESCRIBED OR ORDERED BY THE MEMBER'S
- 7 TREATING PHYSICIAN OR PSYCHOLOGIST.
- 8 (2) COVERAGE FOR AUTISM SPECTRUM DISORDER UNDER THIS SECTION
  - IS SUBJECT TO THE SAME TERMS AND CONDITIONS THAT THE HEALTH CARE
    - CORPORATION APPLIES TO THE TREATMENT OF OTHER DISORDERS, EXCEPT AS

- 1 FOLLOWS:
- 2 (A) TREATMENT SHALL NOT BE LIMITED OR DENIED ON THE BASIS THAT
- 3 IT IS HABILITATIVE IN NATURE.
- 4 (B) TREATMENT SHALL NOT BE SUBJECT TO VISIT LIMITS.
- 5 (3) IF A MEMBER IS RECEIVING TREATMENT FOR AUTISM SPECTRUM
- 6 DISORDER, A HEALTH CARE CORPORATION MAY REQUEST A REVIEW OF THAT
- 7 TREATMENT NOT MORE THAN ONCE EVERY 6 MONTHS UNLESS THE HEALTH CARE
- 8 CORPORATION AND THE MEMBER'S TREATING PHYSICIAN OR PSYCHOLOGIST
- 9 AGREE THAT A MORE FREQUENT REVIEW IS NECESSARY. THE COST OF
- 10 OBTAINING THIS REVIEW SHALL BE BORNE BY THE HEALTH CARE
- 11 CORPORATION.
- 12 (4) THIS SECTION SHALL NOT BE CONSTRUED AS LIMITING BENEFITS
- 13 THAT ARE OTHERWISE AVAILABLE TO A MEMBER WITH AUTISM SPECTRUM
- 14 DISORDER.
- 15 (5) AS USED IN THIS SECTION:
- 16 (A) "APPLIED BEHAVIOR ANALYSIS" MEANS THE DESIGN,
- 17 IMPLEMENTATION, AND EVALUATION OF ENVIRONMENTAL MODIFICATIONS,
- 18 USING BEHAVIORAL STIMULI AND CONSEQUENCES, TO PRODUCE SOCIALLY
- 19 SIGNIFICANT IMPROVEMENT IN HUMAN BEHAVIOR, INCLUDING THE USE OF
- 20 DIRECT OBSERVATION, MEASUREMENT, AND FUNCTIONAL ANALYSIS OF THE
- 21 RELATIONS BETWEEN ENVIRONMENT AND BEHAVIOR.
- 22 (B) "AUTISM SPECTRUM DISORDER" MEANS ANY OF THE PERVASIVE
- 23 DEVELOPMENTAL DISORDERS AS DEFINED BY THE MOST RECENT EDITION OF
- 24 THE DIAGNOSTIC AND STATISTICAL MANUAL OF MENTAL DISORDERS (DSM),
- 25 INCLUDING AUTISTIC DISORDER, ASPERGER'S DISORDER, AND PERVASIVE
- 26 DEVELOPMENTAL DISORDER NOT OTHERWISE SPECIFIED.
