## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 8. (1) The commissioner may conduct examinations and
- 2 investigations of a person over whom WHICH the commissioner has
- 3 regulatory authority as necessary to determine whether the person
- 4 is brokering, making, servicing, or collecting mortgage HOME loans
- 5 as required by this act.
- 6 (2) THE COMMISSIONER MAY PROMULGATE REASONABLE RULES UNDER THE
- 7 ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO
  - 24.328, AS NECESSARY TO IMPLEMENT AND ADMINISTER THIS ACT.
  - (3) THE COMMISSIONER MAY PROVIDE GUIDANCE TO ANY PERSON OVER
  - WHICH THE COMMISSIONER HAS REGULATORY AUTHORITY ON THE APPLICATION
