A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 2882 (MCL 333.2882), as amended by 2002 PA 691.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2882. (1) Except as otherwise provided in section 2890,
- 2 upon written request and payment of the prescribed fee, the state
- 3 registrar or local registrar shall issue the appropriate 1 of the
- 4 following:
- 5 (a) A certified copy of a live birth record, an affidavit of
- 6 parentage filed after June 1, 1997, or a record of stillbirth filed
 - after June 1, 2003 to 1 of the following:
 - (i) The individual who is the subject of the record.
 - (ii) A parent named in the record.
 - (iii) An heir, a legal representative, or a legal guardian of

- 3 (b) If the live birth record is 100 or more years old, a
- 4 certified copy of the live birth record to any applicant.

- 7 (d) A certified copy of a marriage or divorce record to any
- 8 applicant, except as provided by rule.
- 9 (e) A certified copy of a fetal death record that was filed

- 12 payment of the prescribed fee, the state registrar shall issue to
- 13 that individual a copy of his or her original certificate of live
- 14 birth, if the written request identifies the name of the adult

- 16 clearance reply form that was completed by the family independence

- 21 (3) Upon written request of a confidential intermediary
- 22 appointed under section 68b of the Michigan adoption code, chapter

- 24 presentation of a certified copy of the order of appointment,
- 25 identification of the name of the adult adoptee, and payment of the
- 26 required fee, the state registrar shall issue to the confidential
- 27 intermediary a copy of the original certificate of live birth of

- 11 FOLLOWING WITHOUT THE PAYMENT OF A FEE:
- 12 (A) A COURT OF COMPETENT JURISDICTION.
- 13 (B) AN ATTORNEY-AT-LAW, COURT CLERK, OR EMPLOYEE OF A COURT
- 14 CLERK WHO REQUESTS THE RECORD UNDER SECTION 5(3) OF THE
- 15 ACKNOWLEDGMENT OF PARENTAGE ACT, 1996 PA 305, MCL 722.1005.
