HOUSE BILL No. 4717

March 26, 2009, Introduced by Rep. Ebli and referred to the Committee on Tax Policy.

A bill to amend 1995 PA 24, entitled "Michigan economic growth authority act,"

by amending sections 2 and 6 (MCL 207.802 and 207.806), section 6 as amended by 2008 PA 548.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. The legislature finds that it is in the public
- 2 interest to promote economic growth and to encourage private
- 3 investment, job creation AND RETENTION, and job upgrading for
- residents in this state.
- 5 Sec. 6. The authority shall have powers necessary or
- 6 convenient to carry out and effectuate the purpose of this act,
- 7 including, but not limited to, the following:
 - (a) To authorize eligible businesses to receive tax credits OR

- 1 GRANTS IN ANTICIPATION OF TAX CREDITS to foster job creation OR
- 2 RETENTION in this state.
- 3 (b) To determine which businesses qualify for tax credits
- 4 under this act.
- 5 (c) To determine the amount and duration of tax credits
- 6 authorized under this act.
- 7 (d) To issue certificates and enter into written agreements
- 8 specifying the conditions under which tax credits are authorized
- 9 and the circumstances under which those tax credits may be reduced
- 10 or terminated.
- 11 (e) To charge and collect reasonable administrative fees.
- 12 (f) To delegate to the chairperson of the authority, staff, or
- 13 others the functions and powers it considers necessary and
- 14 appropriate to administer the programs under this act.
- 15 (g) To assist an eligible business to obtain the benefits of a
- 16 tax credit, incentive, or inducement program provided by this act
- 17 or by law.
- 18 (h) To determine the eligibility of and issue certificates to
- 19 certain qualified taxpayers for credits allowed under former
- 20 section 38g(3) of 1975 PA 228 and section 431 of the Michigan

- 22 application process and necessary forms to claim the credit under
- 23 former section 38g(3) of 1975 PA 228 and section 431 of the

- 25 economic growth authority annually shall prepare and submit to the
- 26 house of representatives and senate committees responsible for tax

- 19 (k) To determine the eligibility of and issue certificates to
- 20 certain taxpayers for credits allowed under sections 431a and 431b
- 21 TO 431D of the Michigan business tax act, 2007 PA 36, MCL 208.1431a
- 22 and 208.1431b TO 208.1431D.
- (l) To determine the eligibility of and issue certificates to
- 24 certain taxpayers for credits allowed under sections 432 to 432d of
- 25 the Michigan business tax act, 2007 PA 36, MCL 208.1432 to
- 26 208.1432d.
- 27 (m) To determine the eligibility of and issue certificates to
