HOUSE BILL No. 4739

March 31, 2009, Introduced by Reps. Melton, Rick Jones and Dean and referred to the Committee on Labor.

A bill to amend 1947 PA 336, entitled

"An act to prohibit strikes by certain public employees; to provide review from disciplinary action with respect thereto; to provide for the mediation of grievances and the holding of elections; to declare and protect the rights and privileges of public employees; and to prescribe means of enforcement and penalties for the violation of the provisions of this act,"

by amending section 15 (MCL 423.215), as amended by 1994 PA 112.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 15. (1) A public employer shall bargain collectively with
- 2 the representatives of its employees as defined-INDICATED in
- 3 section 11 and is authorized to make and enter into collective
- 4 bargaining agreements with such THOSE representatives. Except as
- 5 otherwise provided in this section, for the purposes of this
- section, to bargain collectively is the performance of TO PERFORM
- the mutual obligation of the employer and the representative of the

- 16 (e) The decision of whether or not to act as an authorizing
- 17 body to grant a contract to organize and operate 1 or more public
- 18 school academies under part 6a of Act No. 451 of the Public Acts of

- 1 OPERATE TO PROHIBIT CURRENT SCHOOL EMPLOYEES FROM OFFERING BIDS TO

- 5 (g) The use of volunteers in providing services at its6 schools.
- 7 (h) Decisions concerning use of experimental or pilot programs
- 8 and staffing of experimental or pilot programs and decisions
