

HOUSE BILL No. 4765

April 2, 2009, Introduced by Reps. Warren, Nerat, Geiss, Haase, Slavens, Scripps, Segal, Liss, Kennedy, Valentine, Leland, Byrnes, Meadows and McDowell and referred to the Committee on Great Lakes and Environment.

A bill to amend 1978 PA 368, entitled
"Public health code,"
(MCL 333.1101 to 333.25211) by adding section 5494.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 5494. (1) NOT LATER THAN JANUARY 1, 2011, THE DEPARTMENT
2 IN CONSULTATION WITH THE DEPARTMENT OF ENVIRONMENTAL QUALITY SHALL
3 CREATE A COMPREHENSIVE LIST OF CHEMICALS OF CONCERN. THE DEPARTMENT
4 SHALL CONSULT EXISTING AUTHORITATIVE LISTS.

5 (2) NOT LATER THAN JANUARY 1, 2012, THE DEPARTMENT IN
6 CONSULTATION WITH THE DEPARTMENT OF ENVIRONMENTAL QUALITY SHALL
7 IDENTIFY WHICH CHEMICALS FROM THE LIST DEVELOPED UNDER SUBSECTION
8 (1) ARE CHEMICALS OF HIGHEST CONCERN. THE DEPARTMENT SHALL CONSULT

1 EXISTING AUTHORITATIVE LISTS.

2 (3) THE DEPARTMENT IN CONSULTATION WITH THE DEPARTMENT OF
3 ENVIRONMENTAL QUALITY SHALL UPDATE THE LIST OF CHEMICALS OF HIGHEST
4 CONCERN DEVELOPED UNDER SUBSECTION (2) AT LEAST EVERY 2 YEARS BY
5 ADDING ANY ADDITIONAL CHEMICALS OF HIGHEST CONCERN, AS IDENTIFIED
6 UNDER THAT SUBSECTION.

7 Enacting section 1. This amendatory act does not take effect
8 unless all of the following bills of the 95th Legislature are
9 enacted into law:
