- 1 SEC. 5495. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 2 ON OR BEFORE THE EXPIRATION OF 180 DAYS AFTER A CHEMICAL OF HIGHEST
- 3 CONCERN IS IDENTIFIED UNDER SECTION 5494, A MANUFACTURER OR
- 4 DISTRIBUTOR OF A CHILDREN'S PRODUCT FOR SALE IN THIS STATE THAT
- 5 CONTAINS A CHEMICAL OF HIGHEST CONCERN SHALL SUBMIT A WRITTEN
- 6 STATEMENT TO THE DEPARTMENT. THE MANUFACTURER OR DISTRIBUTOR SHALL
- 7 INCLUDE ALL OF THE FOLLOWING IN THE WRITTEN STATEMENT REQUIRED
