A bill to amend 1980 PA 299, entitled "Occupational code,"

by amending sections 2004 and 2005 (MCL 339.2004 and 339.2005), section 2004 as amended by 1988 PA 463 and section 2005 as amended by 1998 PA 90.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 2004. (1) In order to be licensed as an architect, an individual shall meet all of the following:
 - (a) The requirements prescribed in section 2005(1).
 - (b) Pass an examination which tests the applicant's qualifications to practice architecture or provide equivalent proof of qualification acceptable to the department and the board ${f OF}$

- 24 months after the date of the examination.

- 1 experience in professional surveying satisfactory to the board of
- 2 professional surveyors, including not more than 5 years of

- 4 (ii) Evidence of completion of a degree in professional
- 5 surveying or a related degree with professional surveying courses
- 6 acceptable to the board of professional surveyors.
- 7 (iii) Not less than 5 references, 3 of which shall be from
- 8 licensed professional surveyors who have personal knowledge of the
- 9 applicant's professional experience.
- 10 (4) The examination required by this article shall be given at
- 11 least once a year.
- 12 (5) An examinee shall be notified in writing of the examinee's
- 13 results on each part of the examination.
- 14 (6) Notwithstanding section 316(3), an individual with a
- 15 mental or physical disability may be tested using special
- 16 equipment, facilities, or assistance. However, the examination
- 17 shall not be varied in form, content, or the format in which
- 18 answers are submitted.
- 19 (7) All requirements for licensure shall be completed within
- 20 10 years after receipt of the application by the department. If the
- 21 requirements are not completed within the 10-year period, the
- 22 application shall be void.
