A bill to amend 1933 PA 167, entitled

"General sales tax act,"

by amending section 4x (MCL 205.54x), as amended by 2006 PA 17.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4x. (1) A sale to a domestic air carrier of 1 or more of
- 2 the following is exempt from the tax under this act:
- 3 (a) An aircraft that has a maximum certificated takeoff weight
- 4 of at least 6,000 pounds for use solely in the transport of air
- 5 cargo, passengers, or a combination of air cargo and passengers.
- 6 (b) Parts and materials, excluding shop equipment or fuel,
- 7 affixed or to be affixed to an aircraft that has a maximum
 - certificated takeoff weight of at least 6,000 pounds for use solely
 - in the transport of air cargo, passengers, or a combination of air

- 2 (2) The tax levied under this act does not apply to the sale
- 3 of parts or materials, excluding shop equipment or fuel, affixed or
- 4 to be affixed to an aircraft that meets all of the following

- 21 passengers, or a combination of air cargo and passengers as a
- 22 business activity.
- 23 (D) (c) "Prepurchase evaluation" means an examination of an
- 24 aircraft to provide a potential purchaser with information relevant
- 25 to the potential purchase.
- 26 (d) "Postsale customization" means any improvement,
- 27 maintenance, or repair that is performed on an aircraft following a

- 1 transfer of ownership of the aircraft.
- 2 (e) "Registered in this state" means an aircraft registered
- 3 with the state transportation department, bureau of aeronautics or
- 4 registered with the federal aviation administration to an address
- 5 located in this state.
