(MCL 333.1101 to 333.25211) by adding section 16280.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16280. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 2 BEGINNING JULY 1, 2010, A PRESCRIBER SHALL ELECTRONICALLY TRANSMIT
- 3 EVERY PRESCRIPTION FOR A PRESCRIPTION DRUG WRITTEN IN THIS STATE IN
- 4 A MANNER THAT COMPLIES WITH THE ELECTRONIC PRESCRIPTION DRUG
- 5 PROGRAM ESTABLISHED FOR PRESCRIBERS UNDER THE MEDICARE IMPROVEMENTS
