THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2515. (1) THE SECRETARY OF STATE SHALL CREATE, OPERATE,
- 2 AND MAINTAIN A STATEWIDE ADVANCE HEALTH CARE DIRECTIVE REGISTRY.
- 3 THE SECRETARY OF STATE, IN CONSULTATION WITH THE COMMISSION, SHALL
- 4 ESTABLISH THE TECHNOLOGY TO IMPLEMENT THE REGISTRY ON OR BEFORE
- 5 JANUARY 1, 2010.
- 6 (2) THE SECRETARY OF STATE SHALL ENSURE THE PRIVACY AND
- 7 SECURITY OF ANY DOCUMENT OR INFORMATION SUBMITTED TO, TRANSMITTED
 - FROM, OR STORED IN THE REGISTRY. THE SECRETARY OF STATE AND ANY

- 24 (i) A HEALTH PROFESSIONAL LICENSED, REGISTERED, OR OTHERWISE
- 25 AUTHORIZED TO ENGAGE IN A HEALTH PROFESSION UNDER ARTICLE 15.
- 26 (ii) A HEALTH FACILITY OR AGENCY LICENSED OR CERTIFIED UNDER
- 27 ARTICLE 17.
