## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 105C. (1) AT THE TIME AN ADULT APPLIES FOR OR RENEWS AN
- 2 APPLICATION FOR MEDICAL ASSISTANCE UNDER THIS ACT, THE DEPARTMENT
- 3 SHALL PROVIDE TO THAT ADULT APPLICANT WRITTEN INFORMATION REGARDING
- 4 THE STATEWIDE ADVANCE HEALTH CARE DIRECTIVE REGISTRY. THE WRITTEN
- 5 INFORMATION SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO, ALL OF THE
- 6 FOLLOWING:
- 7 (A) INFORMATION EXPLAINING ADVANCE HEALTH CARE DIRECTIVES AND
  - HOW THEY WORK, WHAT PURPOSE THE STATEWIDE ADVANCE HEALTH CARE
- 9 DIRECTIVE REGISTRY SERVES, AND THE OPTION FOR THE HOSPICE AND
- 10 PALLIATIVE CARE INFORMATION WITHIN THE STATEWIDE ADVANCE HEALTH
