May 19, 2009, Introduced by Reps. Donigan, Bauer, Kandrevas, Polidori, Gonzales, Geiss, Byrnes, Dean and Melton and referred to the Committee on Transportation.

A bill to amend 1951 PA 51, entitled

"An act to provide for the classification of all public roads, streets, and highways in this state, and for the revision of that classification and for additions to and deletions from each classification; to set up and establish the Michigan transportation fund; to provide for the deposits in the Michigan transportation fund of specific taxes on motor vehicles and motor vehicle fuels; to provide for the allocation of funds from the Michigan transportation fund and the use and administration of the fund for transportation purposes; to set up and establish the truck safety fund; to provide for the allocation of funds from the truck safety fund and administration of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of transportation needs within the state; to authorize the state transportation commission, counties, cities, and villages to borrow money, issue bonds, and make pledges of funds for transportation purposes; to authorize counties to advance funds for the payment of deficiencies necessary for the payment of bonds issued under this act; to provide for the limitations, payment, retirement, and security of the bonds and pledges; to provide for appropriations and tax levies by counties and townships for county roads; to authorize contributions by townships for county roads; to provide for the establishment and administration of the state trunk line fund, local bridge fund, comprehensive transportation fund, and certain other funds; to provide for the deposits in the state trunk line

fund, critical bridge fund, comprehensive transportation fund, and certain other funds of money raised by specific taxes and fees; to provide for definitions of public transportation functions and criteria; to define the purposes for which Michigan transportation funds may be allocated; to provide for Michigan transportation fund grants; to provide for review and approval of transportation programs; to provide for submission of annual legislative requests and reports; to provide for the establishment and functions of certain advisory entities; to provide for conditions for grants; to provide for the issuance of bonds and notes for transportation purposes; to provide for the powers and duties of certain state and local agencies and officials; to provide for the making of loans for transportation purposes by the state transportation department and for the receipt and repayment by local units and agencies of those loans from certain specified sources; and to repeal acts and parts of acts,"

by amending section 10e (MCL 247.660e), as amended by 2008 PA 487.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 10e. (1) The comprehensive transportation fund is
- 2 appropriated for each fiscal year in the following order of
- 3 priority.
- 4 (2) The first priority is to pay, but only from money
- 5 restricted as to use by section 9 of article IX of the state
- 6 constitution of 1963, the principal and interest on bonds or notes
- 7 issued under section 18b for comprehensive transportation purposes
- 8 as defined by law. A sufficient portion of the comprehensive
- 9 transportation fund is irrevocably appropriated to pay, when due,
- 10 the principal and interest on those bonds and notes.
- 11 (3) After making or setting aside payments required by
- 12 subsection (2), the second priority of the comprehensive
- 13 transportation fund is the payment of the department's cost in
- 14 administering the comprehensive transportation fund. The amount to
- 15 be expended pursuant to this subsection shall not exceed the costs
- 16 appropriated for the administration of the fund in the fiscal year
- 17 ending September 30, 1987, as adjusted annually on October 1, by

- 1 the change for the preceding 12 months in the Detroit consumer
- 2 price index for urban wage earners and shall be appropriated
- 3 annually by the legislature.
- 4 (4) After making or setting aside payments required by
- 5 subsections (2) and (3), the balance of the comprehensive
- 6 transportation fund shall be expended each fiscal year as
- 7 appropriated annually by the legislature pursuant to the state
- 8 transportation program approved by the commission as follows:
- 9 (a) The third priority shall be the payment of operating
- 10 grants to eligible authorities and eligible governmental agencies
- 11 according to the following formulations and subject to the
- 12 following requirements:
- (i) For the fiscal year ending September 30, 1998, and for each
- 14 fiscal year thereafter, each eligible authority and eligible
- 15 governmental agency which provides public transportation services
- in urbanized areas under 49 USC 5307, with a Michigan population
- 17 greater than 100,000 shall receive a grant of up to 50% of their
- 18 eligible operating expenses as defined by the state transportation
- 19 department.
- 20 (ii) For the fiscal year ending September 30, 1998, and each
- 21 fiscal year thereafter, each eligible authority and eligible
- 22 governmental agency which provides public transportation services
- 23 in urbanized areas with a Michigan population less than or equal to
- 24 100,000 and nonurbanized areas under 49 USC 5311, shall receive a
- 25 grant of up to 60% of their eligible operating expenses as defined
- 26 by the state transportation department. For purposes of receiving a
- 27 grant under this subparagraph in nonurbanized areas, eligible costs

- 1 of services provided by water vehicle shall be reimbursed at not
- 2 less than 50% of the portion of the costs not eligible for
- 3 reimbursement by the federal government.
- 4 (iii) Funds shall not be distributed to an eligible authority or
- 5 eligible governmental agency under this act unless the eligible
- 6 authority or eligible governmental agency provides or agrees to
- 7 provide preferential fares for public transportation services to
- 8 persons 65 years of age or over or persons with disabilities riding
- 9 in off peak periods of service. As used in this section, "person
- 10 with disabilities" means an individual with a disability as that
- 11 term is defined in 61 FRP 56424 (November 1, 1996) and 49 CFR part
- 12 27. The preferential fares shall not be higher than 50% of the
- 13 regular 1-way single fare.
- 14 (iv) Eligible authorities and eligible governmental agencies
- 15 shall not engage in charter service using vehicles, facilities, or
- 16 equipment funded under this act except on an incidental basis as
- 17 defined by 49 CFR part 604.
- 18 (v) Notwithstanding any other provision of this subsection,
- 19 for the fiscal year ending September 30, 1998, each eligible
- 20 authority and eligible governmental agency shall receive a
- 21 distribution from the comprehensive transportation fund not less
- 22 than the distribution received for eligible operating expenses for
- 23 the fiscal year ending September 30, 1997. Beginning with the
- 24 fiscal year ending September 30, 1998 and each fiscal year
- 25 thereafter, each eligible authority and eligible governmental
- 26 agency shall receive a distribution from the comprehensive

- 14 made on forms authorized by the United States department of
- 15 transportation under the provisions of the surface transportation
- 16 and uniform relocation assistance act of 1987, Public Law 100-17,
- **17** 101 Stat. 132.
- 18 (vii) The department shall periodically adjust or redistribute
- 19 comprehensive transportation funds previously distributed under
- 20 this subdivision.
- 21 (b) For the fiscal year ending September 30, 1997, and each
- 22 fiscal year thereafter, not less than 10% shall be distributed by
- 23 the department for intercity passenger and intercity freight
- 24 transportation purposes.
- (c) For the fiscal year ending September 30, 1997, and each
- 26 fiscal year thereafter, funds remaining in the fund after payment
- 27 of the amounts required by subdivisions (a) and (b) shall be

- 1 distributed by the department for public transportation purposes.
- 2 For the fiscal year ending September 30, 1998, and each fiscal year
- 3 thereafter, funds shall be made available to match all projects for
- 4 eligible authorities and eligible governmental agencies that are
- 5 approved for federal funding as provided by federal law and for
- 6 which an approved transportation improvement program (TIP) and
- 7 state transportation improvement plan (STIP) exist. Funds
- 8 distributed under this subdivision shall be expended pursuant to
- 9 specific line item appropriation for, but are not limited to, the
- 10 following public transportation purposes:
- 11 (i) The specialized services assistance program. The
- 12 specialized services assistance program shall be funded with not
- 13 less than \$3,600,100.00 from funds distributed under this
- 14 subdivision. Funds shall be distributed according to guidelines
- 15 developed by the department based upon the following
- 16 considerations:
- 17 (A) Proposals for coordinated specialized services assistance
- 18 funding shall be developed jointly between existing eligible
- 19 authorities or eligible governmental agencies that provide public
- 20 transportation services and the area agencies on aging or any other
- 21 organization representing specialized services interests, as
- 22 defined in this subdivision. Plans shall be reviewed and approved
- 23 by the bureau of urban and public transportation of the department.
- 24 Upon approval, the department shall release the funds to the
- 25 eligible authority or eligible governmental agency which shall then
- 26 allocate the funds to the area agency on aging or any other
- 27 organization representing specialized services interests, as

- 1 defined in this subdivision for the purchase of services as
- 2 approved in the plan by the department.
- 3 (B) If an eligible authority or eligible governmental agency
- 4 does not exist to provide public transportation service in a
- 5 county, coordinated proposals for specialized services assistance
- 6 funding may be submitted by the area agency on aging or any other
- 7 organization representing specialized services interests, as
- 8 defined in this subdivision. The proposals shall be reviewed and
- 9 approved by the bureau of urban and public transportation of the
- 10 department. Upon approval, the department shall release the funds
- 11 to the area agency on aging or any other organization representing
- 12 specialized services interests, as defined in this subdivision for
- 13 the purchase of services as approved in the plan by the department.
- 14 (C) For the purposes of this program, "specialized services"
- 15 means public transportation primarily designed for persons with
- 16 disabilities or persons who are 65 years of age or older.
- 17 (ii) Local bus capital. For the fiscal year ending September
- 18 30, 1998 and each fiscal year thereafter, not less than
- 19 \$8,000,000.00 will be distributed for either matching federal funds
- 20 for local bus capital or 100% capital projects for eligible
- 21 authorities and eligible governmental agencies that are not
- 22 eligible to receive federal capital formula funds under section
- 23 5307 of the federal intermodal surface transportation efficiency
- 24 act, Public Law 102-240, or any successor act.
- 25 (iii) Local bus new services UP TO \$50,000,000.00 EACH FISCAL
- 26 YEAR FOR THE NEW TRANSIT SERVICES PROGRAM DESCRIBED IN SUBSECTION

27 (15).

- $\mathbf{1}$ (iv) Not less than \$2,000,000.00 in each fiscal year for the
- ${f 2}$ credit program established under section 10l.
- 3 (v) Public transportation development.
- $\mathbf{4}$ (vi) Other public transportation programs approved by the
- 5 commission.
- 6 (d) The unappropriated and unencumbered balance of the
- 7 comprehensive transportation fund lapses at the end of each fiscal
- 8 year and reverts to the comprehensive transportation fund for
- 9 appropriation in the following fiscal year.
- 10 (5) Eliqible authorities and eliqible governmental agencies
- 11 shall receive capital grants each fiscal year by the annual process
- 12 described in this section. Amounts received by an eligible
- 13 authority or eligible governmental agency pursuant to this
- 14 subsection shall be expended by that authority or agency solely for
- 15 capital projects which have been approved by the state
- 16 transportation commission. Any funds approved by distribution to an
- 17 eligible authority or eligible governmental agency pursuant to this
- 18 section which have not been encumbered by that agency or authority
- 19 for an approved capital project by the end of the following fiscal
- 20 year in which the funds were approved shall not be expended by the
- 21 authority or agency and be available for distribution from the

- 24 (6) The department, in carrying out the policy of the state
- 25 transportation commission, shall annually prepare and distribute by

- 1 preparation of a local transportation program. Eligible
- 2 governmental agencies, eligible authorities, and intercity carriers
- 3 shall give public notice of their intent to apply for money in the
- 4 comprehensive transportation fund to the residents of the counties,
- 5 townships, villages, and cities affected by the local
- 6 transportation program and shall make their application available
- 7 for a period of 30 days. All comments received by the eligible

- 3 (8) On or before March 1 of each year, the department shall
- 4 prepare and file for public inspection and review the department
- 5 transportation program. The department transportation program shall
- 6 be prepared on similar format to the local transportation programs,
- 7 and shall include a summary description of projects, with funding
- 8 sources and project justifications for each line item for the
- 9 fiscal year immediately succeeding the fiscal year in which the
- 10 program is submitted. In addition, the department transportation
- 11 program shall include summary, nondetailed budget and project
- 12 descriptions and justifications excluding projects contained in a
- 13 local transportation program.
- 14 (9) On or before April 1 of each year, the department shall
- 15 prepare and file with the commission the proposed state
- 16 transportation program for the next succeeding fiscal year. The
- 17 proposed state transportation program shall contain the local
- 18 transportation programs of each intercity carrier, eligible
- 19 authority and eligible governmental agency, the department
- 20 transportation program, and the programs for the expenditure of the
- 21 state trunk line fund as they may have been supplemented, amended,
- or modified since their original filing. The state transportation
- 23 program shall include the estimated amount of money in the funds
- 24 described in this subsection by revenue source, project
- 25 justifications, project descriptions funding sources, and budget
- 26 summaries.
- 27 (10) On or before May 1 of each year, the state transportation

- 1 commission shall act on the state transportation program for the
- 2 fiscal year commencing on the following October 1. In considering
- 3 approval of the proposed projects of each intercity carrier,
- 4 eligible authority, or eligible governmental agency, other than
- 5 projects which are to be funded pursuant to subsection (5), the
- 6 state transportation commission shall consider whether the projects
- 7 comply with state law, are within funds allocated in this section,
- 8 whether they may be funded within the approved budgets, whether
- 9 there are intercity carriers, eligible authorities, and eligible
- 10 governmental agencies responsible to implement the projects, and

- 20 eligible authority, or eligible governmental agency from the
- 21 comprehensive transportation fund.
- 22 (12) After a multiyear public transportation program is
- 23 approved by the state transportation commission, the state
- 24 transportation department may enter into a grant-in-aid instrument
- 25 with an eligible authority, intercity carrier, or eligible
- 26 governmental agency obligating the state to a minimum level of
- 27 funding for approved projects to be available over the multiyear

- 1 period of the program. This obligation shall be binding upon the
- 2 state transportation department as long as the provisions and
- 3 conditions of the state transportation commission approved program
- 4 are carried out as agreed.
- 5 (13) Contracts and grant memorandum agreements may be audited
- 6 by the state transportation commission's office of commission
- 7 audits using rules promulgated by the United States general
- 8 accounting office and the terms and conditions of the respective
- 9 contracts and agreements. Third party agreements are subject to the
- 10 review and approval of the department.
- 11 (14) Funds distributed by the department may pay 100% of the
- 12 portion of the cost not eligible for reimbursement by the federal
- 13 government for eligible capital projects authorized by the state
- 14 transportation commission using comprehensive transportation funds
- 15 or the proceeds of notes and bonds issued under section 18b.
- 16 Priority for funding obligation shall be given to capital projects
- 17 for which federal funds have been authorized.
- 18 (15) All approved local bus new services initiated by eligible
- 19 authorities and eligible governmental agencies not in their fourth
- 20 year or beyond of funding on October 1, 1988, shall be funded from
- 21 subsection (4)(c)(iii). Local bus new services shall be funded under
- 22 subsection (4) (c) (iii) in the following percentages of eligible
- 23 operating expenses as determined by the department:
- 24 (a) Startup 100%.
- 25 (b) First year 90%.
- 26 (c) Second year 80%.
- 27 (d) Third year 70%.

- 1 (e) Fourth year and each year thereafter, as determined by and
- 2 from funds provided under subsection (4)(a). The balance of
- 3 eligible operating expenses shall be met from local revenue sources
- 4 including farebox. The department shall pay up to 100% of eligible
- 5 capital expenses during the startup and first 3 years of service,
- 6 after the third year, the department shall participate in eligible
- 7 capital expenses in the same percentage as for other eligible
- 8 authorities and eligible governmental agencies. For the purposes of
- 9 this subsection, eligible operating and capital expenses means
- 10 those expenses determined by the department as applicable to
- 11 existing eligible authorities and eligible governmental agencies.
- 12 The department shall prioritize annually all requests for
- 13 comprehensive transportation funds to institute new services under
- 14 this subsection. First priority shall be given to eligible
- 15 authorities and eligible governmental agencies who have not
- 16 completed their first 3 years of service by October 1, 1998. New
- 17 services initiated by eligible authorities and eligible
- 18 governmental agencies under this subsection shall meet all of the
- 19 requirements of section 10. THE NEW TRANSIT SERVICES PROGRAM SHALL
- 20 BE FUNDED FROM SUBSECTION (4) (C) (iii). FUNDS SHALL BE EXPENDED OR
- 21 DISTRIBUTED FOR PROJECTS AS DETERMINED ANNUALLY BY THE DEPARTMENT
- 22 SUBJECT TO ALL OF THE FOLLOWING CONDITIONS:
- 23 (A) PROJECTS SHALL PROVIDE NEW TRANSIT SERVICE IN, TO, OR
- 24 BETWEEN URBAN AREAS IN THIS STATE AND SHALL SERVE MAJOR
- 25 CONCENTRATIONS OF TRIP ORIGINS AND DESTINATIONS.
- 26 (B) FUNDS UNDER SUBSECTION (4) (C) (iii) MAY BE DIRECT
- 27 EXPENDITURES, LOANS, GRANTS, OR GUARANTEES OF PAYMENTS UNDER LEASES

- 1 OR CONTRACTS WITH PUBLIC AND PRIVATE CORPORATIONS, ELIGIBLE
- 2 AGENCIES, ELIGIBLE AUTHORITIES, OR OTHER TRANSPORTATION PROVIDERS.
- 3 (C) FUNDS UNDER SUBSECTION (4) (C) (iii) MAY BE DISTRIBUTED FOR
- 4 ELIGIBLE OPERATING AND CAPITAL EXPENSES.
- 5 (D) FUNDS UNDER SUBSECTION (4) (C) (iii) MAY PROVIDE UP TO 100% OF
- 6 PROJECT COST OR MAY MATCH FEDERAL AID OR GRANTS UNDER ANY FEDERAL
- 7 PROGRAM.
- 8 (E) THE DEPARTMENT SHALL ANNUALLY DETERMINE ALL EXPENDITURES
- 9 AND DISTRIBUTIONS FOR NEW TRANSIT SERVICES UNDER THIS SUBSECTION,
- 10 AND MAY PREPARE A LIST OF ALL ELIGIBLE REQUESTS FOR FUNDS UNDER
- 11 THIS SUBSECTION RANKED IN ORDER OF PRIORITY.
- 12 (F) NEW TRANSIT SERVICES FUNDED UNDER THIS SUBSECTION SHALL
- 13 MEET ALL OF THE REQUIREMENTS OF SECTION 10.
- 14 (G) AS USED IN THIS SUBSECTION:
- 15 (i) "ELIGIBLE OPERATING OR CAPITAL EXPENSES" MEANS THOSE
- 16 EXPENSES AS DETERMINED BY THE DEPARTMENT. FARES, STATE, LOCAL, OR
- 17 FEDERAL AID, GRANTS, AND OTHER REVENUE SHALL BE DEDUCTED FROM
- 18 ELIGIBLE OPERATING AND CAPITAL EXPENSES.
- 19 (ii) "MICHIGAN URBAN AREAS" MEANS URBANIZED AREAS AS DESIGNATED
- 20 BY THE UNITED STATES OFFICE OF MANAGEMENT AND BUDGET FOLLOWING THE
- 21 MOST RECENT UNITED STATES CENSUS.
- 22 (iii) "NEW TRANSIT SERVICE" MEANS SERVICE THAT STARTS AFTER THE
- 23 EFFECTIVE DATE OF THE 2009 ACT THAT AMENDED THIS SUBSECTION.
- 24 (iv) "TRANSIT SERVICE" MEANS EXPRESS BUS, COMMUTER BUS, BUS
- 25 RAPID TRANSIT, LIGHT-RAIL TRANSIT, STREET RAILWAY, COMMUTER RAIL
- 26 SERVICE, AND NEW FEEDER BUS SERVICE IN SUPPORT OF NEW TRANSIT
- 27 SERVICES, OR OTHER SERVICE AS DETERMINED BY THE DEPARTMENT.

- 1 (16) The department shall pay up to 80% of the portion of the
- 2 cost not eligible for reimbursement by the federal government for
- 3 intercity passenger operating assistance projects authorized by the
- 4 commission for the first 2 years of new services. For the third
- 5 year, eligible costs shall be reimbursed at up to 60% of the
- 6 portion of the cost not eligible for reimbursement by the federal
- 7 government. After the third year, eligible costs shall be
- 8 reimbursed at up to 50% of the portion of the cost not eligible for
- 9 reimbursement by the federal government. Eligible costs of services
- 10 provided as of September 30, 1981, shall be reimbursed at up to 50%
- 11 of the portion of the cost not eligible for reimbursement by the
- 12 federal government. However, the amount of funds from the
- 13 comprehensive transportation fund when added to federal funds and
- 14 local funds shall not exceed the total operating assistance project
- **15** cost.
- 16 (17) A vehicle purchased, leased, or rented after November 15,
- 17 1976, by an eligible authority or eligible governmental agency with
- 18 funds made available under this act, which funds were not already
- 19 committed under a contract in existence on November 15, 1976, shall
- 20 not be used to provide service on a fixed schedule and fixed route
- 21 for which a passenger fee is charged unless the vehicle is
- 22 accessible to a person using a wheelchair from a roadway level or
- 23 curb level, and has accommodations in which 1 or more wheelchairs
- 24 can be secured.
- 25 (18) A vehicle shall not be purchased, leased, or rented by an
- 26 eligible authority or eligible governmental agency after October 1,
- 27 1978, with funds made available under this act which vehicle is

- 1 used to provide demand actuated service unless the eligible
- 2 authority or eligible governmental agency has submitted a plan to
- 3 the state transportation department describing the service to be
- 4 provided by the demand actuated service to persons 65 years of age
- 5 or older and persons with disabilities within the applicable
- 6 service area and that plan has been approved by the department. The
- 7 department shall approve the plan as submitted or modified or shall
- 8 reject the plan within 60 days after the plan is submitted. A plan
- 9 which describes the service to be provided by the demand actuated
- 10 service shall not be approved by the department unless that plan
- 11 provides the following:
- 12 (a) That demand actuated service will be provided to persons
- 13 65 years of age or older and persons with disabilities residing in
- 14 the entire service area subject to the plan.
- 15 (b) That as a minimum, demand actuated service will be
- 16 provided to persons 65 years of age or older and persons with
- 17 disabilities during the same hours as service is provided to all
- 18 other persons in the service area subject to the plan.
- 19 (c) That the average time period required for demand actuated
- 20 service to persons 65 years of age or older and persons with
- 21 disabilities from the initiation of a service request to arrival at
- 22 the destination is equal to the average time period required for

- 25 (d) That the eligible authority or eligible governmental
- 26 agency submitting the plan has established a local advisory council
- 27 with not less than 50% of its membership representing persons 65

- 1 years of age or older and persons with disabilities within the
- 2 service area subject to the plan and that the local advisory
- 3 council has had an opportunity to review and comment upon the plan
- 4 before its submission to the department. Each eligible authority or
