- 13 TO THESE RULES. IN EACH CASE BROUGHT UNDER SECTION 8905A, WHICHEVER
- 14 OFFICE PROSECUTED THE ACTION SHALL DETERMINE WHETHER THE
- 15 INFORMATION MATERIALLY CONTRIBUTED TO THE IMPOSITION OF A CIVIL

- 17 (6) THE DEPARTMENT SHALL PERIODICALLY PUBLICIZE THE
- 18 AVAILABILITY OF THE REWARDS UNDER THIS SECTION.
- 19 (7) A CLAIM FOR A REWARD UNDER THIS SECTION MAY BE SUBMITTED
- 20 ONLY FOR INFORMATION PROVIDED ON OR AFTER THE EFFECTIVE DATE OF

- 22 SEC. 8905E. (1) THE ILLEGAL DUMPING REWARD FUND IS CREATED

- 24 (2) FIFTY PERCENT OF ALL CIVIL FINES COLLECTED UNDER SECTION
- 25 8905A SHALL BE DEPOSITED INTO THE FUND. THE STATE TREASURER MAY
