## **HOUSE BILL No. 5205**

July 16, 2009, Introduced by Rep. Robert Jones and referred to the Committee on Commerce.

A bill to authorize the state administrative board to convey certain interests in property in Kalamazoo county; to prescribe certain conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. The state administrative board, on behalf of the state, may convey to western Michigan university, for consideration of \$1.00, the right of reverter and the right of reentry contained in the July 22, 1989, quitclaim deed to western Michigan university recorded in Liber 2083 page 1264, Kalamazoo county records, on real property located in Kalamazoo county, Michigan, and more particularly described as:

The north half of lot thirty-six (36) of plat no. two (2) or revised plat of section sixteen (16), town two (2) south, range

- 2 north half, thence north twenty-six and two-thirds (26 2/3) rods,
- 3 thence east eighteen (18) rods, thence south twenty-six and two-

- 5 place of beginning, and also except commencing two (2) rods south
- 6 of a point two (2) rods west of the northeast corner of said lot

- 9 (8) rods, thence east twenty (20) rods, and thence north twenty

- 13 being one hundred thirty-two (132) feet west of the west line of
- 14 Denner Street and five hundred twenty-eight (528) feet north of the
- east and west quarter line of section sixteen (16), town two (2)
- 16 south, range eleven (11) west, running thence north on hundred
- 17 thirty-two (132) feet, thence west five hundred two and six tenths
- 18 (502.6) feet, thence south one hundred thirty-two (132) feet to a
- 19 point on the north line of North Street six hundred thirty-four and
- 20 seventy-three hundredths (634.73) feet west of the west line of
- 21 Denner Street, thence east on the north line of North Street five
- 22 hundred two and seventy-three hundredths (502.73) feet to the place
- 23 of beginning.
- 24 Sec. 2. The description of the parcel in section 1 is
- 25 approximate and for purposes of the conveyance is subject to
- 26 adjustment as the state administrative board or attorney general
- 27 considers necessary by survey or other legal description.

- 1 Sec. 3. The conveyance authorized by this act shall be by
- 2 instrument approved by the attorney general.
- 3 Sec. 4. The revenue received under this act shall be deposited
- 4 in the state treasury and credited to the general fund.
- 5 Enacting section 1. This act does not take effect unless all
- 6 of the following bills of the 95th Legislature are enacted into
- 7 law:
