HOUSE BILL No. 5256

August 19, 2009, Introduced by Reps. Meltzer, Rick Jones, Calley, Hansen, Bolger, Schuitmaker, DeShazor, Tyler and Haines and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803e (MCL 257.803e), as amended by 2003 PA 30.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 803e. (1) A person who has been a prisoner of war or a person whose spouse has been a prisoner of war may make application to the secretary of state for a special registration plate which

THAT shall be inscribed with special identification numbers preceded by the letters "EX-POW" and shall have the words "exprisoner of war" inscribed beneath the registration number.

(2) A person who was a member of the armed services during World War I may make application to the secretary of state for a special registration plate , which THAT shall be inscribed with

- 2 shall have the words "World War I veteran" inscribed beneath the
- 3 registration number.
- 4 (3) A person who was a member of the armed services during
- 5 1941, stationed at a United States military or naval establishment
- 6 at Pearl Harbor in the Hawaiian islands, and who survived the
- 7 attack by Japan on Pearl Harbor on December 7, 1941 may make
- 8 application to the secretary of state for a special registration
- 9 plate , which THAT shall be inscribed with special identification
- 10 numbers and shall have the words "Pearl Harbor survivor" inscribed
- 11 beneath the registration number.
- 12 (4) A person who is a recipient of the purple heart medal may
- 13 make application to the secretary of state for a special
- 14 registration plate which THAT shall be inscribed with special
- 15 identification numbers and shall have the words "combat wounded
- 16 veteran" inscribed beneath the registration number. In addition,
- 17 the special registration plate described under this subsection
- 18 shall be inscribed with a vignette of the official purple heart
- 19 medal.
- 20 (5) Application for a special registration plate shall be on a
- 21 form prescribed by the secretary of state, and shall be accompanied
- 22 by any proof of the applicant having been a prisoner of war, World
- 23 War I veteran, Pearl Harbor survivor, or recipient of the purple
- 24 heart medal that the secretary of state may require. The
- 25 application for a special registration plate shall also be
- 26 accompanied with payment of a \$5.00 service fee.
- 27 (6) Upon proper application and payment of the \$5.00 service

- 1 fee, the secretary of state shall issue 1 or more special
- 2 registration plates for each applicant for use on a passenger
- 3 vehicle. A person who is disabled who makes application for a
- 4 special registration plate under this section and who makes payment
- 5 of the \$5.00 service fee shall be issued a tab for persons with
- 6 disabilities as provided in section 803f for his or her special
- 7 registration plate. The secretary of state shall require the same
- 8 proof that the applicant is a disabled person as is required for
- 9 issuance of a permanent windshield placard under section 675. One
- 10 person in any household is entitled to 1 special registration plate
- 11 issued under subsection SUBSECTIONS (1) AND (4) that is exempt from
- 12 payment of the tax provided in section 801. The person who is
- 13 issued an additional special registration plate under subsection
- 14 (1) OR (4) shall be assessed the applicable tax provided for in
- 15 section 801. A person issued 1 or more special registration plates
- 16 under subsection SUBSECTIONS (2) AND (3) or (4) shall be
- 17 assessed the applicable tax provided in section 801.
- 18 (7) The use of a special registration plate on a vehicle other
- 19 than the vehicle for which the plate is issued, or by a person who
- 20 does not qualify under this section, is a misdemeanor.
- 21 (8) The special registration plate issued under this section
- 22 expires on the birthday of the vehicle owner in a year in which new
- 23 plates are issued by the secretary of state. Application for
- 24 renewal of the special registration plate shall be accompanied by a
- 25 \$5.00 service fee. The applicant is not required to furnish the
- 26 proof provided in subsection (5).
