A bill to amend 1963 PA 42, entitled

"An act to provide for the termination of dormant oil and gas interests in land owned by persons other than the owners of the surface and for the vesting of title to same in the surface owners in the absence of the filing of a notice of claim of interest within a specified period of time,"

by amending section 1 (MCL 554.291), as amended by 2006 PA 519.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) Any interest in oil or gas in any land owned by
- 2 any person other than the owner of the surface, which has not been
- 3 sold, leased, mortgaged, or transferred by instrument recorded in
- 4 the register of deeds office for the county where that interest in
- 5 oil or gas is located for a period of 20 years shall, in the
- absence of the issuance of a permit to drill an oil or gas well
- issued by the department of environmental quality NATURAL

- 1 RESOURCES, or its predecessor or successor, as to that interest in
- 2 oil or gas or the actual production or withdrawal of oil or gas
