A bill to amend 1990 PA 72, entitled "Local government fiscal responsibility act," (MCL 141.1201 to 141.1291) by adding section 45.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 45. (1) THE JOINT COMMITTEE ON FINANCIAL MANAGER
- 2 OVERSIGHT IS CREATED AND CONSISTS OF 5 MEMBERS OF THE SENATE AND 5
- 3 MEMBERS OF THE HOUSE OF REPRESENTATIVES. ALL OF THE FOLLOWING APPLY
- 4 TO THE MEMBERSHIP OF THE COMMITTEE:
- 5 (A) EXCEPT AS OTHERWISE PROVIDED IN SUBDIVISION (C), THE
- 6 MEMBERS SHALL BE APPOINTED IN THE SAME MANNER AS STANDING
 - COMMITTEES ARE APPOINTED FOR TERMS OF 2 YEARS.
- 8 (B) OF THE 5 MEMBERS APPOINTED FROM EACH HOUSE, 3 SHALL BE
- FROM THE MAJORITY PARTY AND 2 SHALL BE FROM THE MINORITY PARTY.

- 1 (C) THE CHAIRPERSONS AND VICE-CHAIRPERSONS OF THE STANDING
- 2 COMMITTEES ON EDUCATION OF EACH HOUSE SHALL SERVE AS MEMBERS OF THE
- 3 COMMITTEE.
- 4 (D) THE CHAIRPERSON OF THE COMMITTEE SHALL ALTERNATE BETWEEN
- 5 HOUSES EACH YEAR.
- 6 (E) MEMBERS OF THE COMMITTEE SHALL SERVE WITHOUT COMPENSATION
- 7 BUT SHALL BE REIMBURSED FOR EXPENSES INCURRED IN THE BUSINESS OF

- 14 BETWEEN SESSIONS. THE COMMITTEE MAY HOLD HEARINGS AND TAKE
- 15 TESTIMONY ON ANY MATTER RELATED TO THE ACTIVITIES OF AN EMERGENCY
- 16 FINANCIAL MANAGER APPOINTED FOR A SCHOOL DISTRICT UNDER THIS
- 17 ARTICLE. THE COMMITTEE MAY MAKE RECOMMENDATIONS TO THE LEGISLATURE
- 18 ON LEGISLATION INTENDED TO FURTHER THE PURPOSES OF THIS ACT. AN
- 19 ACTION BY THE COMMITTEE SHALL BE BY CONCURRING MAJORITIES OF THE
- 20 MEMBERS FROM EACH HOUSE. THE COMMITTEE SHALL REPORT ITS ACTIVITIES
- 21 AND RECOMMENDATIONS TO THE LEGISLATURE AT EACH REGULAR SESSION.
- 22 (3) THE COMMITTEE MAY HIRE STAFF TO ASSIST THE COMMITTEE UNDER
- 23 THIS SECTION. HOWEVER, THE SUPERVISION OF STAFF, BUDGETING,
- 24 PROCUREMENT, AND RELATED FUNCTIONS OF THE COMMITTEE SHALL BE
- 25 PERFORMED BY THE COUNCIL ADMINISTRATOR APPOINTED UNDER THE
- 26 LEGISLATIVE COUNCIL ACT, 1986 PA 268, MCL 4.1101 TO 4.1901.
