THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 22225A. (1) IN ORDER TO OBTAIN A CERTIFICATE OF NEED

- 2 UNDER THIS PART, AN APPLICANT FOR A CERTIFICATE OF NEED TO ACQUIRE
- 3 OR BEGIN OPERATION OF A NURSING HOME OR TO MAKE A CHANGE IN BED

- 5 TO THE PEOPLE OF THE STATE OF MICHIGAN. THIS SECTION DOES NOT APPLY
- 6 TO A NURSING HOME THAT IS A COUNTY MEDICAL CARE FACILITY. EXCEPT AS
- 7 OTHERWISE PROVIDED IN THIS SUBSECTION, THE AMOUNT OF THE SURETY
 - BOND SHALL EQUAL OR EXCEED THE TOTAL COST TO ACQUIRE OR BEGIN

- 1 OPERATION OF A NURSING HOME OR TO MAKE THE CHANGE IN BED CAPACITY
