- 1 SEC. 20154. (1) BEGINNING JULY 1, 2011, A HEALTH CARE PROVIDER
- 2 THAT SUBMITS A HEALTH CARE CLAIM TO A CARRIER FOR COVERED HEALTH
- 3 CARE SERVICES, EITHER DIRECTLY OR THROUGH A CLEARINGHOUSE, BILLING
- 4 SERVICE, OR ANY OTHER VENDOR THAT CONTRACTS WITH A HEALTH CARE
- 5 PROVIDER TO DELIVER HEALTH CARE CLAIMS TO A CARRIER ON THE
- 6 PROVIDER'S BEHALF, SHALL SUBMIT HEALTH CARE CLAIMS IN ELECTRONIC
- 7 DATA FORMAT TO THE CARRIER. UPON REQUEST, THE DIRECTOR MAY EXEMPT A
