THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 20114E. (1) THE DIRECTOR SHALL ESTABLISH A RESPONSE
- 2 ACTIVITY REVIEW PANEL TO ADVISE HIM OR HER ON TECHNICAL OR
- 3 SCIENTIFIC DISPUTES, INCLUDING DISPUTES REGARDING ASSESSMENT OF
- 4 RISK, CONCERNING RESPONSE ACTIVITY PLANS AND NO FURTHER ACTION
- 5 REPORTS.
- 6 (2) THE PANEL SHALL CONSIST OF 15 INDIVIDUALS, APPOINTED BY
- 7 THE DIRECTOR. EACH MEMBER OF THE PANEL SHALL MEET ALL OF THE
- 8 FOLLOWING MINIMUM REQUIREMENTS:
 - (A) MEET 1 OR MORE OF THE FOLLOWING:

- 1 (i) HOLD A CURRENT PROFESSIONAL ENGINEER'S OR PROFESSIONAL
- 2 GEOLOGIST'S LICENSE OR REGISTRATION FROM A STATE, TRIBE, OR UNITED
- 3 STATES TERRITORY, OR THE COMMONWEALTH OF PUERTO RICO, AND HAVE THE
- 4 EQUIVALENT OF 6 YEARS OF FULL-TIME RELEVANT EXPERIENCE.
- 5 (ii) HAVE A BACCALAUREATE DEGREE FROM AN ACCREDITED INSTITUTION
- 6 OF HIGHER EDUCATION IN A DISCIPLINE OF ENGINEERING OR SCIENCE AND
- 7 THE EQUIVALENT OF 10 YEARS OF FULL-TIME RELEVANT EXPERIENCE.
- 8 (iii) HAVE A MASTER'S DEGREE FROM AN ACCREDITED INSTITUTION OF
- 9 HIGHER EDUCATION IN A DISCIPLINE OF ENGINEERING OR SCIENCE AND THE
- 10 EQUIVALENT OF 8 YEARS OF FULL-TIME RELEVANT EXPERIENCE.
- 11 (B) REMAIN CURRENT IN HIS OR HER FIELD THROUGH PARTICIPATION
- 12 IN CONTINUING EDUCATION OR OTHER ACTIVITIES.
- 13 (3) AN INDIVIDUAL IS NOT ELIGIBLE TO BE A MEMBER OF THE PANEL
- 14 IF ANY 1 OF THE FOLLOWING IS TRUE:
- 15 (A) THE INDIVIDUAL IS A CURRENT EMPLOYEE OF ANY OFFICE,
- 16 DEPARTMENT, OR AGENCY OF THE STATE.
- 17 (B) THE INDIVIDUAL IS A PARTY TO 1 OR MORE CONTRACTS WITH THE
- 18 DEPARTMENT AND THE COMPENSATION PAID UNDER THOSE CONTRACTS
- 19 REPRESENTED MORE THAN 5% OF THE INDIVIDUAL'S ANNUAL GROSS REVENUE
- 20 IN ANY OF THE PRECEDING 3 YEARS.
- 21 (C) THE INDIVIDUAL IS EMPLOYED BY AN ENTITY THAT IS A PARTY TO
- 22 1 OR MORE CONTRACTS WITH THE DEPARTMENT AND THE COMPENSATION PAID
- 23 TO THE INDIVIDUAL'S EMPLOYER UNDER THESE CONTRACTS REPRESENTED MORE
- 24 THAN 5% OF THE EMPLOYER'S ANNUAL GROSS REVENUE IN ANY OF THE
- 25 PRECEDING 3 YEARS.
- 26 (D) THE INDIVIDUAL WAS EMPLOYED BY THE DEPARTMENT WITHIN THE
- 27 PRECEDING 3 YEARS.

- 1 (4) AN INDIVIDUAL APPOINTED TO THE PANEL SHALL SERVE FOR A
- 2 TERM OF 3 YEARS AND MAY BE REAPPOINTED FOR 1 ADDITIONAL 3-YEAR
- 3 TERM. AFTER SERVING 2 CONSECUTIVE TERMS, THE INDIVIDUAL MAY NOT BE
- 4 A MEMBER OF THE PANEL FOR A PERIOD OF AT LEAST 2 YEARS BEFORE BEING
- 5 ELIGIBLE TO BE APPOINTED TO THE PANEL AGAIN. THE TERMS FOR MEMBERS
- 6 FIRST APPOINTED SHALL BE STAGGERED SO THAT NOT MORE THAN 5
- 7 VACANCIES ARE SCHEDULED TO OCCUR IN A SINGLE YEAR. INDIVIDUALS
- 8 APPOINTED TO THE PANEL SHALL SERVE WITHOUT COMPENSATION. HOWEVER,
- 9 MEMBERS OF THE PANEL MAY BE REIMBURSED FOR THEIR ACTUAL AND
- 10 NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR OFFICIAL
- 11 DUTIES AS MEMBERS OF THE PANEL.
- 12 (5) A VACANCY ON THE PANEL SHALL BE FILLED IN THE SAME MANNER
- 13 AS THE ORIGINAL APPOINTMENT.
- 14 (6) THE BUSINESS THAT THE PANEL MAY PERFORM SHALL BE CONDUCTED
- 15 AT A PUBLIC MEETING OF THE PANEL HELD IN COMPLIANCE WITH THE OPEN
- 16 MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 17 (7) A PERSON WHO SUBMITTED A RESPONSE ACTIVITY PLAN OR A NO
- 18 FURTHER ACTION REPORT MAY APPEAL A DECISION MADE BY THE DEPARTMENT
- 19 REGARDING A TECHNICAL OR SCIENTIFIC DISPUTE, INCLUDING A DISPUTE
- 20 REGARDING ASSESSMENT OF RISK, CONCERNING THE RESPONSE ACTIVITY PLAN
- 21 OR NO FURTHER ACTION REPORT BY SUBMITTING A PETITION TO THE
- 22 DIRECTOR. THE PETITION SHALL INCLUDE THE ISSUES IN DISPUTE, THE
- 23 RELEVANT FACTS UPON WHICH THE DISPUTE IS BASED, FACTUAL DATA,
- 24 ANALYSIS, OPINION, AND SUPPORTING DOCUMENTATION FOR THE
- 25 PETITIONER'S POSITION. THE PETITIONER SHALL ALSO SUBMIT A FEE OF
- 26 \$3,500.00. IF THE DIRECTOR BELIEVES THAT THE DISPUTE MAY BE ABLE TO
- 27 BE RESOLVED WITHOUT CONVENING THE PANEL, THE DIRECTOR MAY CONTACT

- 1 THE PETITIONER REGARDING THE ISSUES IN DISPUTE AND MAY NEGOTIATE A
- 2 RESOLUTION OF THE DISPUTE. THIS NEGOTIATION PERIOD SHALL NOT EXCEED
- 3 45 DAYS. IF THE DISPUTE IS RESOLVED WITHOUT CONVENING THE PANEL,
- 4 ANY FEE THAT IS SUBMITTED WITH THE PETITION SHALL BE RETURNED.
- 5 (8) IF A DISPUTE IS NOT RESOLVED PURSUANT TO SUBSECTION (7),
- 6 THE DIRECTOR SHALL SCHEDULE A MEETING OF 5 MEMBERS OF THE PANEL,
- 7 SELECTED ON THE BASIS OF THEIR RELEVANT EXPERTISE, WITHIN 45 DAYS
- 8 AFTER RECEIVING THE ORIGINAL PETITION. A MEMBER SELECTED FOR THE
- 9 DISPUTE RESOLUTION PROCESS SHALL AGREE NOT TO ACCEPT EMPLOYMENT BY
- 10 THE PERSON BRINGING THE DISPUTE BEFORE THE PANEL, OR TO UNDERTAKE
- 11 ANY EMPLOYMENT CONCERNING THE FACILITY IN OUESTION FOR A PERIOD OF
- 12 1 YEAR AFTER THE DECISION HAS BEEN RENDERED ON THE MATTER IF THAT
- 13 EMPLOYMENT WOULD REPRESENT MORE THAN 5% OF THE MEMBER'S GROSS
- 14 REVENUE IN ANY OF THE PRECEDING 3 YEARS. THE DIRECTOR SHALL PROVIDE
- 15 A COPY OF ALL SUPPORTING DOCUMENTATION TO MEMBERS OF THE PANEL WHO
- 16 WILL HEAR THE DISPUTE. AN ALTERNATIVE MEMBER MAY BE SELECTED BY THE
- 17 DIRECTOR TO REPLACE A MEMBER WHO IS UNABLE TO PARTICIPATE IN THE
- 18 DISPUTE RESOLUTION PROCESS. ANY ACTION BY THE MEMBERS SELECTED TO
- 19 HEAR THE DISPUTE SHALL REQUIRE A MAJORITY OF THE VOTES CAST. THE
- 20 MEMBERS SELECTED FOR THE DISPUTE RESOLUTION PROCESS SHALL ELECT A
- 21 CHAIRPERSON OF THE DISPUTE RESOLUTION PROCESS. AT A MEETING
- 22 SCHEDULED TO HEAR THE DISPUTE, REPRESENTATIVES OF THE PETITIONER
- 23 AND THE DEPARTMENT SHALL EACH BE AFFORDED AN OPPORTUNITY TO PRESENT
- 24 THEIR POSITIONS TO THE PANEL. THE FEE THAT IS RECEIVED BY THE
- 25 DIRECTOR ALONG WITH THE PETITION SHALL BE FORWARDED TO THE STATE
- 26 TREASURER FOR DEPOSIT INTO THE FUND.
- 27 (9) WITHIN 45 DAYS AFTER HEARING THE DISPUTE, THE MEMBERS OF

- 1 THE PANEL WHO WERE SELECTED FOR AND PARTICIPATED IN THE DISPUTE
- 2 RESOLUTION PROCESS SHALL MAKE A RECOMMENDATION REGARDING THE
- 3 PETITION AND PROVIDE WRITTEN NOTICE OF THE RECOMMENDATION TO THE
- 4 DIRECTOR OF THE DEPARTMENT AND THE PETITIONER. THE WRITTEN
- 5 RECOMMENDATION SHALL INCLUDE THE SPECIFIC SCIENTIFIC OR TECHNICAL
- 6 RATIONALE FOR THE RECOMMENDATION. THE PANEL'S RECOMMENDATION
- 7 REGARDING THE PETITION MAY BE TO ADOPT, MODIFY, OR REVERSE, IN
- 8 WHOLE OR IN PART, THE DEPARTMENT'S DECISION THAT IS THE SUBJECT OF
- 9 THE PETITION. IF THE PANEL DOES NOT MAKE ITS RECOMMENDATION WITHIN
- 10 THIS 45-DAY TIME PERIOD, THE DECISION OF THE DEPARTMENT IS THE
- 11 FINAL DECISION OF THE DIRECTOR.
- 12 (10) WITHIN 60 DAYS AFTER RECEIVING WRITTEN NOTICE OF THE
- 13 PANEL'S RECOMMENDATION, THE DIRECTOR SHALL ISSUE A FINAL DECISION,
- 14 IN WRITING, REGARDING THE PETITION. HOWEVER, THIS TIME PERIOD MAY
- 15 BE EXTENDED BY WRITTEN AGREEMENT BETWEEN THE DIRECTOR AND THE
- 16 PETITIONER. IF THE DIRECTOR AGREES WITH THE RECOMMENDATION OF THE
- 17 PANEL, THE DEPARTMENT SHALL INCORPORATE THE RECOMMENDATION INTO ITS
- 18 RESPONSE TO THE RESPONSE ACTIVITY PLAN OR THE NO FURTHER ACTION
- 19 REPORT. IF THE DIRECTOR REJECTS THE RECOMMENDATION OF THE PANEL,
- 20 THE DIRECTOR SHALL ISSUE A WRITTEN DECISION TO THE PETITIONER WITH
- 21 A SPECIFIC RATIONALE FOR REJECTING THE RECOMMENDATION OF THE PANEL.
- 22 IF THE DIRECTOR FAILS TO ISSUE A FINAL DECISION WITHIN THE TIME
- 23 PERIOD PROVIDED FOR IN THIS SUBSECTION, THE RECOMMENDATION OF THE
- 24 PANEL SHALL BE CONSIDERED THE FINAL DECISION OF THE DIRECTOR. THE
- 25 FINAL DECISION OF THE DIRECTOR UNDER THIS SUBSECTION IS SUBJECT TO
- 26 REVIEW PURSUANT TO SECTION 631 OF THE REVISED JUDICATURE ACT OF

- 1 (11) UPON REQUEST OF THE DIRECTOR, THE PANEL SHALL MAKE A
- 2 RECOMMENDATION TO THE DEPARTMENT ON WHETHER A MEMBER SHOULD BE
- 3 REMOVED FROM THE PANEL. PRIOR TO MAKING THIS RECOMMENDATION, THE
- 4 PANEL MAY CONVENE A PEER REVIEW PANEL TO EVALUATE THE CONDUCT OF
- 5 THE MEMBER WITH REGARD TO COMPLIANCE WITH THIS PART.
- 6 (12) A MEMBER OF THE PANEL SHALL NOT PARTICIPATE IN THE
- 7 DISPUTE RESOLUTION PROCESS FOR ANY APPEAL IN WHICH THAT MEMBER HAS
- 8 A CONFLICT OF INTEREST. THE DIRECTOR SHALL SELECT A MEMBER OF THE
- 9 PANEL TO REPLACE A MEMBER WHO HAS A CONFLICT OF INTEREST UNDER THIS

- 16 AND ASSESSMENT OF REMEDIAL INVESTIGATIONS, FEASIBILITY STUDIES,
- 17 INTERIM RESPONSE ACTIVITIES, AND REMEDIAL ACTIONS UNDER THIS PART.
- 18 THIS EXPERIENCE MUST DEMONSTRATE THE EXERCISE OF SOUND PROFESSIONAL
- 19 JUDGMENT AND KNOWLEDGE OF THE REQUIREMENTS OF THIS PART.
- 20 Sec. 20126. (1) Notwithstanding any other provision or rule of

- (e) A person who accepts or accepted any hazardous substance
- 23 for transport to a facility selected by that person.
- 24 (f) The estate or trust of a person described in subdivisions
- **25** (a) to (e).
- 26 (2) Subject to section 20107a, an owner or operator who
- 27 complies with subsection (1)(c) is not liable for contamination

- 1 existing at the facility at the earlier of the date of purchase,
- 2 occupancy, or foreclosure, unless the person is responsible for an
- 3 activity causing the contamination existing at the facility.
- 4 Subsection (1)(c) does not alter a person's liability with regard
- 5 to a subsequent release or threat of release at a facility if the
- 6 person is responsible for an activity causing the subsequent
- 7 release or threat of release.
- 8 (3) Notwithstanding subsection (1), the following persons are
- 9 not liable under this part WITH RESPECT TO CONTAMINATION AT A
- 10 FACILITY RESULTING FROM A RELEASE OR THREAT OF RELEASE unless the

- 9 (d) A person who owns severed subsurface mineral rights or
- 10 severed subsurface formations or who leases subsurface mineral
- 11 rights or formations.
- 12 (e) The state or a local unit of government that leases
- 13 property to a person if the state or the local unit of government
- 14 is not liable under this part for environmental contamination at
- 15 the property.
- 16 (f) A person who owns or occupies residential real property if
- 17 hazardous substance use at the property is consistent with
- 18 residential use.
- 19 (g) A person who acquires a facility as a result of the death
- 20 of the prior owner or operator of the facility, whether by
- 21 inheritance, devise, or transfer from an inter vivos or
- 22 testamentary trust.
- 23 (h) A person who did not know and had no reason to know that
- 24 the property was a facility. To establish that the person did not
- 25 know and did not have a reason to know that the property was a
- 26 facility, the person shall have undertaken at the time of
- 27 acquisition all appropriate inquiry into the previous ownership and

- 1 uses of the property consistent with good commercial or customary
- 2 practice. A determination of liability under this section shall
- 3 take into account any specialized knowledge or experience on the
- 4 part of the person, the relationship of the purchase price to the
- 5 value of the property if uncontaminated by a hazardous substance,
- 6 commonly known or reasonable ascertainable information about the
- 7 property, the obviousness of the presence or likely presence of a

- 17 (4) Notwithstanding subsection (1), the following persons are
- 18 not liable under this part:
- 19 (a) The owner or operator of a hazardous waste treatment,
- 20 storage, or disposal facility regulated pursuant to part 111 from
- 21 which there is a release or threat of release solely from the
- 22 treatment, storage, or disposal facility, or a waste management
- 23 unit at the facility and the release or threat of release is
- 24 subject to corrective action under part 111.
- 25 (b) A lender that engages in or conducts a lawful marshalling
- 26 or liquidation of personal property if the lender does not cause or
- 27 contribute to the environmental contamination. This includes

- 1 holding a sale of personal property on a portion of the facility.
- 2 (c) The owner or operator of property onto which contamination
- 3 has migrated unless that person is responsible for an activity

- 9 (ii) An act of war.
- 10 (iii) An act or omission of a third party other than an employee
- 11 or agent of the person or a person in a contractual relationship
- 12 existing either directly or indirectly with a person who is liable
- 13 under this section.
- 14 (E) ANY PERSON FOR ENVIRONMENTAL CONTAMINATION ADDRESSED IN A
- 15 NO FURTHER ACTION REPORT THAT IS APPROVED BY THE DEPARTMENT OR IS
- 16 CONSIDERED APPROVED UNDER SECTION 20114D. NOTWITHSTANDING THIS
- 17 SUBDIVISION, A PERSON MAY BE LIABLE UNDER THIS PART FOR THE
