HOUSE BILL No. 6554

November 9, 2010, Introduced by Reps. Tlaib and Hammel and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending sections 229 and 233 (MCL 436.1229 and 436.1233), section 229 as amended by 2005 PA 288.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 229. (1) The commission may license a hotel or merchant,
- 2 in places that the commission may designate, to sell spirits for
- 3 consumption off the premises, notwithstanding section 233(1).
- 4 Except as otherwise provided in this section, if alcoholic liquor
- 5 is sold by a specially designated distributor pursuant to a license
- 6 issued under this section, it shall not be sold at less than the
- 7 minimum A UNIFORM retail selling price fixed by the commission and
- B pursuant to rules promulgated by the commission.
