November 30, 2010, Introduced by Rep. Opsommer and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 167d (MCL 750.167d), as added by 2006 PA 148.

Sec. 167d. (1) A person shall not do any of the following

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- within 500 feet of a building or other location where a funeral,
 memorial service, or viewing of a deceased person is being
 conducted or within 500 feet of a funeral procession or burial:
 (a) Make loud and raucous noise and continue to do so after
 being asked to stop.
 (A) (b) Make any statement or gesture OR ENGAGE IN ANY CONDITION
 - (A) (b) Make any statement or gesture OR ENGAGE IN ANY CONDUCT that would make a reasonable person ATTENDING THAT FUNERAL,

 MEMORIAL SERVICE, VIEWING, PROCESSION, OR BURIAL under the circumstances TO feel intimidated, threatened, or harassed.

- 7 THOSE ATTENDING THAT FUNERAL, MEMORIAL SERVICE, VIEWING, OR BURIAL
- 8 OR TRAVELING IN THAT PROCESSION.
- 9 (C) MAKE ANY STATEMENT OR GESTURE OR ENGAGE IN ANY CONDUCT
- 10 INTENDED TO DISRUPT THE FUNERAL, MEMORIAL SERVICE, VIEWING,
- 11 PROCESSION, OR BURIAL.
- 12 (2) A PERSON SHALL NOT INTENTIONALLY OBSTRUCT, HINDER, IMPEDE,
- 13 OR BLOCK ANOTHER PERSON'S ENTRY TO OR EXIT FROM A FUNERAL, MEMORIAL
- 14 SERVICE, VIEWING OF A DECEASED PERSON, FUNERAL PROCESSION, OR
- 15 BURIAL. THIS SUBSECTION DOES NOT APPLY TO A PERSON CONDUCTING OR
- 16 ASSISTING IN THE CONDUCTING OF THE FUNERAL, MEMORIAL SERVICE,
- 17 VIEWING, FUNERAL PROCESSION, OR BURIAL.
- 18 (3) (2)—A person who violates subsection (1)—THIS SECTION is a
- 19 disorderly person and is guilty of a felony punishable as provided
- 20 under section 168.
