A bill to amend 1995 PA 24, entitled "Michigan economic growth authority act," by amending section 10 (MCL 207.810), as amended by 2006 PA 283.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 10. (1) The authority shall report to both houses of the
- 2 legislature yearly on October 1 on the activities of the authority.
- 3 BEGINNING OCTOBER 1, 2009, AND EACH YEAR THEREAFTER, THE AUTHORITY
- 4 SHALL ALSO REPORT TO THE CHAIRPERSON OF THE SENATE APPROPRIATIONS
- 5 COMMITTEE, THE CHAIRPERSON OF THE SENATE FINANCE COMMITTEE, THE
- 6 CHAIRPERSON OF THE HOUSE OF REPRESENTATIVES APPROPRIATIONS
- 7 COMMITTEE, THE CHAIRPERSON OF THE HOUSE OF REPRESENTATIVES TAX
- 8 POLICY COMMITTEE, AND THE DIRECTORS OF THE SENATE AND HOUSE FISCAL
- 9 AGENCIES. The report shall include, but is not limited to, all of

- 14 INCLUDE ITS AUDIT FINDINGS WITH THE REPORT.
